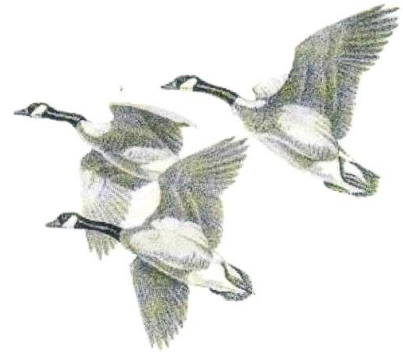

## **2021 Annual Meeting & Election Information**

(September 2021)

**Saturday, September 18th 2021** - The GLA Annual Meeting will be held in the GLA Hall located at 3935 N. Goose Lake Road. The day will begin with "Voting in Person" from 4:00pm-7:00pm in the GLA Hall. **(Members will be asked to show identification before receiving a ballot.)** This will be followed by a complimentary buffet dinner that will start promptly at 7:01pm. The Annual Business Meeting will take place from 8:00-10:00pm with reports to be given from all committees and will also include the voting results of this year's election of Officers and Directors.

Included in this mailing is a sample ballot containing the Board of Director candidates and positions they are seeking. In addition, an autobiography of each candidate is also provided with information that has been provided by each candidate.

- **Election of Officers and Directors** – There is multiple ways in which you can vote in this year's election. They are as follows:
  - 1) **Early Voting** – During normal GLA office hours (M, W, F & S from 9:00am-1:00pm) starting on Friday, August 27th, 2021 and ending on Saturday, September 18th, 2021. Note: The Office will be closed on Labor Day, September 6th.
  - 2) **Absentee Voting** – A mail-in ballot is also available starting Friday, August 27th, 2021 by mailing the GLA Office a hand written letter requesting an absentee ballot be mailed to you. The letter should be signed and include your mailing address and the lake and lot number of your property. The completed ballot must be delivered or mailed to the Association office to the attention of the election committee and must be received no later than the business day prior to the annual meeting in order to be valid.
  - 3) **Voting in Person** - As noted above Saturday, September 18th from 4:00-7:00pm in the GLA Hall. Members will be asked to show identification before receiving a ballot.
