Bar-Hiring process was completed, new hire will be informed and presented with information package on duties and salary. Motion made by Tom Mosey and seconded by Phil Sheedy to accept manager salary as stated 500.00 a week for the first 90 days than an increase to 550.00 after probation period is over. Vote unanimous motion carried. Discussion of proper inventory and the request of an audit committee were covered.

There was also discussion on who the caretaker actually takes his direction from.

Fish-Waiting on budget approval, talked of spring stocking. Ice fishing by outsiders was discussed along with the amount of fish that can be removed. Structures and placement of brush was talked about including a need for work platform. Phil Sheedy made a motion seconded by Tom Mosey for the amount

not to exceed 1400.00 for a platform with a flat deck for use to access areas of the lake. Vote unanimous- Motion carried.

Beach-Nothing to report

Maintenance-Jim Arnold thanked Rich Cambruzzi and Brian Recher for all their help at the campground. Jim Arnold made a motion seconded by Mike Poeschel to renew our contract with our current mowing service at an additional cost of 298.00 a year for a two year period. Vote unanimousmotion carried.

Safety- Jim Grady needs to replace trailer, has bids for a galvanized trailer. Jim Grady made a motion to purchase a trailer not to exceed 1500 dollar, seconded by Dave Barker - Vote unanimous, motion carried.

Weeds- Joe Turk explained that Rollins aquatic will be using a new product this year for the treatment of invasive species. It was requested that next year we review companies and look into other bids, Joe Turk made a motion to accept this years weed removal budget seconded by Tom Mosey. Vote unanimous- motion carried.

Motion Denied

Dave Barker Made a motion Seconded by Barb Peters to add to rules 6.5e that a boat mirror ir required on pontoon boats on Lincoln lake. Vote went as follows- Barb Peters, Dave Darner, Dave Barker, Jim Grady, Tom Haas, Tom Mosey, Eric Pershey, Jim Papesh, Phil Sheedy-YES Steve Peters, Jim Arnold, Mike Poeschel, NO -Motion Denied

Discussion that we need Minimum of 11 voted to change a rule.

Listing D Construction, Lincoln lake estates, Felix townships donations and efforts to help alleviate costs.
