

## Dunkirk, New York

Dunkirk is a city in Chautauqua County, New York, in the United States. It was officially incorporated in 1880, though it was first settled around 1805. The population was 12,563 as of the 2010 census, with an estimated population of 12,328 in 2013. Dunkirk is bordered on the north by Lake Erie. It shares a border with the village of Fredonia to the south, and with the town of Dunkirk to the east and west. Dunkirk is the westernmost city in the state of New York.



The Chautauqua County/Dunkirk Airport, in the town of Dunkirk, provides training facilities and charter services. Railroad service in Dunkirk is provided by CSX Transportation (via the Buffalo-Cleveland-Willard (Ohio)-Chicago Main Line) and Norfolk Southern Railway (Buffalo-Cleveland-Fort Wayne-Chicago Main Line). The New York State Thruway (Interstate 90) passes through the southern end of the city, with access from Exit 59 (NY Route 60) just east of the city limits. The Thruway leads northeast 42 miles to the outskirts of Buffalo and southwest 28 miles to the Pennsylvania border. New York State Route 5 runs through the center of the city, leading northeast 9 miles to Silver Creek and southwest 18 miles to Westfield.
