





BANK AREA MAP


MARKET OVERVIEW | Middlesex County

Colonia, New Jersey is located in Middlesex County, known as the "perfect Northeast location" due to its proximity to surrounding cities and the coastline. It is only a 30-minute drive from the Newark Liberty International Airport, and about an hour drive from Manhattan, the Jersey Shore, and Philadelphia. In addition, travel to the coastal Northeast is not possible without passing through this county. The second most populated county in New Jersey, Middlesex has about 830,000 residents, and offers first class medical facilities, well-known universities, the state's largest convention center, and one of the biggest shopping centers on the east coast.


Home to the Forrester Campus of Princeton University and Rutgers University, Middlesex County boasts a highly educated workforce, a low unemployment rate (3.1% as of August 2019), and median household income of over \$85,000, well above the national average of \$60,336. Middlesex's county's workforce is in the top 4% nationally for Bachelor's and Graduate/Professional degrees. The top industries by employment are Healthcare & Social Assistance, Professional, Scientific & Technical Services, and Retail.


Transportation is another strength of this area. The New Jersey Turnpike (I-95), the Garden State Parkway, and Interstate 287 run through it, as well as US Routes 1, 9, and 30.
