INTRODUCTION

On October 16, 2025, the LVPC Executive Committee adopted the *Organizational Strategic Plan* to affirm the organization's core strengths and provide a roadmap for addressing the region's most pressing challenges. This plan is designed to guide the evolution of the LVPC, ensuring it continues to lead with integrity, vision and impact.

The 2026 Budget and Workplan is grounded in this strategic vision and built upon the foundational responsibilities outlined in the numerous state and federal statutes administered by the LVPC. These statutory obligations shape the core of the organization's work and ensure compliance with and implementation of critical laws.

The LVPC also recognizes the uncertainty created by the Pennsylvania state budget impasse and the federal government shutdown. This dynamic and evolving situation has implications for fund reimbursements and grant award timelines, and the 2026 Budget and Workplan has been developed with these challenges in mind.

Key planning priorities for 2026 include continuing the update of *FutureLV: The Regional Plan*, initiating the Lehigh Valley Watersheds Assessment and Global ACT 167 Ordinance, and organizing implementation actions for the Organizational Strategic Plan, including establishment of a non-profit entity to support revenue diversification and advance implementation of plans.

In addition to these major initiatives, the LVPC team will complete projects such as the transition to an online system for plans, ordinances and maps, as well as a full website rebuild. The workplan also emphasizes municipal services and education, climate action implementation, transportation safety and multimodal accessibility, and advancing the housing supply and attainability strategy.

Overall, the 2026 Budget and Workplan reflects the LVPC's statutory responsibilities, the current funding landscape, and the strategic direction of the organization, all while striving to maintain high levels of service to a growing region.



BUDGET SUMMARY



BUDGET

As the Lehigh Valley Planning Commission (LVPC) enters its 65th year serving the housing, economic, transportation, environmental, infrastructure, and information planning and coordination needs of Northampton and Lehigh counties, its priorities continue to evolve alongside the region's growth.

The LVPC's 2026 Budget and Workplan includes funding for ongoing, mandated planning activities, such as the review of municipal zoning, subdivision and land development ordinance changes. These efforts are supported through annual allocations from Lehigh and Northampton counties, as regulatory restrictions limit the Commission's ability to charge fees for municipal ordinances and plan reviews, curative amendment challenges, and development of model guides, among other critical municipal and regional support activities.

Each county's investment also supports the update to *FutureLV: The Regional Plan* and provides required matching funds for Metropolitan Planning Organization (MPO) activities and related projects. Specific project contracts requiring county match funding are identified, along with any relevant statutory references.


The LVPC stands at a pivotal moment in its evolution as the region's trusted steward of data-driven long-range planning. With a reputation for credibility, a legacy of leadership and a unique regional mandate, LVPC is well-positioned to guide the Lehigh Valley through a period of dynamic growth and complex challenges.

LVPC has earned the respect of stakeholders across sectors for its rigorous analysis, high-quality development reviews and commitment to public service. As the only organization evaluating development from a regional and long-term perspective, LVPC plays an indispensable role in shaping a more sustainable and prosperous future for Northampton and Lehigh counties. Because the Metropolitan Planning Organization, Lehigh Valley Transportation Study (LVTS), is housed within and functionally supported by LVPC, planning and funding for roads, bridges, transit, trails and rail systems is integrated in the regional comprehensive plan.

At the same time, rising demands, limited staff capacity, and regional disparities highlight the need for stronger engagement, clearer communication, increased and diversified revenue and updated systems. The strategic plan builds on LVPC's strengths while addressing its challenges. It focuses on leveraging data to inform policy, strengthening internal capacity, clarifying its role in advocacy and public engagement and reinforcing its identity as a collaborative, forward-thinking regional leader.

The Strategic Plan outlines five pillars to guide LVPC in meeting the region's evolving needs. The 2026 Budget and Workplan aligns with these pillars by identifying how each initiative supports the broader strategic direction.

The Commission operates with 24 full-time staff and 5 part time staff—barely half the number needed to meet the region's growing needs. The region has grown by 170,000 residents since 1990, while stagnant staffing levels have limited LVPC's ability to respond effectively. A comparative analysis of similarly sized Pennsylvania regions shows that LVPC, as a bi-county planning commission and MPO, should employ approximately 46 staff members.



In 2026, staffing is expected to increase, with key roles identified in the Strategic Plan being filled, though the total will remain under 30. Despite these constraints, LVPC continues to diversify funding sources and rise to the region's evolving challenges, while maintaining a balanced budget.

As the Lehigh Valley continues to grow and change, the LVPC remains committed to delivering high-quality, forward-thinking planning services that support a more resilient, equitable and prosperous future for all communities across the region.

Mission Rooted in Law

The Lehigh Valley Planning Commission and Lehigh Valley Transportation Study operate under a series of laws that outline roles and responsibilities of the organization supported by the LVPC mission.

Within this framework, the 2026 Budget and Workplan supports the implementation of several federal, state and county laws, many of these with increasing requirements adding to the complexity, depth and breadth of the work program. It is of note, the Inflation Reduction Act adds US Environmental Protection Act responsibilities to bi-county planning in addition to the Metropolitan Planning Organization functions of the LVTS.

The laws that the LVPC and LVTS operate under include:

- Implementing the County Planning Program, as required by the Pennsylvania Municipalities Planning Code (Act of 1968, P.L. 805, No. 247, as enacted and amended), and associated state and county acts and initiatives, as required
- Implementing the County Watershed Management Program, as required by Pennsylvania Storm Water Management Act (Act of 1978, P.L. 864, No. 167, as enacted and amended), and the associated federal Municipal Separate Storm Sewer System Program of the Clean Water Act
- Implementing the Sewage Facilities Act (Act of 1966, P.L. 1535, No. 537, as enacted and amended) for the planning and regulation of community sewage systems
- Implementing the Solid Waste Management Act (Act of 1980, P.L. 380, No. 97, as enacted and amended) for municipal, residential and hazardous waste permits
- Implementing the Metropolitan Planning Organization Transportation Planning and Investment Program requirements per United States Code, Title 23, as enacted and amended in conjunction with the Infrastructure Investment and Jobs Act and Inflation Reduction Act
- Implementing the Climate Pollution Reduction Program requirements per the United States Code, Title 2 and 40, as enacted and amended in conjunction with the Inflation Reduction Act
- Implementing the Public Utility Code (Act of 1978, P.L. 598, N. 116 as enacted and amended) cooperation provisions for regulated utility distribution systems
- Implementing the Delaware River Basin Compact (U.S. Public Law 87-328 of 1961 and Act of 1961, P.L. 518, No. 268) for water supply protection, pollution control, flood protection, watershed management, recreation, hydroelectric power and regulation of withdrawal and diversion
