#### **CHAIR'S REPORT**

Chair Amato introduced two new members of the LVPC staff, Dr. Subham Kharel and Faria Urmy. Both gave a brief overview of their background and LVPC projects they are looking forward to contributing to in their role.

Chair Amato recognized the individuals who completed the required hours of training to receive the Pennsylvania Municipal Planning Education Institute (PMPEI) award for Certified Citizen Planner. Three individuals were recognized for their achievements in earning the Outstanding Planning Education Achievement Award.

Chair Amato honored long-time City of Bethlehem Planning Director and LVPC Commissioner Darlene Heller, whose retirement was scheduled for January 31. Several Commissioners spoke kind words and congratulated Ms. Heller on her regional impact.

#### MINUTES

Chair Amato stated that the minutes of the Thursday, December 19, 2024, LVPC meeting are in the meeting packet. Chair Amato asked for a motion to approve the minutes. Commissioner Glickman made a motion to approve the minutes and Commissioner Elbich seconded the motion.

Chair Amato asked for any comments or questions. There were none. The motion passed. Commissioners Kelly, Klusaritz and Charles Elliott abstained.

#### **COMPREHENSIVE PLANNING COMMITTEE**

#### ACTION ITEM: Housing Supply and Attainability Strategy

Ms. Seitz shared details about the upcoming Lehigh Valley Housing Supply and Attainability Strategy that will be released. The event will be a part of a three-part series with key stakeholders to address housing shortages across the Lehigh Valley.

Chair Amato asked for any comments or questions. Commissioner Melnick asked about the effects on the local market, and it was discussed how the strategy can be used by municipalities as an informational tool.

#### ACTION ITEM: Comprehensive Planning Committee Summary Sheet

Comprehensive Planning Committee Chair Melnick briefed the Commission on the Comprehensive Committee Summary Sheet that featured four zoning ordinance and map amendments reviews. There were zoning map amendments in Bethlehem and Hanover Townships, a zoning ordinance amendment in Whitehall Township and a zoning ordinance and map update in Alburtis Borough.

Chair Amato called for a motion to accept the summary sheet. Commissioner Morgan made the motion, and Commissioner Repasch seconded the motion. Chair Amato asked for any comments or questions. There were none.

Chair Amato called for affirmative votes to accept the staff comments. The motion passed.

#### **ENVIRONMENT COMMITTEE**

#### INFORMATION ITEM: Greater Lehigh Valley Regional Climate Action Overview

Ms. Myerov gave a brief synopsis of the ongoing Greater Lehigh Valley Regional Climate Action Plan. The Climate Pollution Reduction Grant (CPRG), a program funded by the U.S. Environmental Protection Agency (EPA), features four main parts. The third component of the series is in the works currently. The purpose of the plans and featured findings were shared.

Chair Amato asked for any comments or questions. There was brief discussion about the federal funding freeze and it was emphasized that the LVPC would monitor the situation and report if anything drastically changes with the 2025 workplan.

Commissioner Repasch briefed the Commission on Environment Committee's business that included two Delaware River Basin Commission items involving wastewater treatment plant and discharge renewals in Lehigh Township and North Whitehall Township. The Lehigh Valley Planning Commission (LVPC) will consider the subject application at its Comprehensive Planning Committee and Full Commission meetings, pursuant to the requirements of the Pennsylvania Municipalities Planning Code (MPC). The meetings occur on:

The application is considered a Land Use of Regional Significance under *FutureLV: The Regional Plan* in the Educational Facilities category. The project proposes construction of a 25,800 square-foot childcare center at 1031 Flexer Avenue (Parcel Identification Number 548690615921).

#### Background

According to Salisbury Township's Zoning Map, the project site is Medium Low Density Residential District (R-3) and the proposed use an early learning center and gymnasium. Adjacent uses feature the Saint Thomas More Church campus and Preschool, Louise Lane Park, sports club and multiple single-family detached properties. There is an existing chapel with parking that is to remain and be redeveloped.

#### Site Suitability

The proposal supports a core strategy of *FutureLV: The Regional Plan* to increase density in urban areas using infill development (Density Special Section, page 71). According to the General Land Use in *FutureLV: The Regional Plan*, this parcel is in a Development area and has the factors needed to support growth, such as sewer and transportation infrastructure capacity and contiguity to the existing Saint Thomas More Preschool and Church. The proposal serves to 'expand access to education and job training' (of Policy 4.1) which serves to stimulate investment in local institutions and increase social opportunities (of Policy 4.2).

#### Transportation

Reuse in an urban area located in centers and along corridors supports Policy 1.1 and Policy 4.3 of FutureLV: The Regional Plan for increasing educational opportunities. The Lehigh and Northampton Transportation Authority (LANTA) provides fixed-route public transportation near the project site, with two northbound and southbound bus stop pairings on Flexer Avenue at the intersections of Debbie Lane and Lindberg Avenue, both approximately within 500 feet of the main entrance to the project site (bus stop ID 4900 and 4849). The proposal includes a new crosswalk and expands the existing pedestrian network to enhance transit connections with nearby infrastructure (of Policy 2.3). Another crosswalk is recommended at the proposed northern access to further incorporate universal design and provide safe routes to school (of Policy 5.2). There is an opportunity to extend the proposed sidewalk along Flexer Avenue to the intersection with Debbie Lane to further promote safe and secure community design (Policy 5.1). A potential location for the extension is shown in yellow below. Coordination with the Township is encouraged for a path to connect to the nearby neighborhood through Louise Lane Park. Signage should specify a drop-off area near the northern part of the parking area to reduce car queueing and improve traffic circulation (of Policy 2.2).




Figure 2 Location of sidewalk extension

#### **Sustainability**

The LVPC recommends that educational institutions incorporate environmentally sensitive building and landscape design, such as green roofs or solar panels. This would increase the cost-effectiveness of building operation and further academic endeavors related to these technologies, while enhancing the campus setting, demonstrating environmental leadership within the region, and 'reducing climate change impacts through mitigation and adaption' (of Policy 3.4).

The City of Allentown, Upper Saucon Township, Fountain Hill Borough and Emmaus Borough are being included in this review letter to 'coordinate land use decisions across municipal boundaries' (of Policy 1.4).

Municipalities, when considering subdivision/land developments, should reasonably attempt to be consistent with *FutureLV: The Regional Plan*, as required by the Pennsylvania Municipalities Planning Code (MPC) [Article 1§105, Article III§303, §304 & §306(a), Article VI§603(j)]. The LVPC review does not include an in-depth examination of plans relative to subdivision design standards or ordinance requirements since these items are covered in the municipal review.

# Re: Palmer Township 2025 Active Transportation Plan: A Parks, Recreation and Open Space Plan Update – Lehigh Valley Planning Commission Review

Mr. Beavers,

The LVPC review of the 2025 Active Transportation Plan: A Parks, Recreation and Open Space Plan Update by Palmer Township was completed to provide comments regarding consistency with the goals and policies of FutureLV: The Regional Plan, a bi-county comprehensive and long-range transportation plan for Lehigh and Northampton Counties as well as the goals and policies of WalkRollLV: Active Transportation. The LVPC also reviewed any existing Lehigh Valley Transportation Study (LVTS), the Metropolitan Planning Organization (MPO) for Lehigh and Northampton Counties, initiatives and plans to identify any corresponding mobility projects, programs, or policies for the region.

The Palmer Township Active Transportation Plan Update is generally consistent with the goals and associated policies of *FutureLV* as follows:

#### **Goal 1: Efficient and Coordinated Development Pattern**

- Policy 1.2: Direct growth by establishing a network of mixed-use centers and mixedtransportation corridors.
  - Link centers with high-capacity, mixed transportation corridors.
  - Support pedestrian-scale development.

#### **Goal 2: Connected Mixed-Transportation Region**

- Policy 2.1: Develop a mixed-transportation network to support a more compact development pattern, optimize roadway capacity and encourage alternative travel options.
  - Establish mixed-transportation corridors.
  - Enhance The Link the Lehigh Valley multi-use trail network.
  - Connect regional trails to Centers and Corridors.
  - Promote funding opportunities for mixed-transportation and recreation facilities.
- Policy 2.2: Provide a safe, well-maintained transportation network to move people and goods efficiently, while capitalizing on existing infrastructure.
  - Improve efficiency of existing infrastructure.

• Encourage an interconnected street, sidewalk and trail network.

#### Goal 5: Safe, Healthy, Inclusive and Livable Communities

- Policy 5.2: Increase social and economic access to daily needs for all people.
  - Promote safe routes to schools and playgrounds.
  - Ensure transportation accessibility for all persons.
  - Improve connections between bus stops and pedestrian and bicycle infrastructure.
- Policy 5.3: Create community spaces that promote physical and mental health.
  - Improve walkability of post-wat centers.
  - Promote street trees and pedestrian scale lighting.
  - o Strengthen sidewalk, bike route and trail infrastructure.

Additionally, the update aligns with the following recommendations in *WalkRollLV: The Active Transportation Plan*:

#### **Bicycle Commuting Corridors**

- Northampton Street (Greenwood Avenue to Larry Holmes Drive)
  - Project 3 of the Central Palmer study area is the Northampton Street Bike Lane.
  - The corridor ranges from 6,500 to 8,500 AADT, it connects densely populated areas in three separate municipalities and connects the Two Rivers Area Trailway via the Wilson Bike Path.

#### Recommendations

- Walk/Roll recommends a reconfiguration of the 25<sup>th</sup> Street Intersections. It is recommended that it be a protected intersection with all right turn lanes removed, or a compact modern roundabout instead of signals.
- Walk/Roll also recommends Separated Bike Lanes from Greenwood Avenue to 25<sup>th</sup> Street, eliminating the center left-turn lane and provide buffered bike lanes on each side of the street.
  - Parking protected bike lanes are also suggested if there is a legislative change in Pennsylvania allowing them.
- Where Wilson Bike Path crosses Northampton Street on the Palmer/Wilson Border, Walk/Roll suggests upgrades to the crossing with a median refuge island, a raised crossing, and a rectangular rapid flashing beacon to warn drivers of crossing pedestrians.

Finally, the project aligns with the Lehigh Valley Transportation Study's Traffic Safety Plan mitigation strategies as follows:

#### **Bicycle and Pedestrian**

- Walkable Neighborhoods:

- Implementation of techniques designed to improve pedestrian movements, including well designed streets and sidewalks, places to walk to, interesting buildings, people, comfort, accessibility, green networks and beauty.
- Alternative Transportation:
  - An alternative method or means of travel other than the private motor vehicle, including walking, cycling, carpooling or mass transit.
- Pedestrian Accommodations:
  - Any series of pedestrian amenities, including but not limited to push buttons, crosswalks, ramps, sidewalks, etc.

The Palmer Township 2025 Active Transportation Plan: A Parks, Recreation and Open Space Plan Update will positively impact the residents of the Palmer Township and thousands of other residents within the Lehigh Valley who travel through this area. The plan suggests critical connections to our commuter trail network for pedestrians and bicyclists. Plans of this kind benefit disadvantaged communities and helps promote equitable access to important destinations for employment, education, retail, and recreation. This plan will help implement many key goals and policies of *FutureLV: The Regional Plan, WalkRollLV: Active Transportation Plan*, the Traffic Safety Plan, and several other critical planning documents.

The LVPC review team supports the township's efforts and is available for any further questions or aspects requested regarding this plan review.







The Following LTAP Classes will be held in person at the LVPC Conference Center, 615 Waterfront Drive, Suite 201, Allentown PA 18102

#### Wednesday March 5 Public Works Safety – 8 am to Noon (sold out) By popular demand a 2<sup>nd</sup> class on March 5 from 12:30 pm to 4:30 pm

This course provides a basic understanding of common safety factors and practices associated with public works road maintenance operations. Specific operations discussed include trench excavation, crack sealing with hot asphalt, mowing and chain saw use, as well as winter maintenance. It provides an overview of why accidents happen and how to protect personnel through the use of personal protective equipment. Workplace awareness is stressed with emphasis on chemical safety, environmental hazards, and vehicle and equipment safety issues. The importance of having a formal safety program in place and how to establish an effective program is discussed.

#### Wednesday April 2 Temporary Traffic Control (Work Zones) – 8 am to 3 pm

This course will enhance your awareness of the importance of safety for all workers and road users in work zones. It covers basic work zone principles and reviews the different control devices applied in work zones. The course also emphasizes worker safety, including appropriate safety apparel, safe work zone practices, and appropriate work zone set-ups. The participants will be able to: Recognize the importance of temporary traffic control for the safety of the work crew and of the traveling public. • Develop a working knowledge of State and Federal temporary traffic control laws, regulations, and guidelines. • Demonstrate the ability to develop temporary traffic control plan/set-ups in accordance with PennDOT Publication 213 for various local road situations. Intended Audience: Individuals who are performing maintenance, construction, or traffic control on municipal roadways including: public works employees, road crews, roadmasters and street superintendents. Others who would benefit from this course include law enforcement personnel (for enforcement purposes), municipal managers and elected officials (to understand the importance and for budgeting purposes). Engineers are welcome to attend, but the focus is on the non-engineer. Note: This is not a flagger certification workshop.

All LVGA LTAP classes are free and are intended for municipalities, transportation non-profits and organizations with a transportation purpose. LTAP Enables many practitioners who need courses with professional development hours (PDHs) to earn credits for maintaining their licenses and certificates.

# Talking Business with Becky Bradley: Area

transportation, housing, climate action plans in progress

With 2024 in the rearview, 2025 looks exciting - and daunting

Every new year brings new ideas, new opportunities and new challenges, and as I look at what the Lehigh Valley Planning Commission has scheduled for 2025, I'm filled with excitement. I'm also anxious because our region's needs are great and growing and this underscores the need to work efficiently together.

We'll be tackling, along with our many partners, including you, more than a dozen major projects including creating a new transportation safety plan, analyzing where the gaps are in our trail network, installing a new electronic plan-filing system, upgrading the LVPC website, devising a new regional population and employment forecast and helping 19 municipalities work together in multi-municipal plans that will enable them to better manage development.

All exciting. All important. But I'm especially excited about these five projects that will have majors impacts on the transportation network, environment and housing market in our communities:

- **Route 22 Mobility, Safety and Congestion Plan** Thanks to a \$1 million grant secured through state Sen. Nick Miller, D-Lehigh, and Pennsylvania Department of Transportation Secretary Michael Carroll, this plan will provide a phased and prioritized strategy for the 23-mile stretch of Route 22 from the Interstate 78 split in Upper Macungie Township to the New Jersey/Easton border. The recommendations will address safety, capacity and congestion issues, while providing alternatives for line-painting designed to handle autonomous vehicles, where to place alternative fuels stations and truck parking, high occupancy vehicle lanes and other techniques to make the road more efficient. It will also include significant green infrastructure priorities to help improve air quality and reduce stormwater runoff. The plan should be underway this summer and completed by the summer of 2026.
- **Bus Rapid Transit** We will soon commit more resources than ever into advancing the enhanced bus service offered by the Lehigh and Northampton Transportation Authority. It already has an express bus service that comes as frequently as every 30 minutes on routes through Whitehall, Allentown, Bethlehem and Easton. These new investments will help increase frequency, as well as bring physical changes along the routes to improve pedestrian safety and amenities, while getting the buses through the region more quickly. Giving people a more efficient way to work, school, shops and recreation is key to providing a truly accessible transportation network. Though these will be gradual changes, they are important steps in a future that could evolve into a light rail system with buses or maybe even train cars.
- **Regional Watershed Management Plan** Stormwater management is one of those things most people don't think about, until it fails, and you end up with flooding, property damage and polluted waterways. The Lehigh Valley has 15 watersheds, each with separate watershed management plans. The problem is some of them date to the 1980s, and as a rapidly growing region, there has been a lot of development and weather changes in the last three-plus decades. Updating each watershed plan separately could take two decades, so the Pennsylvania Department of Environmental Protection is allowing us to take the never-before-done approach of updating them all at once, as a single watershed plan. The two-year process is already underway and will continue in earnest through 2025 and 2026.
- **Climate Action** The LVPC's been at the forefront of climate action since it produced its ground-breaking Climate + Energy Element in 2014, but a \$1 million federal grant from the Inflation Reduction Act is helping us lean hard into a much more sustainable future. The Lehigh Valley Priority Climate Action Plan for Transportation Decarbonization

and the Greater Lehigh Valley Greenhouse Gas Inventory Plan, produced into 2024, will serve as a basis for a first-ever Greater Lehigh Valley Regional Climate Action Plan that will set goals and give practical recommendations of how the region can cut its carbon emissions in the coming decades. The RCAP will be delivered this summer.

**Housing Supply and Attainability Strategy** – The Lehigh Valley is in the throes of a nearly 9,000-unit housing shortage that is making it difficult to find housing and pricing families out of their own neighborhoods. Developing a strategy to increase supply, determine what type of homes should be built, where they can be built and at what price points may be the single-most important thing we do this year. We're partnering with Lehigh County and the Urban Land Institute to develop a plan based not only on the data we collect, but the feedback we get from homeowners, developers, bankers, community leaders, school districts and municipal officials.

Every one of these plans has a chance to have a tremendous impact on our community and any one of them alone would make for a frenetic coming year. But put them all into the next 12 to 24 months and it can feel rather daunting. But nothing truly impactful comes easy. Remember if it was easy, it would be done already. Our specialty is building and maintaining collaborations and partnerships to build consensus and progress avoiding and resolving complex issues. That's why we are focusing on the practical, difficult needs of today and what we can predict we will need to do for tomorrow. We'll approach all of these the way we do everything – with fact-based optimism – and we'll find opportunity in every obstacle, purpose for every action and diligence in the pursuit of all solutions. Cheers for a brilliant 2025, when we'll address some of the most pressing issues the region faces, along with you. Together, there is nothing we can't do.
