



Lessons that we should have learned from the HIV/AIDS scam.

Those of us old enough to remember will remember the governments terrifying 1980s fear campaign about the deadly new sexually transmitted virus HIV that could decimate the immune system and lead to a horrible death from AIDS. The adverts were like a horror film shot in black and white with sinister voice overs and sinister images of gravestones and death, dripping with menace. We were instructed not to "die of ignorance". Sound familiar? Remember the deadly black mist of the "Covid" virus swirling around looking for its next unsuspecting victim? Look them in the eyes...

Virologist Robert Gallo from the US NIH first proposed the viral theory of AIDS (Acquired Immune Deficiency Syndrome). Then in 1983, scientists at the Pasteur Institute in France, led by Luc Montagnier, published a paper claiming to have isolated the AIDS virus (Human Immunodeficiency Virus or 'HIV'). A year later, Robert Gallo et al published their own research, claiming the same thing, and the viral theory of AIDS was quickly accepted by most of the biomedical establishment.

However, other experts such as Dr. Peter Duesberg, Dr. Kary Mullis (Nobel Prize winning inventor of the PCR), and "The Perth Group" of researchers from Australia, led by Prof. Eleni Papadopoulos, refuted these viral claims:

"In the five 1983/84 Science papers, Montagnier and Gallo and their colleagues claimed to have purified HIV using density gradient centrifugation, "characterised" (identified) the HIV particle proteins, showed that the particles are infectious and proved (Gallo) HIV the cause of AIDS.

The 1.16 g/ml density band material was declared to be "purified", "pure", retrovirus particles, despite the fact neither group published electron microscopic images to substantiate this claim. Neither have they nor any other scientist since published such images."

HIV – A virus like no other, The Perth Group, 2017.

Contrary to popular belief AIDS is not one distinct disease, but rather a collection of diseases, with a number of different causes, grouped under a single label.

Based on the research of Peter Duesberg, Jon Rappoport, The Perth Group, Jon Lauretsen, and others, the real causes of AIDS include toxicity from AZT and other drugs given to people who (falsely) test positive for HIV, severe malnutrition, poverty, lack of indoor plumbing, toxicity from recreational drugs like nitrite inhalants ('poppers'), and the overuse of antibiotics.

The alleged HIV virus and its alleged link to AIDS should have forewarned us about our more recent experience of the alleged SARS-CoV-2 and its alleged link to Covid-19. The



conspirators are using exactly the same playbook again which isn't surprising since ringleader Anthony Fauci led both assaults on humanity.

The 'proof' for the existence of SARS-CoV-2 relies on the following claims:

- 1) SARS-CoV-2 has been isolated and imaged under an electron microscope.
- 2) SARS-CoV-2 has been sequenced and characterized.
- 3) SARS-CoV-2 has been unambiguously shown to cause severe disease.

EVERY ONE OF THESE CLAIMS IS FALSE.

To prove the existence of a virus the viral particles must be purified. The purification process is required for a number of reasons including:

- 1) To separate viral particles from cellular material. Viruses and cells are composed of the same biochemical molecules, so purification is crucial in order to determine which nucleic acids and proteins are viral and which are cellular.
- 2) To prove that the particles are infectious. Otherwise, it can't be ruled out that other factors are responsible for the production of new particles and cytopathic effects in cell cultures e.g., cellular response to toxicity or starvation.
- 3) To be able to demonstrate the pathogenicity of the virus (fulfill Koch's postulates, Rivers postulates, or Bradford Hills causation criteria).
- 4) To obtain pure viral proteins and nucleic acid sequences for use in developing reliable tests.

In every paper claiming to have 'isolated' SARS-CoV-2, it is evident that researchers have done nothing of the sort. Instead, they have used cell cultures to supposedly 'grow' the virus and then observed damaged cells under the microscope which they call a cytopathic effect.

PCR tests are often used to 'confirm' the presence of SARS-CoV-2, but this is unreliable as the original "viral genome" sequence did not come from purified viral particles. The now notorious Corman-Drosten PCR for SARS-CoV-2 which was adopted worldwide does not specifically detect anything (let alone a virus) and can be used to generate positive or negative results at will and as required for political purposes.

It is also worth noting that the definition of the word "pandemic" was changed, by the WHO, so that a "pandemic" could be declared based entirely on false positive test results without any requirement for large numbers of deaths or serious illness.

Viruses are structurally and morphologically indistinguishable from extra-cellular vesicles such as exosomes, which are particles produced by our cells with numerous important beneficial functions.

In a paper titled 'Difficulties in Differentiating Coronaviruses from Subcellular Structures in Human Tissues by Electron Microscopy', the researchers state that:

"In attempts to attribute pathology of COVID-19 patients directly to tissue damage caused by SARS-CoV-2, investigators have inaccurately reported subcellular structures, including coated vesicles, multivesicular bodies, and vesiculating rough endoplasmic reticulum, as coronavirus particles."

In other words, they failed to differentiate between normal constituents of cells and the "virus" SARS-CoV-2.

Even more damning is a paper titled "Appearances Can Be Deceiving – Viral-like Inclusions in COVID-19 Negative Renal Biopsies by Electron Microscopy":

"We have observed morphologically indistinguishable inclusions within podocytes and tubular epithelial cells both in patients negative for coronavirus disease 2019 (COVID-19) as well as in renal biopsies from the pre-COVID-19 era."

In other words, they observed the EXACT SAME particles in patients who tested negative for Covid-19 as those that tested positive, and in those who they biopsied long before Covid-19 was concocted.

The researchers go on to say that:

"A number of potential natural mimickers that can generate intracellular groups of round vesicles mimicking SARS-CoV-2 virions could be listed, the most likely being endocytic vesicles and endosomal components such as micro vesicular bodies containing exosomes, among others."

"Endocytosis leads to the formation of 60-120 nm vesicles, which is within the size range described for SARS-CoV-2 (60-140nm). These endocytic vesicles may be coated by different proteins, one of the most common being clathrin. The presence of coating proteins may be responsible for the presence of an electron-dense area surrounding these vesicles, giving the appearance of a viral corona."



This paper could be interpreted as evidence for the theory that extracellular vesicles and 'viruses' are the exact same thing. As Dr Stefan Lanka put it:

"All scientists who think they are working with viruses in laboratories are actually working with typical particles of specific dying tissues or cells which were prepared in a special way."

In fact, many of the routine procedures employed by biomedical scientists in the laboratory (including me) are harsh and unnatural and so may be altering natural living cells and tissues beyond all recognition and may be generating artifacts of the processes themselves.

The brilliant but largely unknown and ignored scientist the late Dr Harold Hillman regularly questioned and challenged the validity of these techniques which I wrote about in The Expose article "Modern Medicine: A Castle Built on Sand?".

Virologists have failed to demonstrate pathogenicity for their unpurified "SARS-CoV-2" cocktails, they have failed to induce disease in monkeys and mice, and they have failed to even begin to satisfy Koch's postulates despite what "independent fact checkers" might claim.

Conclusions

SARS-CoV-2 (like HIV before it) is a hypothetical computer construct that does not exist in the real world. The "viral genome" is pieced together from short sequences of unknown provenance obtained from complex multi-species biological soups rather than from purified particles.

The pictures of "virus particles" sometimes proffered by virus researchers have never been proven to be anything other than the various types of extracellular vesicles produced by our own cells. Extracellular vesicles are protective structures rather than disease causing structures.

Genetic sequences uploaded to the internet (initially by the CCP) did not come from purified particles and are artificial constructs pieced together using some real sequences of unknown and unproven origin. These sequences undergo some "cutting and pasting", not with restriction enzymes and ligase enzymes but with computer keyboards, until the virologist artist is happy with their creation.

SARS-CoV-2 did not leak from a lab, and it is not a bioweapon because it is not a physical entity. It is a psychological weapon. The source of the Spike protein toxin is unclear and unproven. It may be completely man made or it may exist in nature in some form but has been partially re-engineered by inhumans.



Covid-19 (like AIDS before it) is not a new disease with a single cause but rather a misdiagnosis exploiting symptoms and signs of pre-existing disease which have nothing to do with a viral infection. Deaths from old age and a multitude of life-threatening conditions have been misdiagnosed under the umbrella of the fake Covid-19 label.

There has been no real pandemic but rather a pseudo pandemic has been created to generate fear and compliance.
