

Transparency: Covid 19 - Crimes Against Humanity

December 2019 a new 'virus' was detected in samples taken from a patient who presented themselves to a hospital in Wuhan, China.

Coincidentally, this new 'virus' was the catalyst required to stop the world, break economies, break the will of the global population, and bring in the Great Reset; a plan, an agenda for the 21st century, previously known as Agenda 21. This plan, devised and led by globalists and technocrats who, by theft and underhand dealings over the centuries, are the wealthiest and most powerful people on the planet.

Sars-Cov-2 was said to be the pathogen which caused what the world would come to know as Coronavirus 2019: Covid 19. This pathogen does NOT exist in nature; therefore, it CANNOT be considered the disease-causing pathogen. Furthermore, as this 'pathogen' has never been isolated, purified, injected into a test subject whereby the resulting disease/virus matches the symptoms suffered by the initial patient, it can only then be assumed that the virus itself does not exist either.

Koch's Postulates, the way in which viruses were detected and identified, right up until the late 60s were not used, instead the World Health Organisation in collaboration with the hospital in Wuhan, China decided that the respiratory symptoms experienced by the patient were sufficient to class them as a new novel coronavirus: Covid 19.

Wuhan has the worst air quality anywhere in the world, respiratory ailments and diseases are commonplace. The World Economic Forum, United Nations and World Health Organisation knew this and used it to their advantage.

What followed was the complete planned removal of freedom, globally. Countries locked down their citizens with differing draconian measures, all designed to put fear into the hearts of their citizens, and all based on the outputs from the various influenza pandemic scenarios which had been debated at conferences held in every country which signed up to the Great Reset since the 80s. The UK itself held more than eleven such conferences, including Exercise Cygnus at which the then Health Secretary Matt Hancock was present. The US held Crimson Contagion in 2016 and world representatives attended Event 201 sponsored and financed by the Bill and Melinda Gates Foundation in October 2019, three months prior to the non-identification of Covid 19 and Sars-Cov-2.

19 March 2020, the UK Government, and this is crucial, DOWNGRADED Covid 19 to nothing more 'than a nasty bout of flu', yet four days later the UK went into the first lockdown: why? Because the World Health Organisation told them to. Under the instruction of the World Economic Forum, the World Health Organisation acted and implemented the pathogen protocol globally. 23 March 2020 saw the end of freedom as we have known it.

The elderly were then moved from hospitals to care homes where they did not or could not receive the same level of treatment or medication as they had done whilst in hospital. This



action resulted in the first wave as those patients became very ill, very fast. The Liverpool Care Pathway was then used to end the lives of thousands. A mixture of Midazolam and Morphine was used to end their lives. The then Health Secretary, Matt Hancock ordered two years supply of Midazolam which was used within months. Culpable genocide.

Using a test originally developed as an analytical tool, not a diagnostic tool, the global population was subjected to constant testing for a non-existent 'virus'. Face coverings became the norm if you wanted to usurp your right to freedom of movement. One-way systems in retail outlets were installed, plastic screens placed at pay points and at desks, a two-metre rule of social distancing was imposed, visits to those in hospital and the care homes were no longer allowed. Our loved ones died alone.

Those deemed to be 'vulnerable' were basically placed under house arrest.

The late Kary Mullis, inventor of the RT-PCR test said, and we quote, "I guess if you run the CTs high enough, you can always find something out of something". CTs is cycle thresholds/magnification. Laboratories and test centres were running these at far higher numbers than those designated by Mullis (28 times magnification), some were run at 50-, 60- or 70-times greater magnification. Not only that but many samples were pooled, meaning that if a pooled sample was made up of twenty test subjects and just one was deemed to test positive, then the whole batch was deemed to have proved positive for a non-existent disease. Case numbers increased as a result, another factor in continuing the fearmongering among the general populous.

How did people test positive for a non-existent disease? Dr Christian Drosten and his team manipulated the reading frame of the RT-PCR test to match that of a computer-generated sequence of dead cellular materials as reported to be fact by the Wuhan Institute of Virology and the World Health Organisation. What many don't realise is that we, humans, shed externally and internally. We shed skin cells daily, hair daily and internally we shed bodily cells within a 24–48-hour period. It should be noted that Peter Daszak is a UK citizen, His father was taken prisoner by the Allies and later resettled in the UK; Greater Manchester to be precise.
