As noted in Ordinance #302, a fee of \$988.00 (Section 5J – System Fee) for each EDU (equivalent dwelling unit) + deposit which is the estimate by borough for excavating and connection to DWG borough water is payable at the time of application. The deposit will be kept in an escrow account. There is an additional water meter installation fee of \$200.00 and a water turn on/off fee of \$75.00.

Any expenses incurred above & beyond the deposit are the sole responsibility of the applicant (such as unforeseen excavation problems such as rock). These costs must be paid for before an occupancy permit can be issued and water turned on.

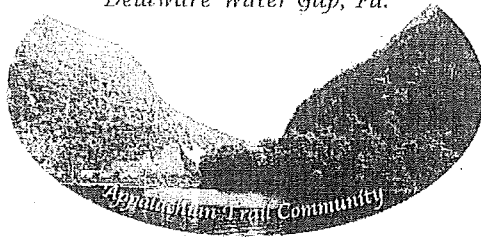
