AN ORDINANCE ADOPTING THE GEORGIA RULES OF THE ROAD, O.C.G.A. S40-1-1 AND O.C.G.A. S40-6-1 THROUGH 40-6-395, TO REGULATE TRAFFIC UPON THE PUBLIC STREETS OF TOWN OF MITCHELL IN GLASCOCK COUNTY.

## SECTION 1. Adoption by reference.

Be it ordained by the Mayor and Council of the Town of Mitchell that pursuant to O.C.G.A. S40-6-370 through O.C.G.A. S40-6-376, O.C.G.A. S40-1-1 and O.C.G.A. S40-6-1 through 40-6-395 of that title known as the Uniform Rules of the Road are hereby adopted as and for the traffic regulations of this municipality with like effect as if recited herein.

## SECTION 2. Penalties.

Be it further ordained by the authority aforesaid that unless another penalty is expressly provided by law, every person convicted of a violation of any provision of this ordinance shall be punished by a fine of not more than two hundred dollars (\$200.00) or by imprisonment of not more than sixty (60) days or both such fine and imprisonment.

## SECTION 3. Effective date.

This ordinance shall take effect from and after the 9th day of September, 1985. The foregoing ordinance was read and passed by the Mayor and Council on the following days:

AN ORDINANCE TO ESTABLISH SPEED LIMITS IN CERTAIN SPEED ZONES ON ALL STATE HIGHWAYS WITHIN THE TOWN OF MITCHELL; TO PROVIDE A PENALTY FOR THE VIOLATION THEREOF; TO REPEAL CONFLICTING ORDINANCES; AND FOR OTHER PURPOSES.

SECTION 1. Be it ordained by authority of the Mayor and Council of the Town of Mitchell that from and after the passage of this ordinance there are hereby created certain speed zones on the State, County, and City Highways which pass through the Town of Mitchell through and over which no vehicles, motor or otherwise, shall be driven or operated at a rate of speed greater than that which is specified for each of said zones, the speed zones being as follows:

FORTY-FIVE (45) MILES PER HOUR ZONES:

THIRTY-FIVE (35) MILES PER HOUR ZONES:

TWENTY-FIVE (25) MILES PER HOUR ZONES:

SECTION 2. Be it further ordained by the authority aforesaid that nothing herein shall be construed to repeal any other ordinances of said town governing the speed of vehicles over any other streets or parts of streets than those named herein.

SECTION 3. Be it further ordained that upon conviction for the violation of any of the terms of this ordinance any person so convicted shall be subject to imposition of a fine of from \$5.00 to \$50.00, and a sentence of from one to thirty days in jail, either or both or any part of either or both in the discretion of the trial officer or the Mayor.

SECTION 4. Be it further ordained that the provisions of this ordinance shall not be enforced until notice of said speed zones shall have been posted by the Department of Transportation of the State Highway Department of Georgia, the Town of Mitchell, or Glascock County.
