

Barkley's Hope Application for Extended Care & Boarding - The Alex Long Fund

- ***Application Criteria & Instructions***

Applicants be advised, you will need to provide specific information to extended care and services for a pet beyond the "Crisis Boarding" 30-day period. Since multiple agencies will be providing services, they will have their own intake process and applications to complete addition to this one. Simply filling out this application does not guarantee services will be provided. Pet owners must be able to provide proof of vaccinations for their pet prior to intake.

- **Applicants must be currently in or seeking inpatient treatment for drugs and or alcohol.**
- **Applicants must have a case manager and plan for after care.**

During this intake process you will need to go online to the Roice Hurst website to fill out their crisis boarding application FIRST. Next, you will receive an email copy of the responses to the online application. Then send that email along with this application to BarkleysHope@gmail.com - (This application is for 1 person and 1 pet)

- **Complete the Roice Hurst "Crisis Boarding Application" online FIRST**

(From Roice Hurst Website) If a personal crisis threatens to permanently separate you and your pet — like housing issues, domestic violence, financial hardship, etc. and you need temporary pet care while you get back on your feet, Roice-Hurst Humane Society's crisis boarding program covers up to 30 days of boarding at one of our partner boarding facilities. Roice-Hurst understands how crucial pets are to overall wellness, and we strive to keep pets and their people together whenever possible. Frequently Asked Questions

- What is the average cost of boarding a pet? It depends on the size and type and breed and the specific need of the animal, but the average cost is between \$500 and \$750 up to \$1500 a month.
- What happens if I default on my agreement? The animal will be rehomed. Barkley's Hope, Roice Hurst, and its partners will always be advocates for the animal and act in the animal's best interest.
- Can I visit my pet during my treatment program? As a rule, no because of liability issues and the resources needed to facilitate such requests at our end. Clients may be able to visit a pet if the boarding facility agrees.
- What does Barkley's Hope do with my intake information? The application goes to the case manager who will be collaborating with the client on their recovery as part of the case file.
- Can I leave my treatment for a medical or family emergency and restart the program later? As a rule. If you leave treatment against the advice of the facility, your sponsor or case manager, you have breached the agreement.
- What if I'm doing an outpatient recovery program? The extended crisis boarding program through Barkley's Hope is ONLY available to individuals who are in or entering an accredited inpatient program with a case manager.
