Dear Neighbor and Property Owner:

As previously communicated with you in our August monthly newsletter <u>The Common Thread</u>, Sugar Ridge Commons will be transitioning to a new property management company effective September 1, 2024. As such, this means that we will need to change certain data in how our payments for dues are being made today. This letter will briefly cover the most important changes that need to be made.

Attached are documents that relate to the transition to HOAK\anagementServices, LLC, who is the new property manager for our community. Mr. Simon Kaye is the property manager who is assigned to Sugar Ridge Commons.

Document No. 1 is a fact sheet covering the various ways that dues can be paid. Please review the document carefully and note that there are instances wherein a "fee" must be paid if you are choosing to pay your dues in that manner. If you pay by Credit Card, 3.5% must be added to the monthly amount (making the amount being charged on your card \$123.90 per month). If you pay by E-check, a flat fee of

\$1.99 must be added to the monthly amoung (making the amount of the e-check \$121.99.). No fees are charged if you pay by one of the following:

Check or Money Order Bank Bill Pay ACH - Automatic Draft

Document No. 2 is a 2 page form for initiating ACH—Automatic Bank Draft. This document must be completed in its ent\rety and returned to Sugar Ridge Common at Applewood HOA, 301 N. Pine Street, Ste 4, Spartanburg, SC. 29302. Either your checking or savings account (whichever you prefer) will be automatically drafted on the 16" of each month for the current regime fee of \$120.00 per month. As noted above there is no fee associated with this method of paying homeowner dues.

The third document is an informational letter that provides information about the reasons behind moving to a new property management company.

As another point, late fees are being waived for the months of September, October and November. This will hopefully help everyone get used to the property management company.

You must provide a voided check or letter from the bank indicating your account information. No other forms of verification will be accepted to initiate auto draft.
How to revoke your Authorizotlon• This authority will remain in effect until you have cancelled it in writing with HOA Management Services. Requests must be received two weeks prior to the next draft, otherwise it will be delayed until the following draft. Selling your home will not automatically revoke this authorization, you must still contact us.
*Changes In your ACH Direct Debit Authorization: Please contact HOA Management Services with any changes to your ACH Debit Authorization. Requests must be received two weeks prior to the next draft, otherwise it will be delayed until the following draft. We will update payment amounts to correspond with increase or decrease in regular dues as set by the Board.
Charges for non-sufficient funds: Any payments or attempted withdrawals from your account that are returned or rejected due to non-sufficient funds, closed account etc., will be charged an additional fee of \$37. This is a non-negotiable fee and will be applied directly to your personal account with the homeowner's association.
I acknowledge that the origination of ACH transactions to the authorized account must comply with the provisions of South Carolina and U.S. law.
