On November 15, 2022, I received an email from Steve Goncalves, the father of Kaylee Goncalves. He stated he had access to some of Kaylee's messages and phone calls. Steve stated he would have his other daughter, Alivea, contact me about those files.

I was able to speak to Alivea and she sent me various files, including an image from the Spokesman Review showing a camera on a nearby residence, text messages between Kaylee and Jack Decouer, text messages between Kaylee and her Uber driver (Eric), a recent phone call list, and video from the Grub Truck Twitch.tv feed.

I attached these files to the case file. The communication between Kaylee and Decouer was located on Decouer's phone examination and the Twitch feed was previously downloaded.

In the image showing the camera, it was found that residence was at 1112 King Road. The SD Card from the camera was brought to the Moscow Police Department, but the file system of the card was not recognized by any of the forensic computers. The card was returned to the owner and reinstalled into the camera.

On November 17, 2022, Ofc John Rosinsky re-contacted the owner of the camera, Paige Carter via phone. Carter stated she was out of town, but sent a video to Ofc Rosinsky showing a figure walk to the dumpster and appear to look inside.

To preserve any potential evidence on the camera, I asked Carter if we could seize the entire device, including the SD Card, to which she stated yes. Carter stated she would not be back in Moscow until approximately November 28, 2022. I directed Carter to contact me when she returns to her residence, at which time I will attempt to connect the camera back to her WIFI router and view video from the device.

On November 13, 2022, I was informed two of the victims had been patrons at the Grub Truck, located on Main Street in Moscow, Idaho. I was also informed Grub Truck streams live feeds of their customers and sales via Twitch.tv.

I was able to locate the Twitch account "GrubTruckers" and locate the stream from the November 12-13, 2022. This stream was labelled, "The Carbonara effect... we'll never reveal our secret ingredient" and located at <https://www.twitch.tv/videos/1651413498>.

In the video, Kalyee Goncalves and Maddie Mogen are seen walking into camera view on the video at 3:43:01 timestamp. They are accompanied by a male, later identified as John "Jack" Showalter. Goncalves orders and receives food.

At the 3:53:31 timestamp, the girls are seen walking around the truck and leave the area. Showalter appears to be talking to another patron and does not see the girls leave. Showalter then raises his arms in a "What?" fashion and walks away in a different direction than the girls.

A copy of this video was captured and saved as evidence.

On November 18, 2022, I logged into the Uber Law Enforcement Portal (lert.uber.com) and submitted an exigent preservation request for any location data associated with the Uber driver named Eric Gower with the phone number of (208)827-6059. Due to the nature of the investigation, Uber recommended an exigency request for the preservation.

In a screen shot received from Alivea Goncalves, it showed messages which appear to be from Gower's phone between Kaylee Goncalves and himself. The name of the recipient is "Kaylee Uber."

It is unknown if Gower was "on duty" with Uber at the time of him picking up Goncalves and Maddie Mogen. Uber stated if the driver was "on duty" it would show the location of the vehicle. If the driver was not "on duty," Uber would not have the data. I was informed by Uber Customer Service this is common if the driver provides personal transportation services.

At 1434 hours, I received an email from Uber stating they received my request.

I received an email at approximately 1617 hours from Uber, which contained files regarding the Uber logs of Eric Gower. The records showed his location up until approximately 0115 hours, where it appears no other information is found and Gower goes "off duty." These records were attached to the case file. No warrant was requested or returned as Uber provided the data via the exigent request.

1112 King Video

On November 13, 2022, I was informed of a possible surveillance camera located at 1112 King Road. Cpl Ryan Snyder had spoken with one of the residents at this location, Paige Carter, who had a camera using the Homeye Pro app on the porch of their dwelling.

Cpl Snyder provided me with the username and password for the Homeye Pro account associated with Carter. I asked Cpl Snyder if this video was stored on a cloud-based system for me to view or if Carter could download a copy of the video.

I was provided a 32GB SDCard from the camera, but the file format was not recognized by any of my forensic computers and prompted me to format the disk. Cpl Snyder informed me Carter could screen capture the video from her phone, and the card was returned to Carter to enable her to assist in the acquisition of the data.

On November 17, 2022, I requested the assistance of Ofc John Rosinsky to recontact Carter and see if she could provide the video from the camera. Ofc Rosinsky contacted Carter who stated she was in Boise, Idaho until November 28, 2022. Ofc Rosinsky Carter sent him a video of a male subject walking by the camera at approximately 0320 hours towards the dumpster on Ofc Rosinsky contacted me and I spoke to Carter and requested permission to remove the camera from the residence and she consented.

Based on my training and experience I know many of the different video surveillance cameras use a First-In, First-Out storage retention system. This means the newer data overwrites the older data. I was concerned data may be lost the longer the camera continued to record footage. I requested assistance from Ofc Aaron Morris to go to the residence and unscrew the camera from its location. The camera screws into a common light bulb base, commonly found on patio/porch fixtures. Ofc Morris returned a short time later with the camera and the SDCard.

On November 18, 2022, I again attempted to view the contents of the SDCard, I plugged the card into a write-blocker and it still was not recognized by the computer. I used FTK Imager version# 4.7.1.2 to make an image of the SDCard. Now

that the data was on a drive recognized by the operating system, I then used Axiom Magnet version# 6.5.0.32778 to parse data from the card.

In reviewing the data, I found over 13,000 individual images from the card. They appear to be individual video frames from the camera.

While attempting to view the data on the card, I received a forwarded email from Charles Niko, whose sister Maura Kido resides at the residence. The email stated that he was viewing the video remotely when Ofc Morris removed the camera. He stated he saw a suspicious vehicle in the area and was concerned with the video footage stored on the device being overwritten.

I was then put in touch with Torrey Long, another resident at 1112 King Road. Long stated she would be back in Moscow at approximately 2000 hours. I met with Long at her residence and asked again if she would be willing to assist in recording screen captures on her phone from the device. I explained to Long I would replace the camera, gather the information and then take the camera as evidence. I also explained to Long I needed to take the wireless router, since the camera was already linked to the WIFI network. Long stated she would consent and allow both items to be seized.

I reinstalled the camera in the light socket and it powered on. I was able to watch as Long accessed the footage on the camera. During this time, the camera showed a vehicle entering the area at approximately 0356 hours and leaving at a high-rate of speed at approximately 0420 hours. Long provided the videos to me. I uninstalled the camera and seized the wireless router. Both items were then taken back to the Moscow Police Department as evidence.

On November 19, 2022, while reviewing the videos located at 0356 and 0420, it appeared the vehicle left the area and may have travelled on Walenta Drive, however, the video stopped. In an attempt to see further, and gain perhaps a better resolution, I reconstructed the wireless network the camera operated on by powering on the wireless router. I downloaded the Homeye Pro app on my work phone.

I was able to use the app and download the video clips. These clips included audio, which were not a part of the screenshots completed and were able to capture a longer duration. In the clips, the vehicle's exhaust and acceleration can be heard, as well as seeing the vehicle leave at a high rate of speed on Walenta Drive.

After capturing the clips, I disconnected the camera and wifi router and placed them into evidence. The videos were placed onto a DVD and placed into evidence.

Router Interrogation

On November 13, 2022, I responded to 1122 King Road in Moscow, Idaho in an attempt to interrogate the wireless router located at this residence. After speaking with Cpl Brett Payne, he informed me the wireless router and cable modem were located in the living room on the second floor.

After arrival, I used an ethernet cable to connect my laptop to the Local Area Network (LAN) ports on the back of the Spectrum WiFi 6 router with the Serial # 60SA2203000B752. The router then provided my laptop with an IP address and Gateway IP, which resolved to the router.

I attempted to locate a web-based management portal for the device but was prompted to download the Spectrum app and use the account username and password to access the device. I contacted Spectrum technical support and found this was the only way for the client to access the data on the device.

I then called the Charter Law Enforcement Response Team (LERT) and spoke with a representative and tried to ascertain if Charter/Spectrum could retrieve data from the router via their diagnostic portal. After several days and phone calls to Charter, I spoke with Tammy Deloach, the manager of the Legal Response Operations Center. Deloach stated her team was working on verifying if the router hardware was able to be accessed.

On November 17, 2022, I again called Charter and left a voicemail. Deloach returned my phone call and stated her technicians were able to access and download the data from the router, however, they did not preserve the correct timeframe specified in my request. I was told she would have her technicians retry and preserve the data.

On November 17, 2022, I again called Charter and left a voicemail for Deloach. I received a call back from Deloach who stated the technicians were able to retrieve data for the time periods of September 14, 2022 to November 7, 2022 and November 11, 2022 to November 14, 2022. I was informed there was a problem with their cloud services and that resulted in the data loss for November 8-10. I informed Deloach I would be applying for a warrant and requesting that data with the legal process.

From my training and experience, I know wireless routers (WIFI routers) allow wireless devices (phones, tablets, laptops, etc) to connect to them for access to the internet or other devices on the local area network (LAN). During this process, after a device has successfully connected to the wireless router, a log of this connection, and the specific MAC address (Media Access Control) of each device, is kept on the device. If a user previously selected the "connect automatically" setting while connecting to the wireless router, which is a common default setting, the device will connect to the router automatically without any user input. These devices would have to be in close proximity of the router to be shown on the MAC address log.

The data previously stored on the wireless router, located at 1122 King Road, and preserved by Charter/Spectrum, may show individual MAC addresses of devices connected to the device. If the suspect had previously connected to the wireless router, was in close proximity to the wireless router located in the residence, this device may have automatically connected and appear on the MAC address logs. This could provide evidence of when a device was in close proximity of the router on the night Madison Mogen, Kaylee Goncalves, Xana Kernodle and Ethan Chapin were murdered.

I requested the assistance of the Latah County Prosecutor's Office in applying for a warrant to serve on Charter for the data records preserved and stored at Charter Communications, associated with the Spectrum Wireless Router with Serial Number 60SA2203000B752 and MAC 4C:19:5D:42:2E:D1, and Spectrum Cable Modem with MAC 1C9ECCCD9B9C and Serial Number 472668464 from the time frame of September 14, 2022 to November 14, 2022.

On November 21, 2022, I was granted a warrant for the data preserved by Charter and served the warrant at approximately 2039 hours via email to Austin.McNeil@Charter.com.

On November 22, 2022, I received an email from McNeil stating the files were ready to download via the Charter Portal. I logged into the portal, downloaded the files and saved them to a computer in the secure forensic lab at the Moscow Police Department.

I completed the warrant return receipt and affidavit. These documents were sent to the McNeil Prosecutor's Office to be returned to the court. I also emailed a copy of the receipt to Charter (Austin.McNeil@charter.com), as this was the originating email address associated with the documents.

On November 17, 2022 Jack Ducouer was interviewed by Sgt Mike VanLeuven from the Idaho State Police at the ISP District One Office. At that time, he provided his phone to Sgt VanLeuven along with consent to the search the phone. That phone is an iPhone XR with IMEI 353069107906768 transported to the Coeur d'Alene Police Department Forensic Lab at 3818 Schreiber Way, in Coeur d'Alene Idaho 83815. I applied for and was granted a search warrant to access the contents of the iPhone.

The phone was to be extracted by Det Dustin Taylor of the Coeur d'Alene Police Department. Det Mike VanLeuven had taken the phone to Dustin Taylor at the computer forensic lab at Coeur d'Alene Police Department. I emailed a copy of the warrant to him at 1643 hours on November 17, 2022.

On November 18, 2022, while confirming Det Taylor received the warrant, I was informed the phone was no longer at Coeur d'Alene Police Department. Idaho State Police Lieutenant Paul Berger picked up the phone from Taylor and delivered it to the Spokane County Sheriff's Office, where Investigative Analyst Vince Jimno received it. The data on the phone was forensically extracted at that location.

On November 19, 2022, Idaho State Police Det. Richalderson retrieved the phone from the forensic lab and delivered the phone to Decour's mother per the attorney's wishes.

On November 21, 2022, Det Anderson of the Idaho State Police provided Sgt VanLueven with a USB drive containing the extraction. Sgt VanLueven then provided the USB drive to me and it was placed into the secure forensic lab at the Moscow Police Department. An examination will be completed at my earliest convenience.

Since the warrant was not served, I did not complete a warrant return receipt as nothing was collected. Court documents were sent to the Latah County Prosecutor's Office to be returned to the court.

On November 13, 2022, I was directed to interview potential witnesses in regards to the incidents at 1122 King Road. The following interviews were conducted at the Moscow Police Department.

#### Interview 1:

Dylan Mortensen DOB: 09/26/2003 PH: 208-283-4782

Address: 1122 King Rd

On 11/13/2022 Dylan Mortensen was interviewed in regard to the homicide investigation at 1122 King Road. Dylan said she was a resident of the house where the incident occurred. Dylan said she was at a Sigma Chi party, at around 1030 hours on 11/12/2022, where she was drinking. Dylan said she went to "Ally's house". Dylan said she believed she arrived home between 0030 hours and 0100 hours on 11/13/2022. Dylan said she thought Bethany arrived home at around 20 minutes after she arrived.

Dylan said she believed Maddie and Kaylee arrived home at around 0130 or 0200 hours on 11/13/2022. Dylan said up to this nothing weird had happened during the night. Dylan said she and her friend "Lake(?)" came home, followed by Bethany from Sigma Chi. Dylan said Lake lived at the Pi Beta Phi house and Bethany was her roommate at the residence. Dylan said when Maddie Mogen and Kaylee Gonclaves came home from the corner club at the same time, and everyone went to bed.

Dylan was asked about the layout of her house. Dylan said Kaylee's room was directly above her room. Dylan said she lived on the 2nd floor and Kaylee lived on the 3rd floor. Dylan said Kaylee and Maddie both live upstairs on the 3rd floor in separate rooms. Dylan said Xana lived closest to the bathroom on the 2nd floor and Bethany lived on the first floor.

When asked about Murphy, Dylan said it was a dog owned in common between Kaylee and her ex-boyfriend Jack. Dylan said there were no apparent issues between Kaylee and Jack. Dylan said Maddie had a boyfriend named Jake Schriger who was in Boise at the time of the incident. Dylan indicated Xana was dating Ethan Chapin who was in the room with her at the time of the incident. Dylan did not know of anyone who would want to hurt Ethan, when she was asked. Dylan was asked if she saw any cars in the area that should not be there. Dylan said "No I was

not really looking at that."

Dylan said she woke up at around 0400 hours on 11/13/2022, where she could here Kaylee and Murphy, the dog, dancing. Dylan said she knew it was Kaylee because she recognized her voice and could hear Murphy barking. Dylan said she heard Kaylee go upstairs and say "There is someone here." Dylan said thought she heard Kaylee run back down the stairs. Dylan said Kaylee sounded scared when she made this statement.

Dylan said at this time she jumped up locked the door because she did not know what else to do. Dylan said she called out Kaylee's name and did not indicate if she got a response. Dylan said she then tried to call Kaylee, Xana and Maddie on their phones. Dylan was asked if she saw anyone come downstairs or heard anything. Dylan said, "No, I don't even know how they got in. We're usually pretty good about locking doors and never had problems before. I was just really random."

When asked again about the series of events, Dylan said she opened the door when she cried out to Kaylee, then closed the door because she was scared. Dylan said she then opened the door again and heard who she thought was Kaylee, but could have been Xana, crying in the bathroom. Dylan said she then heard a man's voice say "It's OK I'm gonna help you." Dylan said it was weird because the statement was not in a nice way and the voice was one she had never heard before.

Dylan said she called out to Kaylee again and there was no crying after and she did not know what happened after that. Dylan said she opened the door again and "the guy" is right there. Dylan described the male as approximately her height (5'10") or a few inches taller, not skinny but athletic build. Dylan said the suspect was wearing all black with masks that covered just his forehead and goes around his face. Dylan showed with her hands the mask exposed his nose but covered the mouth area.

Dylan said she believed the suspect was white but did not remember eyebrow color or what his eyes looked like. Dylan said when she saw the suspect, he saw her and just left. Dylan said she believed he was holding something near his stomach or belt line. Dylan used both hands to point straight out from her abdomen. Dylan then moved her hands apart and back together to simulate a bulge. Dylan said this area was black in color and she thought now maybe it was a gun. Dylan said the unknown object had an arrow shape. Dylan seemed really unsure and said she was tired during the event.

Dylan was asked how long she believed it was from the time Kaylee said "Someone is here", to when she saw the suspect. Dylan said she thought it was about 10 or 20 minutes. Dylan went on to say she was "in and out of it" and she did not fully remember the incident. Dylan was asked where the suspect was at in the residence when Dylan saw him. Dylan said the suspect was between her bedroom door and the kitchen. Dylan said she remembered watching the suspect go out the kitchen door and leave. Dylan said at this time she closed her door and locked it as fast as she could. Dylan said the suspect did not walk toward her or say anything.

Dylan said once the suspect left she immediately called Bethany. Dylan said Bethany informed her she heard a sound that sounded like a firework. Dylan then said she told Bethany she called everyone and they are not answering. Dylan said she was in and out of it and believed everyone was just asleep. Dylan said she then went to Bethany's room locked the door and went to bed. Dylan said she woke

up at around 1100 or 1200 hours and called her roommates and no one answered. Dylan said she called Hunter. Hunter came to the residence, went upstairs and told Dylan they needed to call law enforcement immediately. Dylan was asked if there was anything else she wanted to share. Dylan said the noise Bethany described the noise as a "loud boom", but Dylan did not hear it.

Dylan was asked if any of her roommates shared any weird experiences in the last couple weeks, or calls or texts. Dylan said "No, it's been all normal. Nothing weird at all. Nothing really weird happens in Moscow usually." When asked if there were any altercations at the Sigma Chi party. Dylan said no everything was normal. Dylan mentioned again she was with Dylan and Xana at the party. Dylan was asked if anyone was having sexual relations with anyone they shouldn't be. Dylan said no.

Dylan brought up an incident which occurred about a month prior. Dylan said she and Bethany remembered Kaylee saw a shadow while she was taking Murphy at side. Dylan said Kaylee also mentioned when she was at Winco 2 or 3 weeks prior, an individual was following her. Dylan also said she arrived home one time and the door to the residence at 1122 King Road was found open. Dylan said she did not believe the slider door was locked the night 11/12/22. Dylan said she hear Murphy barking a lot around 0400 hours 11/13/22 when Kaylee went upstairs. Dylan said she heard Murphy go outside barking as well. Dylan was unsure if Murphy would chase a suspect outside. Dylan said she did not remember if the suspect who ran left the slider door open.

Hunter said around 1200 hours on 11/13/2022, Dylan called Emily (Hunter's Girlfriend). Dylan told Emily she thought something "was not right in her house" Dylan also told Emily she heard or saw a man in her house the night prior. Dylan asked Emily and Hunter to come over and make sure everything was OK because she locked herself in Bethany's room. Hunter said he was the first person to get to the residence. Hunter said he entered the code to the front door where Bethany and Dylan were in Bethany's room on the first floor. Dylan and Bethany were telling Hunter they did not know what was going on.

Hunter said he went up the stairs and immediately went into Xana's room. Hunter said this was the only room he went into. Hunter said when he approached the door it was only partially open. Hunter said when he opened it, he saw Xana and Ethan. Hunter said he initially did not realize all the blood was dried blood in the room. Hunter said he thought at first they had been drunk and left a mess. Hunter said when he stood there for a moment he began to realize what he was seeing. Hunter said Bethany and Dylan were uncontrollably crying. Hunter said he told them to get out of the house and call law enforcement.

Hunter said he then went to the kitchen and grabbed a knife from the drawer. Hunter said he then went into the room and checked the closet to make sure there was not anyone else in the room. Hunter said he checked for a pulse on both Xana and Ethan. Hunter said both of the bodies had rigor mortis and were cold with no breath or pulse. Hunter said he believed the two had been deceased for a while. Hunter said he believed he left the knife on the folding table in the living room. Hunter said Emily, Josie and Linden started to enter the house and come up the stairs. Hunter told them to get out of the residence. Hunter said this was about the time Moscow PD arrived on scene. Hunter said the officer told him

to stay where he was at. Hunter said he did not know if anyone else was upstairs as he had not gone anywhere else in the house. Hunter said he had trouble comprehending what he was seeing.

Hunter said he was not at the Sigma Chi party the night prior. Hunter said he and Ethan were texting the night prior (11/12/22) by phone. Hunter said Ethan wanted him to come over but Hunter chose not to. Hunter said he knew Ethan since Fall of 2021. Hunter said he was in Phi Delta Theta and Ethan was a member of Sigma Chi. Hunter indicated Josie and Emily were in the same sorority and were roommates. Hunter said Linden who was also present was in the fraternity Delta Tau Delta and was currently dating Josie. Hunter said he and Linden stayed at Josie's apartment with Emily and Josie the night of 11/12/22. Hunter was asked when was the last time he was at 1122 King Road.

Hunter indicated he was last at the residence on 11/12/22 where he was "pre-gaming for the vandals football game." Hunter said he got to the residence at around 1200 hours or 1300 hours and left at about 1430 hours to go to a different party. Hunter said the last time Emily was at 1122 King Road was Friday 11/11/22. Hunter did not know of anyone who had issues with Ethan and Xana dating. Hunter estimated Xana and Ethan were dating for 8 months. Hunter said he knew Xana very well through his girlfriend Emily. Hunter said he was not very familiar with Maddie or Kaylee. Hunter allowed pictures to be taken of his phone of the conversations between him and Ethan.

Jenna said she heard Dylan on the phone in the background saying "I saw something." Jenna said Bethany asked her to come over to 1122 King Road and pick her up. Jenna said she was in Pi Beta Phi with Dylan, Lake, Bethany and Xana. Jenna said Xana and Maddie were both in Pi Beta Phi but the dropped out and Kaylee was in Alpha Phi but dropped as well. Jenna suspected they girls dropped their respective sororities because of issues with other girls in the houses. Jenna specifically cited girls on the "executive board" who tell other members what to do. Jenna suspected this was what they did not like. Jenna confirmed she, Lake, Bethany and Dylan were still active members in Pi Beta Phi. Jenna said the girls who were still active members of the sorority who chose to not live in the house did so because of money issues. Jenna said Maddie was Bethany's Big Sister in the sorority house.

Jenna said she knew Kaylee saw a dark figure staring at her from the tree line when she took her dog Murphy out to pee. Jenna said this occurred about a month ago at 1122 King Road. Jenna said there has been light hearted talk and jokes made about a stalker in the past. Jenna said all the girls were slightly nervous

about it being a fact though. Jenna did not indicate any social media issues or issues between the girls who lived together. Jenna said there was no issue with girls from the Pi Beta Phi sorority and the residence at 1122 King Road. Jenna said the front door had issues with locking and sometimes it could be opened without a code. Jenna said she did know the code to the front door. Jenna said she was unsure if the residence kept the back-sliding door locked regularly.

Linden recalled an incident from about a month prior, where Dylan said there was a guy stalking her. Linden said he did not hear anything from the night prior.

On November 15, 2022, I contacted Det David Taylor of the Coeur d'Alene Police Department with a request for an agency assist. I requested assistance unlocking the cell phones of Kaylee Goncalves, Maddie Mogen, Xana Kernodle and Ethan Chapin, the victims in this case. I emailed Det Taylor a copy of the signed warrant describing the phones as being searchable.

On November 16, 2022, the phones were transported to the CDA Police Department for a forensic brute force attempt to unlock them, however Det Taylor stated he was not able to extract any information from the locked phones and the phones were not supported for the brute force pin code extraction. The phones were then returned to the Moscow Police Department on November 17, 2022.

I then asked for assistance from Cpt Tyson Barrett in attempting to gain pin codes from family members to access the data on the devices. I was provided pin codes for Mogen, Kernodle and Chapin, which successfully unlocked the devices. The pin codes provided for Goncalves' phone did not unlock the device.

On the three devices I was able to unlock, I performed advanced logical extractions on the devices at the Moscow Police Department. A report for each device will be completed separately.

On November 20, 2022, I again requested the assistance of Det Taylor in gaining a full-file system extraction on the three unlocked devices. The phones were delivered to CDA Police Department on November 21, 2022. On November 22, 2022, Det Taylor stated he would not be able to complete the extractions.

On November 23, 2022, I went to the CDA Police Department and picked up the phones. I then took them to the Post Falls Police Department and spoke with Det Neil Uhrig. Det Uhrig informed me his forensic tools would not support a full-file system extraction.

On November 25, 2022, I went to the Walla Walla Police Department and spoke with Det Chris Ruchert. Det Ruchert stated her forensic tools would be able to support full-file system extractions on the unlocked devices, and would be able to complete limited extraction on Goncalves' locked phone. I left the phones with Det Ruchert to be extracted.

On November 28, 2022, Det Ruchert informed me the phone extractions were complete and ready to be picked up. On November 29, 2022, Det Justin Deane picked up the phones and returned them to the Moscow Police Department. I received the four devices and placed them in the secure computer forensic lab. The extracted data was copied to the forensic computers and verified by hash values.

Upon arrival, I unplugged the power to the current router and removed the camera from the light socket on the exterior of the residence. I then powered on the router I had secured from the residence earlier and installed the camera I secured as evidence earlier into the light socket. While installing the camera, I hear a crack and felt the lightbulb base mount become loose. It should be noted the approximate temperature outside while installing the camera was between 5 and 9 degrees.

I previously had installed a new SD Card into the camera and powered on the router and camera at the Moscow Police Department to ensure the camera was functional.

I then was able to monitor the camera using the Homeye Pro app on my phone. Cpl Brett Payne was able to drive a white colored vehicle into the view of the camera. Sgt Dustin Blaker parked a vehicle near the residence and closed the doors and trunk on a vehicle for audio comparison. A K9 Unit from Lewis County Sheriff's Office was utilized to capture barking audio comparison from the residence.

Upon completion of the data collection, I powered off the evidentiary router and removed the camera from the light socket. In doing so, the base detached from the camera and a wire became disconnected. I gathered the router and camera, placed them back into their evidentiary bags and returned them to the secure computer forensic lab.

I reinstalled the current camera and reconnected the power to the new router. I contacted Long to ensure she could access her camera, and she responded in the affirmative. Cpl Payne and I then ensured the residence was locked and left the residence without further incident.

I was assigned the task of examining the Call Detail Records (CDRs) that were obtained from AT&T pursuant to a warrant served by Cpl Brett Payne for the time frame of November 12, 2022 at 0000 hours through November 14, 2022 at 0000 hours PST. These records were requested for the account associated with the phone number (509)592-8458, known the "8458 phone." This phone showed the subscriber as Brian Kohberger.

I was specifically requested to examine the records showing connectivity to cell towers between the hours of 0200 and 0600 PST (1000 and 1400 UTC), as this was the timeframe surrounding the homicides at 1122 King Road. Although the records contained records for voice, data, and SMS usage in the 48-hour data set, I only located 27 data usage records in the specified timeframe.

To assist in mapping the location of the cellular towers and the direction of their sector antennas I imported the data into CASTViz version # 30.0.0.

The 8458 phone connects with several different cell towers in Pullman, Washington between 0200 hours and 0225 hours. The phone appears to be traveling within or near the city of Pullman, Washington.

At 0242 hours the phone connects to a tower near North East Skyview Drive on the Washington State University Campus.

At 0247 hours, the phone connected to a tower on Observation Drive on the Washington State University Campus.

In continuing to examine the data, I found an approximately 2-hour period with no interactions between the 8458 phone and the AT&T network between 0247 and 0448 hours.

The phone connects to a tower located near Paradise Ridge, south of Moscow, Idaho at 0448 hours.

The phone connects with towers south of Moscow, Idaho, which is consistent with travel back to Pullman, Washington utilizing towers along the route.

---

From my training and experience, I know cellular devices can send and receive data to cellular towers with the user's input (such as surfing the internet) or without the user's input (system data). The normal reasons for a cellular device to not show connections to a cellular tower are the device is not in range of the tower's signal, the device is physically blocked from receiving/sending (such as a faraday bag), the device is in airplane mode, or the device is powered off.

I contacted AT&T Global Legal Demands Center and confirmed devices on the AT&T network connect at least every 60 minutes, if no user connectivity is initiated.

I verified the location of the several towers shown in CASTViz and confirmed their locations with the data in the Call Detail Records.

On October 17, 2023, I received an email from the Latah County Prosecutor's Office in reference to downloading additional video from the security camera seized from the residence located at 1112 King Road in Moscow, Idaho.

Previously video had been downloaded from the camera for the approximately time frame of 0230 to 0430 hours on November 13, 2022. These videos were downloaded and contained audio. Through different methods using forensically acquired data from the camera's SDcard, additional videos were downloaded, however, they did not include the audio.

I was requested to download videos, to include audio, from the approximate time frames of 0445 to 1200 hours on November 13, 2022. Due to the fact the camera light bulb connection was inadvertently broken previously, a repair to the device to allow it to be powered on was needed. In the email received on October 17, 2023, Defense Counsel Anne Taylor provided approval of the repair. Prior approval was provided by the Latah County Prosecutor's Office.

I was able to request and receive the camera and wireless router from evidence. I was successful in replacing the light-bulb threaded connection with a standard wall-plug to power the device. The device powered up and I was able to download videos from 0445 hours to 1205 hours from the device. Upon reviewing the videos, they appeared to contain audio.

The videos were saved to a forensic computer located in the secure Moscow Police Department. These videos were concatenated using Axon Investigate (formerly called Input-Ace) version# 3.2.0. These files were placed onto Blu-Ray disks and placed into evidence. I returned the camera and router to evidence after resealing their respective containers.
