

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://stlsportscompany.com/>, and St. Louis Sports Corp: DBA: St. Louis Sports Company Apparel & Authentics and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to St. Louis Sports Corp: DBA: St. Louis Sports Company Apparel & Authentics include <https://stlsportscompany.com/> and St. Louis Sports Company. The St. Louis Sports Company website is a ecommerce site. By using the St. Louis Sports Company website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, St. Louis Sports Company may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase St. Louis Sports Company's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through St. Louis Sports Company's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. We also may gather additional personal or non-personal information in the future.

## Use of your Personal Information

St. Louis Sports Company collects and uses your personal information to operate and deliver the services you have requested.

St. Louis Sports Company may also use your personally identifiable information to inform you of other products or services available from St. Louis Sports Company and its affiliates.

## Sharing Information with Third Parties

St. Louis Sports Company does not sell, rent or lease its customer lists to third parties.

St. Louis Sports Company may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to St. Louis Sports Company, and they are required to maintain the confidentiality of your information.

### **Tracking User Behavior**

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the

- public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
