Last Thursday at Town Hall, a reception was held to celebrate Myra Cockerham's retirement and honor her for the 30 years she dedicated to the town of Hilliard. Myra was joined by her husband, Jerry, as well as their children and grandchildren. The Hilliard council, staff, employees and lots of friends joined in the celebration. Myra also celebrated working 30 years at Hilliard Town Hall. During her time with the town, she also was an active member of the Hilliard Volunteer Fire Department for four years. Myra became well known as the Hilliard historian for those that stopped by the office with questions about the town. "Myra agreed to continue to be our town historian when we need her," said Town Clerk Lisa Purvis.

Myra began her career in Hilliard when the mayor was Ray Mager. She next served under mayors David Buchanan, Cris McConnell, Floyd VanZant and the current Mayor John Beasley. "There was a lot of blood, sweat and tears throughout my career. I've met a lot of people and made many



friends," said Myra. "As with any job, there have been challenges, but we all worked through them. I've done the best job I could do during my time and I'm proud that I've made it 30 years."

Prior to the meeting, Mayor John Beasley advised the audience that the town wished to honor Myra Cockerham and her service to the town. "This is bittersweet, as it is bitter for the town as we will miss Myra however, awesome for her to enjoy her retirement," said Beasley.

The Florida Tree Farm Program is proud to recognize Mr. Floyd Vanzant as the 2024 Jon Gould Florida Outstanding Tree Farmer of the Year. Each year, one Certified Tree Farm out of the 1,300 tree farms in Florida, is selected for demonstrating exceptional forest stewardship to protect and improve our forest resources and promoting forest stewardship within their community.

The Vanzant property has been in the family since the early 1800's and has historically been used for timber and livestock production. The 400-acre property is owned by Mr. Vanzant and his wife, Mary, who now reside on the property that he once grew up on. to efficiently graze his cattle while providing timber, shade and forage. Along with the areas he has designated for silvopasture, he thoughtfully considers soil and location to identify areas that he can dedicate to pasture or timber. Because Mr. Vanzant is willing to share his experience, in October 2023, he partnered with the Florida Forest Service and the Florida Tree Farm Program to host fellow landowners on a tour so they could see first-hand the success of his silviculture practices.

Recently, his son-in-law, Michael



Franklin, has assisted Mr. Vanzant by taking an active role with the land management. Along with daily responsibilities of caring for the cattle and conducting tractor work, Michael encouraged Mr. Vanzant to connect with the Florida Forest Service County Forester so he could develop a written Forest Stewardship Plan to carry Mr. Vanzant's vision forward. Michael's assistance on the land is appreciated by the family.

A Word From the Publisher



Here are five that I know of: Alliance Defending Freedom; First Liberty Institute; Liberty Counsel; Thomas More Society; and American Center for Law and Justice.

The next agenda item included the approval of the council for a Capital Expenditure for the old Town Hall & Volunteer Fire Department Generator Project from Miller Electric Company in the amount of \$35,694.03.

The final item concerned the approval of AECOM Technical Services, Inc. payable of \$8,250 for project Environmental Assessment. This project is at the Hilliard Airpark and is fully funded.

The next regular meeting of the council will be held Thursday, October 3 at 7 p.m.

Acts: The Spread of the Gospel

The book of Acts is unique for two primary reasons. The book of Acts is the only book that was an intentional sequel. Luke is the author of Acts. Luke's first volume was the gospel of Luke and his second volume was the book of Acts (Luke 1:1-4, Acts 1:1-4). In the first volume, Luke chronicled the beginning of Jesus and his earthly ministry until the time of the ascension. In the second volume, Luke records the continuation of the ministry of Jesus in his ascended state through the ministry of Jesus' spiritual body, the church. The second unique feature of the book of Acts is that it is the only historical book in the New Testament. If you remember, the Old Testament had a whole section of historical books (Joshua-II Chronicles). The first historical event in the book of Acts is the ascension of Christ (30 AD) and the last historical event in the book of Acts is Paul's arrival in Rome as a prisoner (60 AD).

When interpreting and applying the book of Acts, it is going to be critically important to understand how to apply historical narratives in a responsible way. We do not just read the Bible and do what it says. The first command in the book of Acts is to wait in Jerusalem. We are not out of the will of God if we are not waiting in Jerusalem. Apart from the book of Acts, much of the New Testament would be unintelligible. There has been a radical change that has taken place across the testaments and Acts bears witness to these changes. Acts let's us see why there is a shift in focus from Israel to the church. Acts allows us to see why the food laws and dietary restrictions are no longer in force. Acts shows us how Christianity became a global religion. Acts shows us who the Holy Spirit and how he empowers the church to fulfill the mission.

If you remember, Luke's Gospel was arranged around a travel narrative. The same is true of the book of Acts. The outline and purpose for the book of Acts is found in Acts 1:8. "But you will receive power when the Holy Spirit has come on you, and you will be my witnesses in Jerusalem, in all Judea and Samaria, and to the ends of the earth." The book of Acts is the historical narrative of how the gospel went out from Jerusalem to the ends of the earth. An outline of the book of Acts that follows Acts 1:8 is as follows:

- The Witnesses are Empowered: 1-2: The Spirit is promised (1) and the Spirit is poured out and the church is empowered for mission (2).
- The Witness Begins in Jerusalem: 3-7: This section is marked by a series of firsts. The first clashes with the authorities (3-4), the first internal clashes in the church (5-6a), the first martyr (6b-7), and the first missionary (8)
- The Witness Spreads into Judea and Samaria: 8-12:24. In chapter 9, Paul, the Apostle to the Gentiles is converted. In chapters (9:32-11:18), a Gentile, Cornelius, is converted. In the remainder of chapter 11, a large number of Gentiles are converted. In chapter 12, the church is persecuted and begins to spread out to the ends of the earth.
- The Witness Spreads to the ends of the Earth: 12:25-28. This last half of the book focuses primarily on Paul. Paul is presented as a pioneer missionary in 13-21:26. In this section of the book of Acts, Paul takes three missionary journeys. As a result of these missionary journeys the gospel spreads to Asia (12-25-16:5), Europe (16:6-19:20), and eventually to Rome (19:21-28). From Acts 21:27-28, Paul is a prisoner in chains as he finally arrives in Rome in chains, but the Gospel is unchained and Paul preaches the Gospel unhindered (Acts 28:31).

NCBOCC Adopts Reduced Millage Rate for Fourth Consecutive Year

On Monday, September 23, the Nassau County Board of County Commissioners held its second public hearing for adoption of the Fiscal Year 24/25 Budget. This was the end of an 8-month budget process which included a public budget workshop and a first public hearing held on September 9, 2024.

This is the fourth consecutive year that the BOCC was able to reduce the millage rate (property tax rate) while continuing to fund the critical public safety needs through investments into the Nassau County Sheriff's Office and the Nassau County Fire Rescue Department, along with critical investments through the Capital Improvement Plan, Pavement Management Plan, and Chip Seal Program. Additionally, the budget provides funding for the staffing and operations of the new Fire Station No. 10 (Tributary) currently under construction.

Understanding the demands of the residents and the future economic pressures, the adopted budget continues to focus on improving the quality of life for residents, while working within the limited and restricted revenues of the

county. The budget is also structured to continue funding for investment into land conservation and management, in line with the request from the community and pursuant to the voter approved referendum in 2022.

As Nassau County continues to be one of the fastest growing counties in both the state and the country, this population growth requires additional service capacity to meet these demands. The BOCC understands these growing demands along with the growing demands of the current residents and has continued to focus on supporting public safety operations through the Sheriff, Fire Rescue, Emergency Operations, Roads and Animal Services.

Following the public hearing, Chairman John Martin stated, "This is the fourth year we've lowered the millage rate to a modified millage rate. I think that's something we can all be proud of."






