With the spreading of the COVID-19 virus (Coronavirus) came shutdowns. Schools, daycares, colleges, libraries, county offices, courts and more, all came to a halt. Even the county beaches were closed to discourage gathering. Students left for spring break and did not return. Distance learning became the new way of education and teachers were instantly thrown into a world of virtual teaching. We tried to live life as usual as much as possible, but events soon began to be rescheduled or cancelled and businesses began to temporarily close their doors per orders of the Governor. Hair salons, barbershops and bars had to basically suspend all services, leaving many families without income. Even church services were altered, mostly becoming virtual, streaming services online. The State of Florida did continue to make sure children who depended on school meals were fed. The food staffs at each school worked hard, even into the summer, to offer drive-through meals to children.

Events such as weddings and funerals were postponed since gatherings were discouraged. Graduations for the class of 2020 were postponed and schools and community members went out of their way to honor the graduating class. Kudos to the Nassau County School Board for coming up with a plan to eventually graduate the seniors in June observing safety protocols.

The Nassau County Department of Health and Emergency Operations Center became quite popular as many residents looked to them for information and statistics locally. Barnabas and many local churches also became more important as families leaned on them for food donations. Barnabas and the Nassau County Council on Aging took care of many seniors in the community, delivering meals and smiles. Nursing homes were one of the first establishments to close doors to visitors in order to protect the elderly. This was hard for many families, but

especially straining on those who did not understand why they weren't receiving visitors. As time went on, we got creative and held drive-through parades for residents at Life Care Center in Hilliard, Dayspring Senior Living and Dayspring Village. So much love was shown as families waved and blew kisses to residents.

Unfortunately, many residents in our area have been affected by the virus. The loss of loved ones as well as the battle once contracted is not to be taken lightly. Many have been hospitalized and thankfully recovered, while some never even showed symptoms. As we all adjusted to social distancing, virtual gatherings and yes, even masks, life went on. Outdoor events and activities became more popular. We slowly learned more about the coronavirus and began to reschedule events. Businesses resumed with changes and it seemed that we cautiously just had to resume life with the attitude of those who wish to participate will, and those who need to stay home should.

The Nassau County School Board worked diligently to come up with a back-to-school plan that included face

# Fish Talk

## Let's get our Sheepshead on!

The bite is heating up and you don't want to miss out! Great reports have come in from all over our region. For many, fishing season starts during Sheepshead season. With that said, from all of the great catches, it looks like it's going to be a banner year. These cold snaps will make it tough to get fiddlers so gather them up as soon as you can. Oysters, clams and fiddlers are by far the best baits so if you can't find one, the other will suffice.

There are some great fish being caught at the Nassau Sound Bridge. Most of the bigger sheepshead have been caught inshore in our local rivers and throughout the St. Johns. Our jetties are firing off as well so check the marine forecast and find the best days to suit you. As many of you know, our jetties can get nasty quick. Look for the entire top of the outgoing tide to be good. Focus on breaks in the current. Now you can find that in many different locations. Rock piles, trees and bridge pilings are excellent areas to begin.

Start off with a short leader, swivel, egg sinker and small bait hook. Keep a few larger weights like 1.5 to 2 oz. sinkers handy in case you need more lead to stay in the strike zone. Once you find the fish, be patient and cover the area well. Chum legally when you can because the outcome is usually much greater. On my fish finder rigs, I use a 2/0 triple barb VMC bait hook. Tip them with a live fiddler and slowly jig them over submerged structure. You can also use a sparky jig. They usually allow you to feel the fish immediately and many times that's the best scenario. The idea, in most cases, is to snag the fish before he steals your bait. Keep in mind, these fish will be leader shy in clean water and slower moving currents. Sometimes a smaller fluorocarbon leader will be key.

With the sheepshead you'll find puppy drum. So keep some fresh dead shrimp handy for the kids if they're aboard. Drum school and they may be keyed in on your bait scent. Drop back down quickly so you can take advantage of the chum slick you've created. That's said, hope you have much success. I look forward to see you all on the water, be safe!

In fact, Jesus Christ, in his humanity, faced worse temptation than we will ever face and he did not sin. It is very comforting for me to know that my God, Jesus, has walked in my shoes. I love that Jesus is not far off and distant, but close and personal.

2) God is faithful. Although the Father allowed Jesus to face the worse of it all, he does not do so to us. He only allows what He has enabled us to handle.

3) The way of escape: When temptation comes, we do not have to fail. God has already provided the way for us to make it through the other side of temptation. The way is trusting Him through all of it. And we can choose to do that or choose not to.

4) That you may be able to endure it: God does not tempt us. But, in this life, we will face temptation. God does not remove the temptation; we have to endure it. But, He walks through it with us and He provides the ability to stand strong in the face of temptation.

have joined us this season will enjoy it enough to return. I want you to know how thankful I am for the opportunity to demonstrate our desire to have a fun and competitive league for your children.



## Callahan Attorney Jeb Branham Appointed to Judge

The Callahan Town Council met Tuesday night for their first meeting of 2021. Town Attorney Jeb Branham announced to the council that he had been appointed by Governor Ron DeSantis to fill a judicial vacancy. DeSantis named Branham, of Jacksonville Beach, to serve as a circuit judge in the Fourth Judicial Circuit, which encompasses Duval, Clay and Nassau counties. area he uses with his workouts. I challenge other businesses and private donors to join in the cause to help make Ewing Park better."

Keith Wingate, President of the NE FL Fair Association, advised the council that the Fair Association would like to hook up to Callahan water and sewer. "We (the fair) are in dire need of Callahan water and sewer. During fair time, we are just holding our breath that the sewer system will hold up with all of the people we are serving," said Wingate. "We put in a new water system with an aerator that is working pretty good. We just need direction as to cost to hook in to the Callahan sewer line and water if possible or where we can go to find grants to help us fund our own?"

Town Manager Mike Williams advised Wingate that the town could possibly partner with them concerning hooking into the towns system. "You're looking at around \$100 a linear foot for the water line to be run one way. The sewer system would be easier as we could put a lift station out there at a cost of about \$50,000-\$75,000," said Williams. "Perhaps we could also find some partnerships with Florida Power & Light and/or Nassau County. We need to get together and see what options are available."

Randy Zakrzewski approached the podium to advise the council he would like to help make Ewing Park a safer and cleaner place for people to enjoy. "I just want to know how can we (as citizens) help? I know you are looking at a security system and it definitely needs more lighting," said Randy. "I know the ditches could be cleaned and maybe we can help with drainage issues. Just give me directions of how I can help!"

Next, David Pinkstaff, representing AA Bottled Gas, addressed the council. "I've been a Callahan resident for some time. I used to take my son to the park all the time. Recently, I have been doing the Boot Camp workouts at the park with Compound Fitness owner Eric Hernandez. While there I have thought of many ways we, as citizens and businesses, can help make this park better," said Pinkstaff. "I have a check from AA Bottled Gas for \$500 to donate for park improvements and also have a check from Compound Fitness for \$250.
