Saturday, October 2, the funeral service was held for Nassau County Sheriff's Office Deputy Joshua Moyers at Callahan First Baptist Church. A long procession of First Responders from all over the state followed the escorted hearse to Oakwood Cemetery in Hilliard for Deputy Moyers' final resting place. The streets were once again lined with residents paying their last respects to



the fallen deputy and his family.

Callahan Commerce Center Approved

The Callahan Town Council met Monday night for their first meeting of October. Councilwoman Janet Shaw filled in for Council President Ken Bass. Shaw asked everyone for a 'moment of silence' in remembrance of Deputy Josh Moyers.

The first order of business was the approval of Resolution 2021-R12 which concerned the town Christmas party. The council approved up to \$1,000 for the end of the year dinner that includes town personnel, officials, contractors and representatives. The town has set Friday, December 10 to have their celebration.

The next order of business was the first Public Hearing and reading of Ordinance 2021-004 which concerned the Voluntary Property Annexation. The property includes 1.76 acres with 4 parcels on Luther Street and 1 parcel on Martin Luther King Jr. Avenue. The



council approved the ordinance.

The next agenda item was a site plan review and approval of the Callahan Commerce Center. Engineer Matt Phillips advised the council that the 6,600 sf one-story structure would be located on SR 200. "The structure will be built directly in front of the retention pond on the property and will face Page

Street," said Phillips. "The first units on the site plan will be a dental office. The entire building will be built however the dental office is the only office filled thus far. There will be two more units available for rental." The new Commerce Center will be located on the property behind the future Zaxby's restaurant. The council approved the

site plan.

In closing comments, Mayor Matthew Davis asked the council to take a moment to reflect on the events that have occurred since the last meeting. "I'm just so proud of the way the Nassau County Sheriff's Office handled everything," said Davis. "It was a stressful time."

"We have lights and cameras at the park now and all are working," said Shaw. "Also, who took the trees down from the Fire Station?"

"We took the trees away because nobody would do any upkeep on the plants or weeds," said Town Manager Mike Williams. "We have the fountain in and we plan to put concrete in that area. If you want to put some plants in pots there, you can. But you have to maintain them."

The next regularly scheduled meeting of the council will be Monday, October 18 at 7 p.m.

As Monday rolled around, the manhunt continued. People received word that Deputy Joshua Moyers' body was to be escorted in a procession Monday evening through Callahan all the way to Fernandina Beach. Once again, people rose to the occasion. The streets were lined all down US 1 south and down SR 200 (A1A) as far as you could see. Again, word spread through Facebook and the crowds continued

all the way to the funeral home in Fernandina Beach. It was an emotional and respectful procession by all that watched. Tears filled the eyes everyone, young and old.

On Tuesday afternoon, cheers filled the air as the suspect was captured. It was a fearful, heart-wrenching week. My thoughts continue to Deputy Moyers' family, however the deputy that backed him up was heavy on my mind as well as the entire NCSO family. Then you have the Fire-Rescue personnel on scene that early morning. All of these departments are like family because they are together so much. Just continue to pray for each of them through these coming days.

Deputy Moyers' funeral service was held Saturday and once again, many stood on the side of the road to pay their respect. As things settle back to 'normal' many of these lives will never be the same again. Your continued prayers and support will still be welcomed.

As we all know, we live in a broken world with broken people. We had a real taste of that last week. We don't know the day or the hour that our time will be. Each and every day is a blessing and should be lived to the fullest. I have the comfort and peace to know that I will be spending eternity in Heaven with my Heavenly Father. Wouldn't you want to have comfort and peace? Ask Jesus to save you, He is the only way to Heaven.

Fear, Faith and First Responders

These last few weeks have been revealing about our community. Together we experienced the loss of Deputy Moyers. Our community's response flooded my Facebook news feed with the grief of this awful event. One response that really stuck with me was on the sign in front of First United Methodist in Callahan. They shared this verse: "Greater love has no one than this: to lay down one's life for one's friends." John 15:13. Following in Christ footsteps, this is what Joshua Moyers did for our community. He sacrificed his own safety for the safety of our community; just as Jesus sacrificed His life for our lives.

Quickly, our shock turned to anger and fear. However, from our first responders and the first responders in the communities that surround ours came resolve and determination. They would find the one responsible. Our community responded with support. Callahan First Baptist opened up all its resources to our first responders. Food and supplies poured in from all over our community. I remember at one point seeing a post about having all the food they needed.

After five days, there was a feeling of "are we really going to catch this guy?" But, the resolve of our first responders remained steadfast. And he came out in handcuffs. We had all been grieving, now our first responders could grieve. On Saturday, an American flag taller than a building could be seen hanging over US 301. Joshua's life was celebrated and his body laid to rest. Now grief continues and healing begins.

When events like these unfold, we can respond in fear or in faith. 1 John 4:18 says: "There is no fear in love. But perfect love drives out fear..." The comfort of knowing Jesus is not that everything will go perfectly, but that the true Perfect Love, Jesus Christ, walks alongside us through our most difficult times.

The old hymn captures this well: When peace like a river attendeth my way, When sorrows like sea billows roll, Whatever my lot, Thou hast taught me to say, It is well, it is well with my soul. No matter the circumstances, it is well with my soul because of Him who walks with me.

The last response I want to share with you is that the Churches of the Westside are hosting an event on Saturday and Sunday specifically for our First Responders. This event has been in the planning for several weeks, but seems even more fitting given recent events. The goal is to provide a place and a time where our Police and Firefighters can rest and play with their families. There will be bounce houses, slides, Red vs Blue softball game, food and more. Mind you, I should mention that this event is only for Police and Firefighters. If you would like to support this event, you can drop off gift cards at The Anchor Church. We will give them away to our first responders.



Nassau County Value Adjustment Board

John A. Crawford, Clerk to the VAB

The Value Adjustment Board (VAB) provides an independent forum for property owners to appeal their property value or denial of an exemption, classification, under certain circumstances regarding change of ownership or control, or a qualifying improvement has occurred, disabled first responder discount or tax deferral.

You may request a meeting with the Property Appraiser and/or file a petition with the VAB when there is a disagreement between the taxpayer and Property Appraiser concerning property exemptions, classifications, valuations, under certain circumstances regarding a change in ownership or control or a qualifying improvement; or the Tax Collector regarding a tax deferral, among others.

Further information and petition forms may be obtained at www.nassauclerk.com. Click on Clerk's Office, then click on Board of County Commissioners Services. Look for "VAB General Information and Important Notes."

For convenience of online filing

of value petitions, the VAB Clerk has implemented a software program which will be activated upon the Property Appraiser's mailing of the Truth in Millage (TRIM) notices to taxpayers, currently scheduled for August 19, 2021. Petitions related to valuation issues may be filed at any time during the taxable year on or before the 25th day following the mailing of the TRIM notice. Based on the TRIM notice mailing on August 19, 2021, the deadline to file a timely petition to the VAB is September 13, 2021 at 5:00 p.m. in the Clerk's office or midnight if filing online.

Did you know that in Florida, nearly 65 percent our state's forests are privately owned and are key to keeping forests as forest? Keeping our forests healthy and stocked with trees is especially important for the air we breathe. Forests remove or sequester carbon dioxide (CO2) from the atmosphere during the entire lifespan of the tree. Current growth of Florida's forests offsets almost 20 percent of the annual carbon dioxide emissions produced in the state. Additionally, they continue to store carbon well beyond the tree's lifetime as the trees are converted into wood products such as paper and lumber. Not only do forests store CO2, they also produce oxygen, clean water for drinking, provide homes for wildlife, opportunities for recreation and assist in addressing climate change.

However, regenerating or creating new forests can be a costly undertaking. Up-front costs such as site preparation and planting require extensive investments that are not realized for many years. To help landowners overcome the hurdle of establishment costs, the Florida Forest Service recently announced a new cost-share program known as the Sequestering Carbon and Protecting Florida Land Program. This program is designed to help increase

the acreage of healthy forests in Florida by helping Florida landowners make the long-term investment required to establish and/or maintain forests. The program offers landowners incentive payments for conducting certain approved forest management practices, such as site prep and planting slash, longleaf or loblolly pines to establish new forests.

Applicants are limited to non-industrial private landowners; a county or local government; and registered nonprofit organizations, who own a minimum of 20 acres. Applications will be accepted from September

3 - October 8, 2021. Interested

Triple Crown. It's big stuff!"


The track is the fastest half mile in the world. Horses are brought from all around the world. "The atmosphere is

NCSO Receives Bringing The Lost Home Project Bill Resources

The Nassau County Sheriff's Office (NCSO) has been named as one of five Florida Sheriff's Offices to receive missing person response training and resources through the highly successful Bringing The Lost Home Project legislative bill. The Bringing The Lost Home Project bill was sponsored by Florida House Representative, Scott Plakon and signed into law by Florida Governor, Ron DeSantis, in June 2021.



propensity to wander or elope with a rapid search response and recovery. The bill provides Scent Preservation Kits® or "Scent Kits" to families with loved ones living with Alzheimer's Disease or related dementia (ADRD), and autism.

The Alzheimer's Project will identify groups and areas in need of services and will help educate community residents about the Scent Kits and Missing Person Awareness for at-risk groups.

The bill also includes Missing Person Response Protocol and Scent Discriminate K-9 Training conducted by Scent Evidence K9 CEO, Paul Coley for the participating agencies. The training impacts law enforcement response capabilities by increasing search success and decreasing the time and resources needed to find missing persons.

The Bringing The Lost Home Pilot Project was introduced in Florida in 2019 and has been successfully implemented by 8 Florida Sheriff's Offices and Police Departments. (Bay, Sumter, St. Johns, Lee, Marion, Franklin, and Seminole Counties, and the Tallahassee Police Dept.) Nassau County Sheriff's Office participated in Scent Evidence K9 training sessions last year as part of its mutual assistance relationship with St. Johns County Sheriff's Office. A few days after the training, NCSO Deputy Beth Smith and her bloodhound K9 Rogue had their first missing person find when they located an endangered youth who had been missing for over 50 hours.

Scent Evidence K9 CEO, Paul Coley, and The Alzheimer's Project CEO, John Trombetta, partnered to introduce the bill to help law enforcement better serve their populations with Alzheimer's/Related Dementia and autism who are at high-risk of wandering and going missing. The Bringing The Lost Home Project enhances missing person response capabilities and recovery success by raising missing person awareness, mitigating risk, and improving search performance through the use of scent trailing recognition assessments, K-9 and Handler training, and scent collection technology.



In 2021, The Bringing The Lost Home Project will be implemented in Nassau, Escambia, Charlotte, Desoto, and Putnam Counties and will enable the Sheriff's Offices to introduce and maintain a proven and effective missing person's response and location program. Past participants have used the project resources to find 86 missing persons in Florida in the past 2 years and have protected thousands of people who are in high-risk wandering populations by distributing Scent Preservation Kits in their communities.

The project is focused on using recovering individuals who have a
