Officer Involved Shooting Tuesday

On Tuesday, October 6, 2020 around 1:30 p.m., the Nassau County Sheriff's Office received a call in reference to a female suspect who went into her exhusbands residence outside of Hilliard unauthorized and unannounced, where she had an injunction to stay away from. She got into an argument with another female that was there, over some domestic and custody issues she had with her ex-husband. Threats were made and the suspect left and traveled back to her father's house on Ruby Drive. The suspect lived behind this residence in a travel trailer.

NCSO initially received word that the suspect stuck a gun to her father's head in his house, but later said she stuck the gun in her mouth then left his house and went inside her trailer. Responding deputies tried to get her to come out without success. NCSO's Special Response Team (SRT) was called to take over negotiation attempts to get her to eventually come out.

While talking to the deputies on a cell phone the suspect repeatedly threatened to blow everyone away, kill law enforcement officers, as well as kill herself. Several times she came out onto

a screened porch and pointed an AR-15 rifle at the SRT vehicle where some deputies were stationed. She then made a statement that she was going to shoot a deputy that was in a wooded area. At approximately 5:30 p.m. she came out and raised her rifle toward the deputy and he shot one time striking her. She died at the scene. The suspect was a 48-year-old white female.

The shooting is being investigated by the Florida Department of Law Enforcement (FDLE).



Callahan Christmas Parade & Out with A Boom Fireworks Confirmed

The Callahan Town Council met Monday night for their first regular meeting of October. The first order of business was the appointment of a new Planning & Zoning Board member. Current member Ryan Haugh is moving out of Callahan and resigning his position. The council appointed Mr. Thomas Blue, III, to fill the vacant seat. Mr. Blue has been a Callahan resident for 25 years and lives on Dutton Way. Blue included in his letter of intent to serve, "...he will yield his time, skills and talents to assist in planning the future of our township."

The next item was a discussion of whether the council wishes to join the Chamber of Commerce again. Immediately, Councilman David Mellecker replied, "I say no. I don't know what they ever did for us."

"The mayor (who was absent) requested that we consider joining," said Town Clerk Stephanie Knagge. "Mayor Davis said we should consider joining as the current president is from the west side."

"I say no," said Councilwoman Shirley Graham. "I don't see any benefit to joining."

"The benefit is the chamber would be looking out to help the businesses," added Knagge. "We have to step up and do our part."

"I'll call over there and have the president come to our meeting," said Council President Ken Bass. "Then I'll ask him what are you going to do for us?"

The council agreed to table the discussion until the mayor is present.

The following agenda item concerned a change ordinance for the new cell tower. Back history on this issue: Shirer & Associates are currently contracting with T-Mobile concerning the cell tower on the top of the Callahan Water tower. Through some engineering surveys, it was decided that the tower can no longer stay on the tower due to structural issues with the water tower. Jay Shirer and his father Robert Shirer began working with Farm Bureau Insurance in Callahan since December 2019 concerning purchasing a parcel of property from them to place a new stand-alone tower for T-Mobile. At the time, the Callahan code allowed towers in the Highway Commercial zoning. The zoning has since been changed to Commercial which does not allow towers. Shirer was before the council again concerning whether they will change the ordinance or not. "The council has to decide whether you want to do nothing," said Town Attorney Jeb Branham. "Or if you choose to have me (attorney) draft an ordinance to allow this."

"I would prefer the tower look like a tree if possible," said Bass. "I think it would look better."

"Could you maybe make it look more like a palm tree?" said Councilwoman Bishop-Vargus.

"I certainly understand what you're saying. However, when you have a tower that is 160' high and you put branches on it...it will stand out," said Shirer. "The reason we have chosen this location is because this is where the signal is the best. If we move further out of town the signal is weak. Adding branches to the tower can also make it weak. This tower would make cell service so much better for residents and businesses. The bottom area would be completely enclosed by wood fencing and would be landscaped."

"I don't care what it looks like at the bottom," said Graham. "I care what it looks like in town. And you are taking money away from the town."

"All the cell towers are going to be removed due to the structural issues. I don't think we have any choice," said Mellecker. "I make a motion to have the attorney draw up an ordinance to allow the new tower."

The council agreed by a vote of 3-1 with Graham voting no (Councilwoman Shaw was absent).

The final item concerned whether or not to sign the contract for the Out with a Boom Fireworks display for this year. After much discussion, the council agreed to sign the contract with Fireworks by Santore at a cost of \$10,000. The council plans to have donations from local businesses to help pay at least half the cost and the town will pick up the remainder. Out with a Boom will be held Sunday, December 27 and the fireworks will be shot off from West Nassau High School.

The council also agreed to allow the Callahan Christmas Parade with the West Nassau Band Boosters handling the parade and entries. Town Clerk Stephanie Knagge will make contact with the school personnel that handled the vendors from last year and confirm that they will do it this year. The Christmas Parade is scheduled for Saturday, December 5 at 11 a.m.

The next regular meeting of the council will be Monday, October 19 at 7 p.m.

Amendment 4: Requires all proposed amendments or revisions to the state constitution to be approved by the voters in two elections. Excellent amendment, it allows for long term consideration as to whether or not the amendment is

truly an advantage for Florida. My vote is YES.

Amendment 5: Limitation on Homestead Property Tax Assessments: This gives home owners three years to utilize their Save-Our-Home benefits to be transferred from a prior homestead to a new homestead. I am for any benefit for tax paying homeowners. My vote is

Amendment 6: This gives Ad Valorem Tax Discount for Spouses of Certain Deceased Veterans Who Had Permanent, Combat-Related Disabilities. This grants the spouse the same benefits as when their spouse was living. It ends upon the spouse remarrying or selling the homestead. I support anything that benefits our wounded veterans and their spouses. My vote is YES.

Also on the 2020 ballot, is 1 State Supreme Justice; and 6 District Court of Appeals Judges. My choices are: Supreme Court Justice Carlos Muniz, appointed by Governor De Santis. My vote is YES. District Court of Appeals: Joseph Lewis, Jr., appointed by Governor Bush, my vote is YES; Scott Makar, appointed by Governor Scott and highly endorsed by Pam Bondi, my vote is YES; Rachel Nordby, appointed by Governor De Santis, my vote is YES; Tim Osterhaus, appointed by Governor Scott, my vote is YES; Clay Roberts, appointed by Governor Crist, my vote is NO; Adam S. Tanenbaum, appointed by Governor De Santis, my vote is YES.

Back on August 28, I tested positive for the Coronavirus. At first it started out as a low-grade fever and a little cough. By the third day it felt like the fever had broken and everything had passed. I knew I had to quarantine for ten days, so I started making a list of things that I would like to do around the house. But two days later the fever returned and I was starting to feel like I had flu-like symptoms. I had no energy, all I wanted to do was sleep and it was a chore just to move from the bed to the

recliner. On my last day of quarantine, I still had fever and just didn't feel good at all. That next morning, I was struggling to catch my breath even when I wasn't trying to walk around in the house. I just didn't feel right and I thought that this sickness should have been over by now. I told my wife that I felt like I needed to go to the ER and get checked out. She called 911 and Rescue came and checked me out. They determined that my blood oxygen level was low. Rescue did a great job getting me on some oxygen and then rushed me to the ER. Once at the ER they found out that the coronavirus had given me pneumonia and my kidneys were starting to fail. The doctors at the ER said it was good that I came in because I was in bad shape. They put me in the ICU on a high flow oxygen machine and started their treatment.


Not long after I was at the hospital, word got out that I was admitted to the ICU and needed prayer. I'm told that a prayer request was sent out on the church email prayer list and before long it was all over Facebook that I needed prayer. The hospital had me on antibiotics and the oxygen machine doing all that they could for me in the natural, but at the same time the Saints of God (the Christian Believers) were offering up prayers on my behalf. There were people all around the world, people that I don't even know that were praying for me. I'm so grateful for all the prayers that were offered up on my behalf. On the eighth day they began to wean me off that oxygen machine to see how I would respond. All the time people were still lifting me up in their prayers. Three times that day they turned the oxygen flow lower and lower. Later that afternoon the nurse said that she wanted to see how I would do without the help of the extra oxygen flow. I was doing so good that they decided to leave the extra oxygen off all night and see how I would do (that was the first night that I had any sound sleep). The next morning the doctor was amazed at how well I was doing (I believe it was because God was responding to all the prayers). Before the doctor left the room that morning he said, "If you can walk down the hallway and back that I'll send you home."

Praise God, the Lord gave me the strength to make that walk without any problems. That morning they had me discharged from the hospital before 11 a.m.

God is so good! He is a miracle working God. He still answers Prayer, and He is still in the Healing business. Because of all the prayers and the healing hand of God I am getting stronger every day. This past Sunday morning I was able to preach His word for the first time in over a month. It was like a "Fire shut up in my bones and I

As I close today let me share a couple verses of scripture that I have put my faith in especially during this time: Hebrews 13:8, "Jesus Christ is the same yesterday, today, and forever." James 5:15, "And the prayer of faith will save the sick, and the Lord will raise him up." Hilliard Selects Whittenburg as Parks & Recreation Director

The Hilliard Town Council met Monday night for their first meeting of October. This will be the only regular meeting during October, as the October 15 meeting will only be to take care of payables and will be done by conference

The first order of business was a presentation by Tim Norman, representing the engineering firm of Mittauer & Associates, Inc., concerning the engineering and design to place an overflow pipe on 4th Street and replacing old underground sewer pipes. "There have been some problems of water back-up near the Franklin minimall. We have videoed the pipes that are currently 8" pipes and need to be replaced with 12" pipes," said Norman. "With the large amounts of rain we have been having the pipes are unable to handle the water. Many of the pipes are 40-50 years old. The entire replacement job would be around \$663,000. Hopefully, we can secure some grants to help with the costs. Placing an overflow pipe will help tremendously until we can do the entire job. The cost of the overflow would be \$8,600."

The council approved recommendation for the overflow valve.

The next item concerned appointing the new Parks & Recreation Director. There were six applications received and 3 made it to the final cut. The council had a workshop Monday to discuss the applicants. Thursday, prior to the meeting, the council interviewed the 3 candidates. During the meeting, the council chose Gabe Whittenburg as the new Director. Whittenburg is a lifelong resident of Hilliard and a 1995 graduate of Hilliard Middle-Senior High School. Whittenburg will begin the position October 19, 2020.

The gymnastics program was the next item discussed. Jenni Bradley, gymnastics instructor, for the Parks & Recreation Department, advised the council that she and the girls in the class, along with their parents, would like to have a drive-thru Halloween event. "During the event, girls would be given an information paper about the gymnastics class that will have a coupon to invite them to come and enjoy two free nights of the class to see if they like it," said Bradley. "We currently have 16 girls in the class and they are good. These girls are so talented. We hold our classes in the gym and it is

miserably hot. We have been trying to do fundraisers to try to get some fans to cool us off. Can we continue with our fundraisers?"

"The reason it is so hot in the gym is because the big exhaust fans at the ends of the building are not working," said Councilman Lee Pickett. "It would feel much better if that problem is fixed."

Bradley was given approval to continue her programs as she has been, however after October 19, she will be directing questions through the new director Gabe Whittenburg.

The council approved the request by the Historical Recovery Association of NE Florida to use metal detectors first in the field beside the recreation department.

The council approved Resolution

2020-13, which concerned allowing FDOT to upgrade the school signals near Hilliard Elementary School.

After some discussion about asphalt & concrete repair on Georgia Street, Assistant Public Works Director Greg Grooms advised the council that their (public works) department could handle the asphalt repair. "We have the new dump truck and we can go get hot asphalt and repair it ourselves," said Grooms. "We can't do the concrete work though." The council approved the department to do the asphalt repair.

Grooms also advised the council that the department needed another load of culverts (bulk) at a cost of \$12,805.24. The council approved the request.

The next regular council meeting will be November 5, 2020.

In 2017, the program hosted their first home game on the newly revamped





Dangerous Lem Turner Rd.

Dear Editor,

Since I sent this letter in 2015 (Date: May 18, 2015; To: Florida Department of Transportation; From: Steven Nickell; Subject: 18 Wheelers on Lem Turner Road) all the information has increased significantly.

My name is Steven Nickell, I live at 54426 Lisa Drive, Callahan. In the past six months, I have witnessed several problems resulting from tractor trailers moving north and south on Lem Turner Road. The stretch of Lem Turner Road is between I-295 north to US 1 approximately 8 miles of 2 lane road with very little shoulders and heavily covered with trees in sections. Along with the aforementioned issues, there are a growing number of semi-trucks using part of Lem Turner Road. Let me first say that the only business that may require semi service is Nutri-Turf.

The only reason I am mentioning this is because all the other semi-trucks on Lem Turner are using it strictly to avoid having to go to US 1 north at I 295. This road is used primarily for residential traffic other than the trucks which mixes with commercial traffic, this poses huge issues. Lem Turner Road is 2 lanes now with 80,000 lb. trucks along with an aging community of drivers now having trucks stopped in the road waiting for people to turn into their driveways. So I think everyone knows that it is not an issue whatsoever on US 1 which is four lanes (2 each way).

Lem Turner Road also has several blind curves. It is just a matter of time before someone is going to be in a disabled vehicle and these trucks moving 60 mph are not going to be able to stop. We have mail delivery and garbage pickup (curbside) which poses all kinds of other issues.

Lem Turner Road as a whole has very little to offer as a main thoroughfare for commercial traffic when I don't know to be the fact but seems to be used more frequently by semi-trucks than US 1 at least between I 295 and Callahan. I believe that these trucks going down 2 more exits to be on a four lane road with no obstructions at all, versus potential stop and go which we all know causes accidents is a small price to pay.

I have personally seen way too many accidents and potential situations that have persuaded me to write this. My hope is for someone to at least look into this situation. Just remember every time a resident has to turn into their driveway and a semi-truck is behind them. They have to come to a complete stop if there is oncoming traffic. They also have to go through the gear changes to get back to speed.

Also, all residents and anyone who travels Lem Turner Road should call FDOT about the trees falling on the actual roadway. The phone







129 yards of total offense and 87 yards on the ground. Lee led the charge




