



## Justice for Joleen: Kessler GUILTY

The nightmare began in May 2018, one that no family deserves. The family of Joleen Cummings realized something was not right when Joleen failed to pick-up her children from her ex-husband on Mother's Day and also her 34th birthday. The next day, Cummings' mother, Ann Johnson, reported her missing to the Nassau County Sheriff's Department.

Through meticulous investigating, the Nassau County Sheriff's Department quickly began finding evidence concerning Joleen's disappearance. On May 15th, deputies found her vehicle parked near the Yulee Home Depot near where Joleen was last seen at Tangles Hair Salon, where she worked as a hair stylist. Through video footage from a nearby business, Kimberly Kessler, also an employee at Tangles Hair Salon was seen driving Joleen's vehicle and parking it. Joleen was not with her. Other leads and evidence pointed to Kessler so the search for Kessler began.

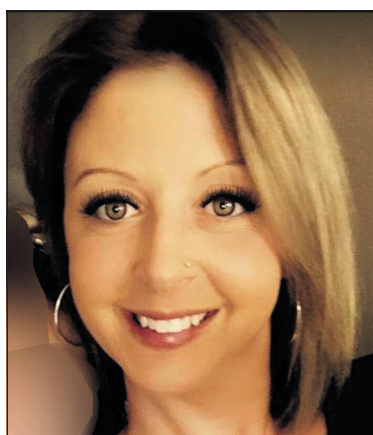
The very next day, investigators found Kessler at an I-95 rest area in St. Johns County. Kessler was arrested on charges of vehicle theft.



Just six days later, Sheriff Leeper announced, "Investigators have reason to believe that Joleen is not alive." The investigation turned to a Georgia landfill, her body was not found but

Leeper states they found several items of interest. On September 7, 2018 Kessler was indicted for first-degree murder.

In July of 2019, Kessler was ruled "not competent" for prosecution even though she was competent enough to have multiple aliases throughout many years and was working as a hair stylist under a fictitious name. She was sent to a Florida State Hospital to restore competency and be reevaluated in six months. Upon return to Nassau County Jail, Kessler went on



a hunger strike which reduced her weight from 200 pounds down to 90 pounds. Two more times the defense requested her competence be re-evaluated. Both times Kessler was found to be competent for trial.

Finally on November 29, 2021, jury selection began for the trial. The trial began on December 6 with lots of evidence and witnesses. Closing arguments from both the prosecution and defense began on Thursday, December 9. The jury deliberated a little over an hour before

making a decision. On December 9, Kimberly Kessler, aka Jennifer Siebert, was convicted of First Degree Murder and Grand Theft Auto. She is facing mandatory Life in Prison. Sentencing is set for 1:30 p.m. January 27, 2022.

"She (Kimberly Kessler) is evil. She is evil in the flesh. And as soon as she is sentenced, I want her behind out of our jail," said Nassau County Sheriff Bill Leeper. "It's the state's problem from now on."

Joleen's body has yet to be found. The family is praying Kessler will see fit to give them a location of her body so Joleen can be laid to a proper rest and give the family the peace of doing so.

## K9s United Hosts K9 Benefit

K9s United recently hosted its inaugural "A Very Merry K9 Christmas" holiday party to benefit the local nonprofit's efforts to ensure K9 units across the country have the highest levels of customized training and animal care needed to protect and serve their communities. The holiday celebration was held Sunday, December 12 at The Barn at Cottonwood Ranch, in Callahan.

At the event, a special presentation was made to the Moyers family. Earlier this year in September, Nassau County Deputy Joshua Moyers was fatally shot during a traffic stop. The community mourned his passing but also rallied around all the departments

who searched during the manhunt for the shooter. Four days later, with the help of K9s, the shooter was found and arrested.

K9s United presented Joshua's parents, Tim and Brenda Moyers, of Hilliard and his fiancé Ivy Carter with a beautiful portrait. Nassau County Sheriff Bill Leeper along with several NCSO deputies attended the special event.

# NASSAU COUNTY IS ACCEPTING NOMINATIONS OF PROPERTIES FOR POTENTIAL ACQUISITION THROUGH THE CONSERVATION LAND ACQUISITION MANAGEMENT PROGRAM (CLAM)

NOMINATION DEADLINE APPROACHING  
Nomination Period Extended to January 31, 2022

The Nassau County Conservation Land Acquisition and Management (CLAM) program was created to preserve and conserve the county's natural, historic, and working lands resources by identifying, ranking, and assessing conservation lands for acquisition and management.

The County is accepting nominations of properties for potential acquisition by the County through the CLAM Program from any person or organization, including the County, nonprofit organizations, and local, regional, state, or federal governmental entities. To nominate a property for potential acquisition, the nominator shall submit an application to the Nassau County Planning Department. Nominators may nominate an entire parcel for acquisition in fee simple or only a specific portion thereof or interest therein. In nominating properties, nominators should consider, at a minimum, the information contained in the Conservation Plan, the CLAM Resource Rankings Map, and the CLAM Manual.

Nominations must be received by the Nassau County Planning Department no later than 5:00 p.m. on Friday, January 31, 2022. Nominations received after the nomination period will not be considered. CLAM documents and nomination forms can be found at the following website or can be picked up and dropped off in person at the address listed below:

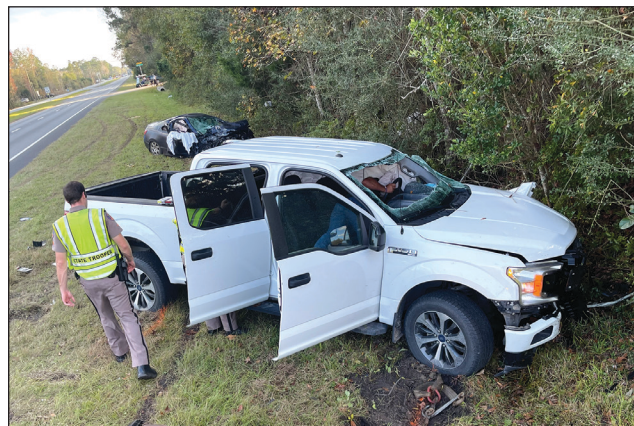

## Fatal Crash Friday Near Callahan

Last Friday afternoon around 1:40 p.m., a fatal car accident occurred on U.S. Highway 1 at Charwood Drive south of Callahan. According to the Florida Highway Patrol report, three vehicles collided leaving a 76-year-old man from Jacksonville deceased.

The FHP report states that the 76-year-old man was driving north on U.S. 1 in the outside travel lane. The second vehicle involved was also traveling north and was ahead of the first vehicle. The third vehicle involved was traveling southbound on U.S. 1 in the outside lane and was driven by Gary Howard of Hilliard. The first car that was heading north slowed to make a right hand turn



off U.S.1. The second car failed to slow and attempted to swerve to the left to avoid striking the car turning right.

The front of the second car collided with the left rear of the car making the right hand turn. This caused the second car to careen forward through the median and travel north in the southbound lanes. The car struck the southbound pickup truck head on. The driver of the second car was announced deceased at the scene. The drivers of the first car and the pick-up truck had minor injuries according to the report. All traffic lanes were blocked for several hours and traffic was rerouted around the accident.

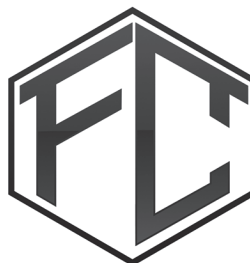

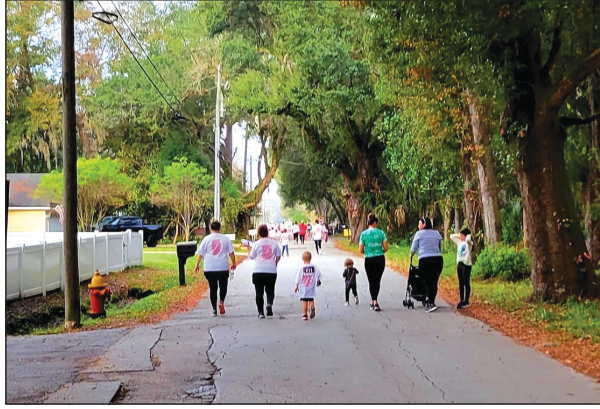
