# West Nassau Cheerleaders Bring Home a World Title and National Championship!





### Fatal Accident Tuesday

According to Florida Highway Patrol reports, a fatal accident occurred Tuesday around 2:27 p.m. near the intersection of Lem Turner Road and Terrell Road in Jacksonville. A 2010 Hyundai Genesis, driven by Richard Thornton, 44, of Callahan, with a passenger Jessica Holland-McDonald, also of Callahan, was traveling southbound on Lem Turner Road just south of Terrell Road approaching a 2016 Harley-Davidson motorcycle, driven by Stewart Lee Bowles, 58, of Jacksonville, traveling northbound. The Hyundai veered from its lane entering the lane of the motorcycle. As a result, the vehicles collided head-on. The vehicles came to rest on the southbound right shoulder of the roadway, south of the collision area. Bowles was pronounced deceased on scene by the responding rescue personnel.



# Sowing and Reaping

Pastor Arlie Johns, Hilliard First Assembly of God



When we think of the law of sowing and reaping, we are reminded of what is known as the law of the harvest. Galatians 6:7, "Do not be deceived, God is not mocked; for whatever a man sows, that he will also reap." (NKJV)

First, this passage refers to the type of seed that we plant. If we want to produce a crop of corn, then we better make sure that when we plant the seeds that they are corn seeds. Or if we want a crop of turnip greens then we better make sure that we plant turnip seeds. We can't plant orange seeds

and expect to have a harvest of apples. According to the scripture above whatever a man sows that's what he will reap.

Secondly, I know that many use this passage for encouraging believers within the church to give more liberally in the offerings, but it applies to every area of our lives. I'd like for you to focus for a moment with me on how we treat others around us. Matthew 7:12 says, "Therefore, whatever you want men to do to you, do also to them, for this is the Law and the Prophets." (NKJV) Take a few minutes and evaluate how you have been treating those around you, your spouse, your children, your friends and even those in your church. When we treat those around us with love and respect, we should expect to be treated the same.

When it comes to the believers in the Church, it's our job to build each other up. One of the best ways to encourage other believers in the body of Christ is to speak words of life and encouragement to them. We should also be sure to thank them for their part in what they do within the body of Christ, whether they serve as an usher, greeter, or nursery worker their part in the Church is important. We should be cautious that we don't criticize each other with negative words because those are words that defeat and discourage.

Galatians 6:7-10, "Do not be deceived: God cannot be mocked. A man reaps what he sows... Therefore, as we have opportunity, let us do good to all people, especially to those who belong to the family of believers." (NIV84)

2 Corinthians 9:6, "Remember this: Whoever sows sparingly will also reap sparingly, and whoever sows generously will also reap generously." (NIV84)

My prayer is that you will do your part in helping to build up the body of Christ (the Church) with words and expressions of kindness. May God richly bless you as you faithfully serve Him.








### Hilliard Town News

The Hilliard Town Council met Thursday night for their first regular meeting of February. The first order of business was an agenda item request by Jeremy Neidhart. Neidhart was requesting permission to use the fields at the Hilliard Parks & Recreation Department for a new soccer club he is forming. The council recently held a workshop concerning the issue. "I am requesting to use the soccer fields. The goal of the club is to improve the character of the athletes and to promote good grades before playing," said Neidhart. "The dates we will be using the field will be March 9 – May 11."

"I thought we (council) were going to receive a contract for Mr. Neidhart to sign," said Councilwoman Callie Kay Bishop.

"We will issue him (Neidhart) a conditional agreement, until we make sure this all goes through," said Councilman Jared Wollitz. "I propose we place a term limit on the contract for 1 year and see how it goes." The council approved the request.

Town Clerk Lisa Purvis advised the council that the Nassau County School Board requested a workshop with the council. They have set a date of Monday, February 25 at 6 p.m. here at Town Hall. "Is this date okay for everyone?" The council approved the workshop date.

The next agenda item was a water connection exception for Michael Shawn

McClinton by Mr. Bobby Franklin. "I am requesting a water connection exception for the old building on US 1. Mr. McClinton wants to have a small office there," said Franklin. "There is a well on the property and there is not city water available at this time. There is sewer but not water. Mr. McClinton has said he would hook into the city water when it is available."

"I would like to table this request until we (town) can see what the cost would be for the town to make the water available," said Councilman Kenny Sims.

The item was tabled until the next regular meeting.

Ordinance 2019-01 was approved on first reading which concerned changing the future land use classification of that certain property consisting of 4.08 acres located on the east side of US Highway 1 between CR 108 and Eastwood Road, Hilliard. The classification is currently Agricultural changing to Industrial Mechanical.

Ordinance 2019-02 was also approved on first reading. The ordinance concerns changing the zoning designation from town zoning R-1, single family residential district; to town zoning C-1, General Commercial District; for the 4.08 acres located on the east side of US Highway 1 between CR 108 and Eastwood Road, Hilliard.

The next agenda item request was from Mr. Lin Loyd. "I already have a septic tank exception for this property however I

haven't had an opportunity to get to it," said Mr. Loyd. "The exception is fixing to expire so I'm asking to extend it, please."

The council extended the request for 1 year

"We have some equipment at the recreation department that we need to maybe have an auction to get rid of it," said Council President John Beasley. "We need to make a list of what we have to see the best way to handle it."

"The fire department also has some

items they are getting rid of," said Town Clerk Lisa Purvis. "They (fire department) are using a .gov site to place their items for sale. Maybe we could do that."

"I'm familiar with the .gov site for surplus items. It's a great way to surplus items," said Councilman Wollitz. Beasley will compile a list along with the fire department items and look into placing them on the site.

The next meeting of the council will be Thursday, February 21 at 7 p.m.
