

### In the Kitchen... **Buffalo Chicken Sliders**

1 (12 oz.) package Hawaiian sweet dinner rolls (such as King's Hawaiian<sup>®</sup>) 6 oz. Monterey Jack cheese, shredded (about 1 1/2 cups), divided 3 cups finely shredded cooked chicken breast, warmed

1/4 cup cayenne pepper hot sauce (such as Frank's RedHot<sup>®</sup>) 1/4 cup ranch dressing 1 (1 oz.) envelope ranch dressing mix, divided 2 tablespoons unsalted butter, melted

Preheat oven to 350°. Line a large-rimmed baking sheet with aluminum foil; lightly coat with cooking spray. Using a serrated bread knife, cut rolls in half horizontally, keeping top halves and bottom halves intact; place bottom half of rolls, cut-side up, on prepared baking sheet. Sprinkle 3/4 cup of the cheese evenly over bottom half of rolls. Stir together warmed chicken, hot sauce, ranch dressing, and 3 tablespoons of the ranch dressing mix in a large bowl until evenly coated. Top bottom half of rolls evenly with chicken mixture; sprinkle with remaining 3/4 cup cheese. Place top half of rolls over cheese. Brush tops and sides of rolls with melted butter. Sprinkle tops of rolls evenly with remaining 1/2 tablespoon ranch dressing mix. Bake about 10 minutes. Remove from oven, cut into 12 sliders and serve immediately.



also have six grandchildren Drew, Tori, Brayden, Zach, Bailey and Carson; and two great-grandchildren Bjorn and Aella.




