

What's New with West Nassau AFJROTC?

The Cadets of West Nassau's Air Force JROTC unit have had a busy couple of weeks. Saturday, April 2, the unit hosted another "Warrior Challenge" in which eight (8) other High Schools competed. The Warrior Challenge is comprised of a physical fitness competition followed by an obstacle course competition. The event has grown from 3 schools to 9 JROTC programs coming from as far away as Ocala in just two years. Over 150 cadets competed during the day. "The word is



getting out about how great this event is and highlights the volunteers from the Hilliard American Legion, local military recruiters and cadet parents as the reason for its success," said Col. Gregg Kline, West Nassau advisor.

This past Saturday, April 9, the cadets were involved in three events. Twenty-three cadets traveled to Orlando to compete in a statewide Orienteering meet and won 2 Team trophies and several individual trophies. About 20 cadets attended the Hilliard Town Clean Up; while another nine supported the Hilliard VFW during their Easter event and fundraiser.

This Friday, April 15, the cadets will walk 14 miles on the Jacksonville/Baldwin trail in memory of the Bataan Death March during WWII. The cadets have selected

to use this event as a fundraiser for "Relay for Life" and will make a donation with what they raise at the Relay for Life event on May 7.

We would also like to recognize Cadet Alexandria Decker for being selected by the National Flight Academy to attend

Wesleyan University in Indiana during her summer break and earn her Private Pilot's license courtesy of the US Air Force. When she returns, the Air Force will continue to fund her to fly once a month during her senior year to keep her currency. Cadet Decker is part of a new program being offered as part of West Nassau's AFJROTC program. Col. Kline is teaching qualified Juniors "Ground School" which is required for a Private Pilots license. At the completion

of the year, the cadets are qualified to take the FAA Ground School exam. During the year, the cadets also get actual flight instruction from a Certified Flight Instructor and earn hours toward the Pilots License. In addition to passing the FAA ground school test, student pilots usually need

to obtain about 50-60 hours of flight instruction before being ready for their FAA flight evaluation. Unfortunately, the West Nassau flight instructor recently left to fly for the airlines. If you are a Certified Flight Instructor (CFI) and are interested in working with the West Nassau AFJROTC cadets, please reach out to Col. Kline at West Nassau High School, 879-3461.

As you can see, even though the end of the school year is fast approaching, the AFJROTC cadets are still in full swing!



Hilliard Carjacking Suspect Arrested

Saturday morning around 5:50 a.m. the Nassau County Sheriff's Office was dispatched to the Marathon gas station, 551758 US Highway 1 in Hilliard in reference to a carjacking that just occurred. The victim stated a black male, later identified as Ivan Fox, entered his running 2013 Dodge Ram pickup that was occupied by two small juveniles. The suspect drove approximately 150 feet and removed the two juveniles from the rear of the vehicle, subsequently dropping them off in front of Hilliard Pharmacy.




bitten by a Jacksonville Sheriff's Office K9. The suspect then surrendered and was placed into custody. Lt. Arline was able to get a positive ID on the suspect via RAPID ID. Records revealed the suspect to have three previous DWLSR and his current license to be invalid.

The suspect fled with the vehicle northbound into Georgia, where he was intercepted by the Charlton County Sheriff's Office (CCSO). A pursuit ensued back into Florida where NCSO joined with CCSO with lights and sirens. NCSO Deputies later deployed and made contact with stop sticks on the vehicle. The suspect continued fleeing south on US 1, approximately 2 miles, when the vehicle wrecked into a ditch near US Highway 1 and Testone Lane in Hilliard.

The suspect fled the vehicle on foot into a nearby wood line. The NCSO dispatched K9 Deputy/Handler Beth Smith and her K9 Rogue to the scene. The suspect (Fox) was later apprehended. The suspect refused to comply with verbal commands and was

Post being read his Miranda rights, the suspect refused to speak or give any information in regards to this incident. The suspect was transported to Baptist Nassau for injuries he received and later



transported to the NCSO Detention Facility, where he was booked. Ivan Leslie Fox, 45, of Rockledge, Florida was charged with Carjacking; Felony Flee/Elude with Lights and Sirens; Resist without Violence Simple Assault; Driving While License Suspended/Revoked (no prior forcible felony).



Bondage or Freedom

Medication Take Back Day: Why is it Important?

Prescription medications, especially opioid and stimulant medications, are among the highest misused and abused drugs in the nation today. Over 70% of all prescription pain medication abuse starts by access to a family member or friend's medications. Access to these medications has led to a tragic increase in addiction, prescription drug related overdoses and overdose related fatalities



in our Nassau County communities, including our youth. Recent data shows that in Nassau County, opioid related overdoses have increased by 139%, when comparing Emergency Department data from 2019 to 2021. Data comparisons from 2019 to 2021 also show stimulant overdoses have more than doubled, equating to a 152% increase and Benzodiazepine related overdoses have increased by 87%. Examples of commonly used opioids are oxycodone and fentanyl, common stimulants are ADHD medications, such as Adderall, and benzodiazepines are sedatives, like Xanax and Valium.

One way we can help overcome this and keep our community healthy, is by keeping cabinets clean of unneeded and old medications. This helps to prevent medication misuse and opioid addiction from ever starting. Since most prescription medication misuse and opioid addictions start by accessing the drugs from a friend or family member, we can work as a community to keep

our medication cabinets cleaned out and reduce the possibility of access these medications. This limits the ability for unintended use of these medications, and we can do our part to help keep Nassau County safer and healthier.

National DEA Prescription Drug Take Back Day offers a safe, convenient way to clean your cabinets of any old or unused medications and turn them in for safe disposal. This event will take place in Nassau County on Saturday, April

30 from 10 a.m. – 2 p.m. Medication drop-offs will be available at Hilliard Pharmacy, Winn Dixie in Callahan and the Yulee Community Center. This event is coordinated by the Community Coalition Alliance, in partnership with the Nassau County Sheriff's Office, National Guard, and Starting Point Behavioral Health. We will be giving out Deterra Medication Disposal Bags, for safe medication disposal at home, resource information and providing Narcan education and distribution. Narcan is a lifesaving tool, that should be a part of all first aid kits at home, especially for anyone who is prescribed opioids, or has a loved one who is prescribed opioids.

Hilliard Town News

The Hilliard Town Council met Thursday night for their first meeting of April. The first order of business was a proclamation concerning Water Conservation Month. The proclamation is prepared every year for the St. Johns River Water Management District (SJRWMD). The proclamation included, water is a basic essential need for everyone; April is one of the driest months in Florida as to why the proclamation is done now; the Town of Hilliard joins with SJRWMD to educate citizens on the importance of water conservation. The proclamation was read and presented by Council President John Beasley.

Dave Conkey, representing SJRWMD added, "This is the 24th Anniversary of proclamations and we appreciate the Town of Hilliard's support. Recently, SJRWMD have been locating abandoned artesian wells and plugging them. As to date, 62 wells have been plugged, which have saved 10.4 million gallons of water a day."

In other business, the council approved the contract renewal between the Town of Hilliard and Mr. Bryan Higginbotham, for Building Official services, with a 3% pay increase for a total annual contract amount of \$33,990.

The next three items were approved by the council: the Building Official/Inspectors; the Code Enforcement Officers; and the Land Use Administrators quarterly report. Each of the reports can be found on the town's website at: www.townofhilliard.com.

The council also approved the Gravity Sewer Overflow Pipe Project change order at a cost of \$4,520.

Resolution 2022-03 concerns an FDOT Public Transportation Grant Agreement offer for Land Acquisition. The resolution agreement allows the

FDOT to acquire land on the north side of the Hilliard Airpark. The council approved the resolution.

Resolution 2022-05 was also approved that concerns amending Zoning and Land Use Application Fees to add a deposit to applications that require a consultant review.

Resolution 2022-06 was also approved which concerned amending Resolution 2021-23 Water and Sewer Usage Rates & Fees; Water and Sewer Tap-in Fees, adding a Septic Tank Application Permit Fee and adding a Right-of-Way Application Permit Fee.

Parks & Recreation Director Gabe Whittenburg advised the council that he was contacted by Jen Hart of First Baptist Church Hilliard. "The church would like to use Oxford Park on Saturday, April 16 from 4-6 p.m. for a Community Easter Egg Hunt," said Whittenburg. "They have already turned in their forms. I am recommending we waive the fees and allow this event."

The council approved the recommendation.

The council approved two septic tank exceptions: one for David W. and Callie K. Bishop, property located off Twelfth Avenue; the second for Michael Franklin, property located off Twelfth Avenue.

The council approved the resignation of Jack Burnette, grounds/facilities maintenance. This will leave a vacant position in the Parks & Recreation Department.

The council approved the Bulk Culvert purchase of \$20,664.12.

The council approved payment to Dixon Tree and Lawn Service for the first payment of \$8,750, for mowing the town right-of-ways.

The next meeting of the council will be Thursday, April 21 at 7 p.m. at Town Hall, 15859 West County Road 108.

Drug Arrests Made

On Friday, April 8, Sheriff Bill Leeper announced that the Nassau County Narcotics Drug Task Force raided two drug houses: one in Fernandina Beach; and one in Jacksonville. Three individuals were arrested with drugs and weapons seized during the raids.

On Wednesday, April 6, Nassau County Sheriff's Office Special Response Team members with the assistance from the Fernandina Beach Police Department served a search warrant at 619 South 10th Street Fernandina Beach. Nassau County Narcotics Drug Task Force Detectives searched the residence and found illegal drugs inside consisting of marijuana, cocaine and MDMA (Ecstasy/Molly), as well as drug paraphernalia and digital scales. Two people were arrested in the raid: Gus Antonio Holcey, 41, from Fernandina Beach was charged with (3) Counts of Drug Possession, (1) Count of Possession of Drug Paraphernalia, and Keeping a Place where Drugs are Sold/Kept and Declared a Public Nuisance. Darien Jovon Owens, 25, from Fernandina Beach was charged with (2) Counts of Drug Possession and (1) Count of Possession of Marijuana with Intent to Sell within 1,000 feet of a School or Public Park.

Seized from the house were 42.6 grams of Marijuana, individually weighed out and packaged ready to be sold; 0.3 grams of Powder Cocaine, and 3.4 grams of MDMA (Ecstasy/Molly). In the residence, detectives located numerous Drug Paraphernalia items such as cigars, a glass pipe and digital scales with residue. A total of \$1,090 was located and seized from the property.

of a joint investigation that originated in Nassau County. During the operation, the suspect Jadarien Turner, 26, from Jacksonville, was arrested from inside the residence and charged with the following: (1) Count of Armed Possession of Illegal Drugs, (1) Count of Possession of Marijuana with Intent to Sell and (1) Count of Use of a Firearm During the Commission of a Felony. There were two small children (1 month and 3-year-old) inside the residence at the time of the search and DCF was contacted to conduct an investigation.



Detectives seized the following from the residence; 3 pounds of Marijuana, 3.8 grams of Cocaine, 4.1 grams of Oxycodone 10 mg pills, approximately 4 grams of suspected Heroin, 5 THC cartridges, 2 Firearms with Ammunition, 4 additional magazines (2 of them extended). Also in the residence, detectives located numerous Drug Paraphernalia items such as: multiple large vacuum seal bags with marijuana residue and several other suspected narcotic contraband. A total of \$8,019 in US currency was seized from the property.

"These drug dealers prey on and make money off others who are addicted to drugs," said Sheriff Leeper. "You'd think with all of the 'Help Wanted' signs all around and businesses looking for people to work they'd go get a real job to make money legally and stay out of jail."



On Thursday, April 7, members of the NCSO Narcotics Drug Task Force assisted the US Bureau of Alcohol, Tobacco and Firearms (ATF) with a search warrant located at 1829 Biscayne Circle, Jacksonville. The search warrant was part

Marijuana Bust in Fernandina

According to Nassau County Sheriff's reports, April 4, 2022, 106 pounds of marijuana was recovered from a storage shed in Fernandina. Several different departments were used NCSO Narcotic Detectives; Drug Enforcement Administration



Special Agent; Task Force Officer and Florida Highway Patrol State Troopers conducted a surveillance of a delivery of Marijuana, which resulted in the arrest of Johnathan Lee Balyeat of Jacksonville.

Officers, Special agents and Detectives observed Balyeat meet with another subject near the Flash Foods gas station at 5518 South Fletcher Avenue, Fernandina. When the meeting was completed, Balyeat was followed by officers to a home on Forrest Drive in Fernandina. Balyeat was driving a black GMC Sierra pickup truck. Once Balyeat arrived, officers observed him carrying black duffle bags to a small detached storage shed in the rear of the property.

Officers arrived at the residence and made contact with Balyeat while he was standing outside of the shed. Officers then made contact with the homeowner who advised she did not know Balyeat and did not give permission to store any property inside the shed. She also gave NCSO a signed consent to search the shed. A detective then talked with the other homeowner who stated he had given him permission to store personal belongings in the shed but nothing illegal.

During the search of the storage shed, officers located five black Addias brand duffle bags and one cardboard box containing approximately one pound of marijuana packaged inside vacuum sealed plastic bags; Two 5-gallon buckets containing opened vacuumed plastic bags of marijuana; a box of small sandwich bags; a digital scale and several sandwich bags which were pre-packaged and readily available for sale. A total of approximately 106 pounds of

marijuana was recovered from inside the shed.

Balyeat was read his Miranda Rights via card, which he stated he understood. Balyeat was arrested and charged with 1 count of Trafficking Marijuana; 1 count of Possession of Drug Paraphernalia; and 1 count of Possession with Intent to Sell.



SILLY RABBIT EASTER IS FOR Jesus



The Last Supper

Before the Passover celebration, Jesus knew that His hour had come to leave this world and return to his Father. He now showed the disciples the full extent of his love. It was time for supper, and the Devil had already enticed Judas to betray Jesus. Jesus knew that the Father had given him authority over everything and that he had come from God and would return to God. So He got up from the table, took off his robe, wrapped a towel around his waist, and poured water into a basin. Then He began to wash the disciples' feet and to wipe them with the towel he had around Him. (John 13:1-5 Summarized)

Jesus is Tried and Beaten

Following Jesus' arrest in the Garden of Gethsemane for claiming to be a king, Pilate had Jesus flogged with a lead-tipped whip. The soldiers made a crown of long, sharp thorns and put it on his head, and they put a royal purple robe on him. "Hail! King of the Jews!" they mocked, and they hit him with their fists. When the crowds saw him, the leading priests and Temple guards began shouting, "Crucify! Crucify!" (John 19:1-6a Summarized)

His Crucifixion

Carrying the cross by himself, Jesus went to the place called Skull Hill. There they crucified him. There were two others crucified with him, one on either side, with Jesus between them. And Pilate posted a sign over him that read, "Jesus of Nazareth, the King of the Jews." When the soldiers had crucified Jesus, they divided his clothes among the four of them. (John 19:17-24 Summarized)

Jesus' Death

Jesus knew that everything was now finished, and to fulfill the Scriptures he said, "I am thirsty." A jar of sour wine was sitting there, so they soaked a sponge in it, put it on a hyssop branch, and held it up to his lips. When Jesus had tasted it, he said, "It is finished!" Then he bowed his head and gave up his spirit. (John 19:28-30 Summarized)

His Burial

Afterward Joseph of Arimathea and Nicodemus wrapped Jesus' body in a long linen cloth with the spices, as is the Jewish custom of burial. The place of crucifixion was near a garden, where there was a new tomb, never used before. And so, because it was the day of preparation before the Passover and since the tomb was close at hand, they laid Jesus there. (John 19:38-42 Summarized)

The Resurrection of Jesus Christ

Early Sunday morning, while it was still dark, Mary Magdalene came to the tomb and found that the stone had been rolled away from the entrance. An angel was there on the stone and said to the women, "Do not be afraid, for I know that you are looking for Jesus, who was crucified. He is not here; he has risen, just as he said." The women hurried and told the disciples what they saw. The disciples arrived and went inside. They noticed the linen wrappings lying there, while the cloth that had covered Jesus' head was folded up and lying to the side. They saw and believed.

Jesus later appeared to the women and his disciples telling them, "All authority in heaven and on earth has been given to me. Therefore go and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, and teaching them to obey everything I have commanded you. And surely I am with you always, to the very end of the age." (John 20:1-8; Matthew 28:1-8 Summarized)

Relay for Life...Meet Katie Milledge

My name is Katie Rochay Milledge. I am your neighbor, a mother of eight girls, a coach, a nurse, a grandmother, a wife and I am a survivor. In 2009, at the age of 35, I found a lump the size of a BB. I called my doctor and I was sent for a mammogram where nothing showed up. Because of my concerns they did an ultrasound and found the lump along with two other places. A biopsy was done immediately on a Friday and Monday I was told it was breast cancer. Surgery was set up within two weeks of my diagnosis. The kind of cancer I had was under the muscle and pushed everything out. It was hidden. That's why it did not show up on the mammogram. After my surgery, I started radiation and chemotherapy. After two days, I was given medications due to dehydration and nausea. Once I got on a regiment, things got a little more stable.

During my diagnosis and treatments, I had children at home that ranged in ages from 2 to 15 years old. I was a single parent and worked. I also coached basketball and volleyball. Also, during my treatment I went back to school to become a nurse. My parents, Kathy and Howard Rochay, were there for all of it. My mom was my rock. She helped with the kids and anything that I needed. I also had a great friend, Shawn Milledge, who helped me out. Later he became my husband.

Following treatments, I started

reconstructive surgery. I had spacers put in and preparing for implants. Another scan revealed that my cancer had come back. Immediately, I started the chemo again. After the second treatment of chemo, we did a PET scan. The results showed it was in my lymph nodes, with 3 out of 12 nodes cancerous. Robotic surgery was done for the cancerous spots and weekly treatments began. The treatments of radiation and chemo worked. I am cancer free but very high risk because they were in my lymph nodes.

Besides the side effects of the nausea, dehydration and weakness there were many other things happening to my body. It caused kidney damage, to where they had to put stents in for kidney stones. Currently I work 3 days a week as an LPN in home healthcare and I fill in as a PRN. However, I do have some lasting effects that will eventually cause me not to be able to work this profession much longer.

I have had 37 surgeries since my diagnosis. There is no history in my family of breast cancer. I have been through a lot, but I am looking forward to continuing to be cancer free.

A Prom Night to Remember, Not a Tragedy to Forget

Few occasions in our lives produce more lasting memories than our high school prom or graduation. The pomp and pageantry is unforgettable as we bid farewell to more than a decade of schooling and the treasured friendships forged throughout our childhood. It culminates in a night of fun and frivolity before we embark on the next journey in our lives.

A long time ago, my wife Emma and I attended our high school prom together and we witnessed the same joy when our son and daughter headed out to their high school prom. The excitement I felt for them as they basked in the enthusiasm of prom night, however, was masked somewhat by my own worry. As a father and law enforcement officer for 45 years, I have the unique experience and unfortunate perspective of personally witnessing the darker side of prom season. Far too often, happy times can turn tragic — often the result of someone impaired getting behind the wheel of a vehicle.

Here are some sobering facts:

- Young people aged 12 to 19 are already more likely to die in an accident than by any other cause, with motor vehicle crashes being the most common.
- Between April and June (peak prom and graduation season), there is a massive spike in alcohol-related teen traffic fatalities.



Keeping our children safe has always been a priority. That is why the Nassau County Sheriff's Office and many community partners team up to raise awareness in the battle to eliminate impaired driving. We want to see our teens enjoy a safe and memorable prom and graduation season. Each year, NCSO presents important programs to warn and inform teens of the serious consequences of impaired driving. These presentations can be quite intense and real — but it reinforces the dangers and potentially fatal consequences of drinking and driving. NCSO also continues to be a proud supporter of other community organizations devoted to stamping out drunk driving, including Mothers Against Drunk Driving (MADD).

Should you have knowledge of teens that may be intoxicated or at a venue where they may be consuming alcohol, report this information to local law enforcement. Our young sons and daughters should dance, have fun and make lasting memories this prom and graduation season. But, above all, they should also be safe. PARENTS: please speak with your children. Remind them to protect their futures by making good choices — before a night to remember turns into one we'd all like to forget.



KINDERGARTEN REGISTRATION FOR NASSAU COUNTY SCHOOLS
