Callahan Approves Popeyes

The Callahan Town Council met Monday night, via teleconference, for their first meeting of April. The first order of business was four public hearings. The first was Ordinance 2020-O02 which concerned a small scale amendment to the Town's Comprehensive Plan Changing 1.91 aces on US Highway 1 from Mixed Use to Commercial Highway future land use. The council approved the ordinance.

The next was Ordinance 2020-O03 which concerned Chapter 195 to amend Due Public Notice definitions and requirements. The council approved the ordinance.

The final was Ordinance 2020-O04 which concerned amending Chapter 195 of the Callahan Code by removing outdated provisions and updating language. The council approved the ordinance.

The council received a recommendation from the Planning and Zoning Board to approve Popeyes Louisiana Kitchen site plan as presented. A public hearing was held on all previous items however on this item the council received public comment from Mr. Arthur Israel. "I am opposed to a Popeyes coming to Callahan. We don't need another fast food restaurant here," said Israel. "We need a nice place to go eat."

"We have petitioned several different restaurants but none have responded," said Mayor Marty Fontes. "It's not like we haven't tried."

"I've contacted numerous eating places: Golden Coral, Ruby Tuesday, etc.," said Councilman Ken Bass. "All respond that we don't have enough people or enough money to bring them here."

"I've only lived here about 2 years. I appreciate you answering my questions," added Israel.

"When I was mayor, I worked really hard to try to get a Publix to come to Callahan," added Councilwoman Shirley Graham. "It was the same story. Not enough people to



bring it."

Following the discussion, the council unanimously approved the Popeyes site plan. Popeyes Louisiana Kitchen construction will begin shortly with hopes for completion before Christmas!

Mayor Fontes advised the council that he had got some answers concerning the WeatherStem agreement with Nassau County and the Sheriff's Department. "I was told there will be 5 weather stations throughout the county. People in Callahan, Hilliard, Yulee and Fernandina Beach can use it," said Fontes. "Should we choose to have one here in Callahan the cost would be \$400 per month for 10 years with the first 3 months free. The weather station would be placed on the water tower or the fire station."

The council approved the WeatherStem agreement.

Fontes also advised the council that he declared a State of Emergency in the Town of Callahan on March 18. He requests to continue the emergency state until April 30 or until the pandemic is lifted. The council approved to continue.

Fontes gave an update on the Economic Opportunity Grant which is for \$5 million. "There have been some major changes. FPL is not pleased with the response from the county," said Fontes. "I recommend that we go ahead to run the wastewater line from our wastewater plant out US 301 to Crawford Diamond, and build a wastewater

Hilliard Town News

The Hilliard Town Council met Thursday night for their first meeting of April via telephone conferencing due to the coronavirus outbreak. The meeting was called to order by Mayor Floyd Vanzant followed by the Pledge of Allegiance and a prayer. Town Clerk Lisa Purvis called roll, in which all council persons and department heads answered.

The first item was the Water Conservation proclamation requested by the St. Johns River Water Management District (SJRWMD) and Mr. Geoffrey Samples. Town Attorney Christian Waugh read the proclamation that included: water is a basic and essential need for everyone; we want to help educate the citizens on the importance of water conservation; and everyone can make a difference by conserving water. "I want to thank you (Mayor) and the council for reading this today," said Samples. "March was a dry month and April is predicted to be even drier so more the reason to conserve water."

Town Clerk Lisa Purvis presented all the bids for the mowing contracts to the council. A motion was made by Councilman Kenny Sims and seconded by Councilman Jared Wollitz to accept the mowing contract bid from Smart Lawn Care at a cost of \$66,000. The council unanimously approved the award.

The next item was the approval of Emergency Ordinance 2020-02 which concerned declaring a State of Emergency in the Town of Hilliard. This was an emergency ordinance of the town council for the Town of Hilliard declaring a State of Emergency within the town of Hilliard in accordance with the declaration of emergency by the Governor; adopting emergency regulations to address preparation, management and mitigation of the Covid-19 threat

The following item was an emergency item added to the agenda by Mayor Floyd Vanzant which concerned setting up a workshop on Mayor Reform. Town Attorney Christian Waugh advised the council that he would like to give a little background about the workshop. "The concern is the Sunshine Law between the council and the mayor," said Waugh. "The town Charter says one thing and the Town Code says another. One needs to be corrected. Giving a veto to the mayor but can be changed by a 3-2 vote of the council. We need to make the changes or corrections by

"I think we should have a workshop on this however I would prefer us to do it in front of each other and not on the phone," said Sims. "I just feel like we can understand each other better in person."

Councilman Wollitz agreed.

"Perhaps we can at least have one workshop by phone to understand the issues, then hopefully by the next workshop we can all meet in person," added Vanzant.

"Let's discuss it at our next meeting and possibly set up a workshop date then," said

Another emergency item was added to the agenda: Setting a workshop for Policy for the Pandemic. "I was looking at Monday, April 6 for the workshop so we can get organized," said Town Clerk Lisa Purvis. "This is so that emergency powers will be designated to enable people who deal with day to day services and problems. Our attorney will have a draft ready for each of you to look over prior to the workshop."

"Can we move the workshop to Tuesday, April 7 at 6 p.m.?" asked Councilman Wollitz.

The council approved the emergency workshop teleconference Tuesday, April 7 at

In closing comments, Purvis requested approval to continue no late charges or cutoffs through April and also close the window (drive-thru) effective Friday, April 3? "We have had several people not following the distancing orders and our employees are scared they will get sick," said Purvis. "People can call the office, use the drop box or call for an appointment."

"Why wasn't this added to the agenda?" said Councilwoman Callie Kay Bishop. "These are things, I feel like we should discuss. Shouldn't we (council) be notified when changes are made?"

"This is what the State of Emergency allows. Decisions to be made and handled," said Purvis.

"I totally agree that we (council) should be told about any changes," added Wollitz. "I don't want to be blindsided by residents about something I don't even know about."

"I will notify council members about changes," said Purvis.

"Of course all of our programs are suspended and the fitness center is closed," said Parks & Recreation Director Kyle Malucci. "Are we going to look at possible refunds for gymnastics and soccer since they have only had one game? Also, some of our employees are questioning will they be laid off or do we have a plan?"

"Could your employees help out in other departments? It's just a thought," said Sims.

"That's a great idea," said Council President Beasley. "Check around and see what they can do. Also, we will look at refunds for those programs."

The next teleconference council meeting will be Thursday, April 16 at 7 p.m.

Dog Training at its Best...Tandem K9

I have noticed the new paint job, nice fencing and just the allaround upgrading of the building on US Highway 1 directly across from Spinner's Pizza in Hilliard. I tried to look and see just what it was but my mind got the best of me and Roger did some checking. He visited the website: www.tandemk9.com and was impressed with what he found. We need to do a story on them he suggested.

Friday, I made an appointment to visit with Dana Brown, owner and her partner Freddie Burger. Fortunately for me, she had a training session with one dog and a consultation with another. The dogs live in the same house but are different breeds and about six months different in the ages. Dana worked with the younger dog first, Miles (a boxer), to access his training needs. As his owner

and I sat on a couch, the energetic boxer ran around the room. Dana continued to talk with him but he continued to check us out. She told us to ignore him. In a short time, he gave Dana his full attention and continued to follow her commands somewhat.

Dana joined the Marine Corp in 1995 and served 17 years. She worked as a Military Police and trained dogs. She started showing

dogs when she was only 9 years old so dogs have been a big part of her life for a long time. In the military, she trained the dogs to be working dogs, searching for bombs, explosives, etc. "It was very intense but I love it," said Dana. "Dogs are masters of body signals. They are going to react to what our body is telling them."

She actually began Tandem K9 in memory of Dustin 'Dusty'

Jerome Lee, a friend who served with her in Iraq. He was killed in the line of duty March 21, 2007. "This was actually Dusty's dream to start this type of school," added Dana. "He was a great person and shared my passion and love of dogs."

During the assessment with the boxer, Dana was constantly working with the dog and talking with the master



about things to do. Later, she put Miles in the kennel and went and got Zeva, a giant schnauzer. It was completely night and day between the two dogs. As she continued to train and again referred to the owner of what needed to be done at home. "We are actually training the owners what to do," continued Dana. "The animal knows what to do. The

key is to take time with your dog daily and they learn. This is so rewarding for me."

Dana has recently been working as a contract worker in Iraq training dogs. Due to the Covid-19, she and Freddie are home for a while. The back of the building is set up with a kitchen, living room, bathroom, much like anyone's home. This is done so when people tell her they are having problems with their dog when they're in the kitchen, she can actually make it look that way to the dog. Such a neat set up.

She plans to have a doggy daycare and grooming at some point. She also plans to board for some clients. She is looking for a part-time groomer now.
