## Buck's Gulf Station in Hilliard Finally Demolished

For many residents in Hilliard, last Tuesday was a bittersweet day as they watched the former Buck's Gulf Station being torn down. The station, located at the corner of US Highway 1 and CR 108 in Hilliard, has sat dormant for 26 years since its closure in 1996. It was such an honor for me to meet with David Buchanan, whose grandfathers (both) and eventually his father owned the once-thriving business.

"The original Gulf station building was built in 1953 and it was located on the other side of US 1, by the current Nassau Pawn Shop. It was owned and built by my grandfather Cris S. Walker



(his mother's father) and the station was run by my uncle Ivor McConnell for about a year," said David. "For about the next 30 years, the station was managed by Julian Stokes, who was my father's brother-in-law. In fact, after Julian retired, his son Jeffrey managed the station for a few years. This was truly a family business. My other grandfather, Mr. Buck Buchanan, Sr. also worked at the station. My father Buck Buchanan already had a station and took this one over around 1955. Dad would

have been about 28 years old at that point. My grandfather was always called Mr. Buck, my dad Buck and me Little Buck."

Mr. Buck was always at the station and ready to help when needed. He loved meeting with people and talking. In fact, Mr. Buck passed away in 1963 at the counter in the station. He truly loved what he did!

Buck's Gulf Station was open 24/7 offering full service for all vehicles that came through. By full service they meant: fill up your car with fuel, check your engine fluids, windshield wipers, tires and vacuum your car. Back in those days, Gulf offered Gulf Flecks, basically a check list of things to do when a car pulled in. It was a good way to keep up with what the employees were supposed to do while providing a copy for the customers, too. Wouldn't that be nice to have that now, full service?

The new building (the one that was just demolished) was built around 1966. The old Methodist Church, a wooden building, was on the corner and it was moved to the back of the property behind the station. The building was

quickly put into use as a garage for working on vehicles. Through the years, many high school students were employed at the station. It was a great place to learn a trade and learn how to talk to people and socialize.

David remembers he and his brother, Gary, working at the station as young boys and later young men and adults.

The Buchanan family also owned and operated a Fuel Oil business that was located behind the original station. The business was open from 1946- 1978 serving and delivering fuel oil around the area. During the last few years of the station, the brand was changed from

Gulf to BP and finally to Shell. "It was bittersweet to see the old station go. I do wish my dad would have been here to see this. I think he would have been happy," added David. "I have so many memories of those days. I'm glad to see something come in its place and hope it will be as popular as the station was!"

The property was sold years ago by the Buchanans and has recently been sold again to its current owner. And yes, the old tanks have long been removed and the property has been clear of gas and diesel for several years. The current owner is still considering several options at this time of what will fill this new vacant corner in Hilliard. Inquiring minds can't wait to see what comes next!

### Volunteers Needed!

Dear Editor,  
I am Kim Clemons, Facilitator for the new NAMI (National Alliance on Mental Illness) Nassau County Family Support Group meeting the first Wednesday of the month at 12 noon at the Journey Church on Highway 1 in Hilliard. Since May is Mental Health Awareness Month, I would like to explain some things about our organization. NAMI Nassau County has no employees. We are completely staffed through volunteers and our Board members are volunteers. Maybe you have a link to mental illness and would like to make a difference? Maybe you have seen that untreated mental illness can lead to homelessness? Maybe in your job you have worked with people impacted by the devastating impacts of mental illness and substance abuse? Maybe you work in law enforcement and see the tie between mental illness and crime? Maybe someone in your family has come through a dark period of a suicide attempt, and you want to help other families in similar situations? Many of our volunteers come from these types of connections to mental illness.

Some of the volunteer opportunities require no training or expertise. For example, we have new print materials that need to be distributed around all parts of Nassau County in grocery stores, churches, community centers, laundromats or anywhere we have permission to place them. Many still don't know about NAMI or its work. But it takes volunteers to get out these fliers, brochures and information cards.

We also need help planning events. It is a volunteer who rounds up tables, tents and materials and develops a schedule for those who will work the NAMI table. In the past, NAMI has also put on a golf tournament, community dinners and walking events. These activities require several volunteers for successful planning and working the events.

For the support groups like the one I lead, we need facilitators. These individuals are also volunteers, though a friends and family facilitator should have a loved one living with a behavioral health diagnosis and peer facilitators should be individuals living with a mental health condition. Training is provided to interested persons at no cost to you. NAMI is a national program with a well-organized training model and a well-vetted evidence-based curriculum.

### Simple Chicken

2 skinless, boneless chicken breasts  
 2 1/2 tablespoons grated Parmesan cheese  
 2 tablespoons mayonnaise, or more to taste

2 tablespoons bread crumbs, or more  
 1 1/2 teaspoons herbes de Provence

Preheat oven to 425°. Place chicken breasts in a baking pan. Mix Parmesan cheese and mayonnaise in a bowl; spread evenly over chicken breasts. Coat with bread crumbs; sprinkle with herbes de Provence. Bake in the preheated oven until chicken breasts are no longer pink in the center and the juices run clear, 20 to 25 minutes. An instant-read thermometer inserted into the center should read at least 165 degrees F.

## JUST MY OPINION

You know the liberals can't let a horrific occurrence go to waste. It didn't take but a moment for Joe to turn the Texas massacre in to a political event. He totally disgusts me. Below is a portion of his message the day of the senseless killing of children and their teachers in Texas. He starts with, "I had hoped, when I became President, I would not have to do this again." It's been 340 - 3,448 days - 10 years since I stood up at a high school in Connecticut, a grade school in Connecticut, where another gunman massacred 26 people, including 20 first graders, at Sandy Hook Elementary School. Since then, there have been over 900 incidents of gunfire reported on school grounds. Marjorie Stoneman Douglas High School in Parkland, Florida, Santa Fe High School in Texas, Oxford High School in Michigan. The

list goes on and on. And the list grows when it includes mass shootings at places like movie theaters, houses of worship, and as we saw just 10 days ago, at a grocery store in Buffalo, New York. I am sick and tired of it. We have to act. And don't tell me we can't have an impact on this carnage. I spent my career as a senator and as Vice President working to pass commonsense gun laws. We can't and won't prevent every tragedy. But we know they work and have a positive impact. When we passed the assault weapons ban, mass shootings went down. When the law expired, mass shootings tripled. The idea that an 18-year-old kid can walk into a gun store and buy two assault weapons is just wrong. What in God's name do you need an assault weapon for except to kill someone? Deer aren't running through the forest with Kevlar vests on, for God's sake. It's just sick. And the gun manufacturers have spent two decades aggressively marketing assault weapons which make them the most and largest profit. For God's sake, we have to have the courage to stand up to the industry."

There's not enough room here to list all of his atrocities, however one response to his political speech from a friend on social media is perfect: she stated, "Seriously? You, the supposed leader of our country, dare to say "when in God's name?" when God isn't allowed to be a part of our country. No prayer in schools, but, yet, "when in God's name?" You want to know "when in God's name?" When YOU, J.B., and your people in D.C. go back to the basics on which our country was founded - God!

# What's Different?

When it comes to the term, Christian, some may have differing definitions. But I believe God's Word will give us a clear understanding of what a Christian is. For those who claim to be a Christian, the question must be asked, what's different? What is different about you now compared to before you became a Christian?

Let's start by coming up with a working definition of Christian. Merriam-Webster gives us a theologically poor definition: One who professes belief in the teachings of Jesus Christ. You could believe in His teaching without knowing Him. Dictionary.com also fails us theologically: A person who believes in Jesus Christ. This definition would include Satan and every demon, but I'm pretty sure they are not Christians. I think Focus on the Family gets it right with: The term 'Christian,' as we understand it, refers to anyone, man, woman or child, who trusts in Jesus Christ as his or her Savior and Lord and who strives to follow Him in every area of life.

So, let's say for the purposes of this article that you are a Christian. What's different? If we have had an experience with the Creator of the universe, shouldn't we expect that we are now different? Isn't that how interactions with powerful things work? If, for example, you found a downed live power line and decided you were going to touch it. I can guarantee that you would not be the same after. The same is true of 18-wheelers. You can't walk up to me and tell me you were standing out on US1 and got hit by a tractor-trailer. Because I know when you are hit by something as powerful as an 18-wheeler, you are changed.

When we experience the God of this universe, the Beginning and the End, the almighty Creator of everything, we are changed. So, what's different now? What has Christ done in your life? What does He want to do next?

"...Let us go over to the other side of the lake. So, they got into a boat and set out. As they sailed, he fell asleep. A squall came down on the lake, so that the boat was being swamped, and they were in great danger. The disciples went and woke him, saying, 'Master, Master, we're going to drown!' He got up and rebuked the wind and the raging waters; the storm subsided, and all was calm. 'Where is your faith?' he asked his disciples." Luke 8:22-25 (NIV)

Like the disciples, Jesus may ask us to go from where we were to another place. In our modern vernacular that could mean to change jobs, to sell and buy a different home, marry again, move to a different city, or to trust Him in the journey of your grief.

Perspective directly affects your faith. What can we learn from this powerful story? Your circumstance does not dictate your reality. He wants to speak life to it! He wants to usher you to the other side of healing and wholeness. Because of Him you do not have to live "there" anymore. Wherever your "there" is He wants to set

you free.

Your circumstance is surrounded by God. At the time, the disciples were unaware that the very Creator of the winds, rain and storm was asleep just a few feet away from them. They were unaware that the answer to their problem was already with them. Let that sink in. (pardon the pun) Like the disciples, your answer is already with you. He is omnipresent, all-knowing, all-seeing. Salute this Truth by believing and living as though He is already there.

Your circumstance requires Faith. Do not allow a storm to cover up your faith in Christ. Do not allow your circumstance to rattle you so badly so that you cannot think sober mindedly. The Lord wants you to be like a tree planted by the water, where your roots grow deep and are established. When the winds of life blow your way, "Where is your faith?" Have your own. Do not rely on other's faith like the disciples had to do.

Your circumstance does not have to swallow you up! There was a storm. The boat was filling with water. Danger is mentioned. The highlight of this story is not that danger existed, but the way Jesus calmly and peacefully reacts to it. That same fortitude is within us, His believers, by the power of the Holy Spirit living inside of us.

Some of you are living in a very real storm right now. You have been asking for help. You have been asking for direction. The good news is that He is already there. Trust Him. Allow your faith to be established in Him.

Pray this prayer: Father, you know the pain I have been dealing with in my life. You know the heartache that overwhelms me to the point that all I can do is cry. You know exactly where I need the greatest help right this very moment. Lord, come in and help me to have my faith established only in You. You will never leave me, nor forsake me. You will always have my best interest in mind. Lord, I want to glorify You with my life. Bring your will on earth as it is in heaven and establish it in my life today. In Jesus Name. Amen.



# Home Values in Nassau County Reach Record Appreciation Levels

In my forty plus years in the real estate and appraisal industry, I have never experienced a real estate market like the current one. There are a record number of people migrating to Florida from other states due to previous lock downs, lower taxes, better schools, and the ability to work remotely. This has created a shortage of available housing for sale and inflation has driven building cost to record levels, making existing homes more attractive. For the second year in a row, almost all properties offered for sale are receiving multiple offers within the first few days, resulting in bidding wars and sales prices above the original list price. However, this market is dramatically different than the market we experienced from 2004 to 2008 which produced a collapse of the housing market. The current market is a user's market opposed to a speculative market, which was driven by loose lending practices and speculative building. This market is being driven by buyers with cash looking to improve their quality of life by relocating to the Great State of Florida. The record level of appreciation is a direct result of limited supply and increased demand, which is simple supply and demand economics. Tracking and trending sales into the first quarter of 2022 indicate some neighborhoods on Amelia Island have seen a 50% or more annual appreciation.

The supply chain issues, staffing, fuel prices, and inflation have hurt many small businesses and commercial properties. Our job is to measure what, if any, the loss of business had on the value of the real estate as of January 1, 2022. Some properties are owned and purchased for their ability to produce income. That

income drives the value of the real estate. Due to the lockdowns in 2020 and 2021, many income producing properties, such as hotels, restaurants, and movie theaters, lost value due to a forced shutdown. Most made a comeback in 2021, but the full-service hotel industry, for example, is not expected to reach 2019 income levels until 2024. Even after considering the reductions in value to some commercial properties because of the pandemic, value in Nassau County has once again reached record levels.

Due to the migration of out of state buyers and increased demand for residential properties, the total market value for the County has reached a new record high of over \$20.5 billion, which is an increase of over 18% from the previous year. The taxable value has surpassed the previous year exceeding \$12.6 billion, almost 14% above last year.

The City of Fernandina Beach is projected to see a taxable value increase of 12.5%, bringing their taxable value to about \$3.37 billion.

The Town of Callahan is estimated to have its taxable value increase to \$137 million, up by over 10% from last year.

The Town of Hilliard is expected to see about an 11.3% increase in taxable value, bringing that value to over \$129.5 million.

The primary responsibility of the Property Appraiser's office is to produce a tax roll which is fair and equitable. Florida Statutes require we identify and appraise every parcel in the County to a "Just or Fair Market Value" each year. This is the starting point for Florida's property tax system and the funding source for



local government. I am often asked, "How do you determine the just or market value of my property?". Florida is a 100% assessment state. This means each year we are required to estimate the "fair market value" of a property based on the most probable price it

would have sold for if offered for sale in an open market. Consequently, we run sales and statistical analysis for different neighborhoods, markets, and property types to determine a sales ratio. These ratios reflect a comparison of a property's sales price and its current just or market value. We make changes to values based on the sale ratio for their property types and market. Because we mass appraise, the Department of Revenue allows us to be within a range of value, not to exceed just or fair market value. Our effective date for value and exemptions is January 1st of each year, which means this year's values are based on last year's sales. With market values increasing at record levels, we were required by the Department of Revenue to time trend sales that happened in 2021 to account for appreciation. This means if you purchased your home in the early part of 2021, it would most likely sell for more than your purchase price by January 1, 2022.

Also, to qualify for homestead exemption for this tax year, you must have owned and occupied the property as your primary residence as of January 1, 2022. Although taxable values have increased county-wide, many property owners are protected by the Save our Homes (SOH) Amendment, which caps the amount the assessed value can increase. The assessed value of homestead properties

can increase no more than 3% or the consumer price index (CPI), whichever is lower. Because the CPI is well in excess of 3% for 2022, previously homesteaded properties assessed values will increase the maximum 3% this year. Non-homestead properties have an assessment cap of 10%.

We provided the 2022 estimated values to the taxing authorities on May 27th so they may begin their budget process using these preliminary figures. They will use these values to help determine their tax rate for the property owners of Nassau County for this tax year. Property Appraisers in Florida have NO control over the actual amount of taxes levied. The amount of the taxes levied is controlled by the taxing authorities and is determined by the millage rate needed to support their annual budgets each year. I would encourage you to participate in this process. Increases in taxable values will result in higher taxes "IF" taxing authorities increase their current tax rate or keep their millage rates the same as last year.

The "official" preliminary tax roll is expected to be released to the taxing authorities and the Department of Revenue by July 1st. Property owners are encouraged to visit the Property Appraiser's website at [www.nassauflpa.com](http://www.nassauflpa.com) in late July to review their 2022 property values. 




