Nassau County School District Approves Return-to-School Plan

In a School Board meeting held last Thursday, July 23, the Nassau County School Board finalized plans for faculty and students to safely Return-to-School. On Monday, July 27, the board voted unanimously to approve the plan. Students will return to school Monday, August 24, 2020, either in person or through distance learning. It is in the best interest of the district to reopen with healthy learning environments. Schools will employ a combination of self-screening and observational screening protocols for universal screening of illness of staff and students. The district and schools will communicate information to parents and staff about the symptoms of COVID-19 and require them to self-screen before coming to school. Students and staff exhibiting symptoms of COVID-19 without being otherwise explained are prohibited from coming to school, and if they do come to school, they should be sent home immediately. In addition, the district/school may take the temperature of students and staff on a random basis or in situations where there is reason to believe that the person may be ill. Touch-free thermometers will be utilized and will be provided for use in clinics, at front desks, to food service staff, and any other school/district area where a team has determined a specific need.

FACE COVERINGS: The importance of wearing face coverings has been well documented and is being recommended by public health officials at all levels. Face coverings may slow the spread of the virus and help people who may have the virus and do not know it from transmitting it to others. Face coverings, as used in this plan, mean a uniform piece of material that covers a person's nose and mouth and remains affixed in place without the use of one's hands, whether store-bought or homemade, concurrent with Nassau County Health Department guidelines. Parents are encouraged to provide their

students with their own face coverings. However, the district will provide face coverings for students who do not have them.

Elementary students (grades K-5) are required to wear a face-covering while walking in hallways, riding the bus, waiting in line in the cafeteria and when working in small groups or individually with a teacher or peers whenever a divider is unavailable. Students may remove face coverings during high-intensity outdoor activities, while in their classroom working at their desk and while seated for dining within their class group.

Secondary students (grades 6-12) are required to wear face coverings when they are not able to be 6 feet from others, are in hallway transitions/class changes, in large common areas, are riding the bus, and are in line in the cafeteria area. Face coverings may be removed for high-intensity outdoor activities, when seated at the dining tables for eating, and during mask breaks in the classroom as determined by the school or teacher.

Accommodations for face-covering

protocols can be made for students/staff based on their individual health needs. The need for face coverings will continue to be evaluated.

LEARNING OPTIONS:

ELEMENTARY (Grades PreK-5): Elementary Option 1— Traditional School (Brick and Mortar) K-5 students will go to school as normal, five days a week. PreK students will go to school as normal, four days a week. Early release days will continue to occur every Wednesday.

*If your child is a student with disability being served through our pre-kindergarten, Access Points, STARRS, or our medically fragile program, it is the recommendation of the Nassau County School District that you continue to send your student to their zoned/assigned school and to select Option 1 for your student.

Elementary Option 2— School-Based Distance Learning Students will remain attached to the current school while receiving instruction online. Teaching will mirror the pace and rigor of the traditional brick and mortar school. Students choosing this option should

make a semester commitment.

Elementary Option 3— Nassau Virtual Students who choose Nassau Virtual will withdraw from their traditional school and switch their enrollment to Nassau Virtual. Students choosing this option should make a semester commitment.

SECONDARY (Grades 6-12): Secondary Option 1 – Traditional School (Brick and Mortar) Students will go to school as normal, five days a week. Early release days will continue to occur every Wednesday.

*If your child is a student with disability being served through our Access Points, STARRS, Transition Adult Program (TAP)/Project Search, or our medically fragile program, it is the recommendation of the Nassau County School District that you continue to send your student to their zoned/assigned school and to select Option 1 for your student.

Secondary Option 2 – School-Based Distance Learning Students have the choice of remaining attached to the current school while receiving instruction online. Teaching will mirror the pace and rigor of the traditional brick and mortar school. Students choosing this option should make a semester commitment. All courses will not be available through school-based distance learning. For courses not available through school-based distance learning, students may take the course through Nassau Virtual or FLVS.

Secondary Option 3 – Nassau Virtual Students who choose Nassau Virtual will withdraw from their traditional school and switch their enrollment to Nassau Virtual. Students choosing this option should make a semester commitment.

Primary Election, Upcoming Mailers and Information

As the August 18th Primary and November 3rd General Elections near, I want you to know that your Elections Team has been hard at work planning and preparing to provide you with safe, secure and convenient methods to vote. I will be preparing press releases as often as needed to provide updates and factual information to Nassau County citizens to ensure a safe, transparent, and smooth voting experience for all voters.

AUGUST 18th PRIMARY ELECTION:

- BALLOT STYLES:** In a primary election, your ballot style is based on your residential address and your party affiliation. Every voter will receive a ballot with the same races except for the Republican ballot style which will have one additional race: Rep. in Congress, District 4.

- REPRESENTATIVE IN CONGRESS, DISTRICT 4 RACE:** In order to vote in this race, a voter must be registered as Republican. The deadline to change party affiliation for this election was July 20, 2020. The Republican candidate who receives a majority of the votes will face a Democratic and write-in candidate in the general election.

- UNIVERSAL PRIMARY CONTESTS:** There are seven (7) races that are Universal Primary Contests on the ballot. This means that candidates with the same party affiliation qualified for the seat and, because there were no other candidates to face in the General Election, all registered voters in Nassau County are eligible to vote in these races. The candidate with the highest number of votes in the primary election will be elected to the seat.

- DISTRICT RACES:** In Nassau County, the County Commission, School Board and Ocean, Highway and Port Authority are at large districts. This means that all registered voters in the county are eligible to vote in all district races. Provided your address is correct in your voter record, you are eligible to vote for any contest on your ballot. You will never be issued a ballot with a race for which you are not eligible to vote.

- NONPARTISAN RACES (COUNTY JUDGE AND SCHOOL BOARD):** The following nonpartisan races are on the ballot:

County Judge: There are four candidates in this race. If one candidate

does not receive a majority of the votes (50% plus 1 vote) in the primary election, the two candidates with the highest number of votes will be on the ballot in the General Election.

School Board: There are only two candidates in the race. Therefore, the race will be decided in the primary and will not be on the general election ballot. The candidate with a

majority of the votes will win.

- POLLING PLACE CHANGES:** There have been eight (8) polling place changes for the upcoming elections. A new Voter Information Card is being mailed to every registered voter with the name and address of the voter's current polling place.

- VOTE BY MAIL BALLOTS:** Florida law does not allow ballots for domestic voters to be mailed any earlier than 40 days prior to an election. Vote by Mail ballots for voters who had a request on file were mailed on July 9th and will be mailed daily to voters who request them. The last day to request a vote by mail ballot be mailed is August 8, 2020 at 5 p.m.

UPCOMING MAILERS FROM THE NASSAU COUNTY SUPERVISOR OF ELECTIONS OFFICE:

- Every registered voter will be mailed a new Voter Information Card.

For those voters who have a polling place change, a Notice to Voter will be noted on the front of the mailer.

All voters will be provided a detachable postage paid Vote by Mail Request form. I strongly encourage every voter to request a vote by mail ballot this year. By doing so, you will have your ballot at your fingertips in the event of a hurricane, pandemic such as COVID-19, an unexpected family emergency or a business obligation arises, etc. and you can return it by dropping it off at an early voting site during early voting hours, returning it by mail at least 7 days prior to Election Day as recommended by the postal service, or delivering it to the Elections Office. You can track your vote by mail ballot at www.VoteNassau.com to show when it was requested, sent, received and counted (no voter error so ballot will be counted). It's like taking extra medications on your person when you are traveling and separated from your luggage—you have it if you need it! You can always vote in person if you choose to do so.

- No later than July 28th, every registered voter will be mailed their Sample Ballot for the August 18th Primary Election

with specific ballot style, early voting dates, times and locations, acceptable forms of identification if voting in person, how to prepare before going to vote and upon arrival and much more!

Both of these mailers will have the residence address and mailing address as currently shown in your voter record. It is extremely important that you verify your residence and mailing address are accurate to ensure you receive the correct ballot style when voting. If it is not correct or you do not receive these mailers, please contact our office immediately and we will assist you, or visit www.VoteNassau.com to update your voter record.

A Voter Guide will be mailed to every household in Nassau County to provide: all Nassau County citizens with an opportunity to register to vote and/or update their voter record, information on COVID-19 preparations, polling place changes, and other important election information.

FACTS ABOUT VOTE BY MAIL LAWS IN FLORIDA:

There has been confusion about the difference between a full mail ballot election (allowed in some states) where every registered voter is mailed a ballot versus voting by mail in Florida where a voter has to request their ballot be mailed. Florida is a state that has three methods to vote: by mail, early voting or on Election Day. I am confident that vote by mail laws in Florida provide a controlled and verifiable method to ensure voter fraud does not occur, for some of the following reasons:

Florida law does not allow mailing ballots to every registered voter except for referendum elections for local government elections and a plan must be submitted and approved by the Secretary of State to conduct the full mail ballot election.

In Florida, a voter (or immediate family member) can request vote by mail ballots through two General Election cycles and the ballot must be delivered to

an address in the voter's record or the voter has to provide a signed request to mail to another address.

Ballots cannot be forwarded and are returned to our office if the address is not current. Therefore, ballots do not end up in the hands of other people. When an undeliverable ballot is received, contact information in the voter's record is used to notify the voter and a letter is promptly mailed (which is forwardable).

In order for the ballot to count, it must be received in the Elections office no later than 7 p.m. on the day of the election and the signature on the Voter's Certificate must compare to signature(s) in the voter's record.

If there is a voter error (no signature or signature difference), the voter has 2 days after the election to deliver an affidavit (with proper identification) to cure their error.

Voting by mail in Florida is safe and secure. Unlike mail ballot elections where every registered voter is mailed a ballot and may not expect it, in Florida a voter has to request the ballot, so they expect the ballot to be delivered to them. It's similar to ordering a product online, you order it and you expect it to be delivered, you can track it, and check on it if it is not received timely—the same applies to the vote by mail ballot a voter requested—you expect it and you control it!

Many citizens have contacted our office about mailings, emails and calls they have received which have caused concerns and confusion. If you receive an unofficial mailing, I would recommend you use it as a reminder to visit our official website or call our office directly and then promptly dispose of the unofficial mailer. For unofficial calls and emails, I would recommend that you not provide your personal information but that you contact our office directly for assistance. We are here to assist you and provide you with factual information and efficient, transparent and accurate elections!







NCSO Seeking Statewide Re-Accreditation

A team of Commission for Florida Law Enforcement Accreditation assessors will conduct an assessment of the NCSO in August. The Commission for Florida Law Enforcement Accreditation's assessment team will consist of team leader Mr. Oscar Kieffer, Palmetto Police Department and team members Captain Lee Ann Holroyd, Monroe County Sheriff's Office and Sergeant Michelle Hernandez, St. Lucie County Sheriff's Office.

Once the Commission's assessors complete their review of the agency, they report back to the full Commission, which will then decide if the agency is to receive accredited status. The NCSO accreditation is for 3 years. Verification by the team that the NCSO meets the Commission's standards is part of a voluntary process to gain or maintain accreditation--a highly prized recognition of law enforcement professional excellence.



Florida Master Gardener Volunteers Help Youth Grow Up Florida-Friendly

Florida students can now learn the nine principles of Florida-Friendly Landscaping™ (FFL)—guidelines that help yards thrive and protect Florida’s waterways, from a new illustrated book, thanks to UF/IFAS Florida Master Gardener Volunteers.

The book, “Growing Up Florida-Friendly,” was written and illustrated by two Florida Master Gardener Volunteers and designed for grade-school children. “There are not a lot of resources for children that speak to this topic on a friendly, easy to apply level,” said Kim Pepitone Cottrell, Florida Master Gardener Volunteer, and the book’s author. “Evelyn, the book’s illustrator, took my idea and brought it to life. Readers will follow Flory, an orange blossom, on a journey with Russell and Harriet through the nine FFL principles.”

Flory, Russell and Harriet represent a fun and innovative way to share the nine principles with children. The main characters take children on a journey through Florida-Friendly Landscaping™

and emphasize the importance of learning early to keep Florida’s water clean and protect natural resources. “From the get-go, it is important for kids to understand the connection to science when they talk about plants and gardening,” said Cottrell. “We want to teach children from the beginning that they can make a positive impact on our environment, even when gardening in their own backyards.”

Readers are asked to become an “FFL kid,” which provides goals along the way. The overall mission is to let kids know that they can play a role in saving our waterfront. “All roads lead to the aquifer, and we have to protect our natural resources,” Cottrell said. “Taking responsibility beginning forms good habits that children

will carry into the future. Everything you do can have a positive or negative impact on our environment. This book helps kids see the positive outcomes they can have.”

Bill Lester, who holds a doctorate in plant medicine and serves as the UF/IFAS Extension Hernando County horticulture agent and Master Gardener Volunteer Program leader, encourages volunteers to identify unique ways to reach residents in the county, especially youth. “We are always looking for a diverse, strong representation of the community within our Master Gardener Volunteers, where they can bring different talents and abilities to the program,” Lester said. “When they bring unique ideas like this to me, I support them to run with it and ask them how I can help. This book is great because it is a unique project for Master Gardener Volunteers to take on,

not something we have done before. It will help educate children, adults and our local residents.”

While many UF/IFAS Extension agents educate youth around the state on FFL principles, this is the first tool of its kind created exclusively for students. “I loved creating the graphics,” said Evelyn Lavaughn Davis, the book’s illustrator and Master Gardener Volunteer. “I am a substitute teacher and see the need for more Florida living education in our schools that can help children and their parents understand best practices. I want children to understand the impact humans have on what makes Florida a beautiful state to live in,” continued Davis. “I hope outdoor experiences will inspire them to be good stewards of the land.”

Additional COVID-19 Test Site in Nassau County

The Florida Division of Emergency Management (FDEM) has partnered with the Target Corporation to sponsor seven COVID-19 testing locations across the state. One of these drive-up sites will be located in the parking lot of the Yulee Target store located at 463737 SR200 in Nassau County. Testing provided through the site is free of charge and available to anyone over 18 years of age. Specimen collection at the Yulee Target site will take place from 9 a.m. to 5 p.m. seven days a week beginning Saturday, July 25. The site will be operational for four weeks.

The FDEM is providing the necessary staffing and personal protective equipment for the operation. Individuals who go to the Target test site in Yulee should have photo identification with them. Upon arrival, each person to be tested will register their name and contact information and then return to their vehicle or wait in a shaded area until they are notified that their specimen collection kit is ready. The samples will be sent to certified laboratories for testing; results are expected to be available within five to seven days from the date of collection.


