Golf Cart Friendly Community in Hilliard?

The Hilliard Town Council met Thursday night for their first regular meeting of July. Hilliard resident Ray Schmoltz approached the podium to address the council. "I would like to ask, What would it take for Hilliard to be a Golf Cart Friendly Community?" said Schmoltz. "I am a golf cart owner and just want to know what we (residents/council) need to do to get us there?"

"I think this would be a good workshop to discuss whether the carts must have lights, tags, etc.," said Councilman Kenny Sims. "We also need to know if there is any liability to the town. What are your thoughts



Christian (Town Attorney)?"

"I think a workshop is a great way to get the conversation started. I would see no liability to the town," added Attorney Waugh. "I also represent The Villages down state, which is a Golf Car community. There is a difference between cart and car. I also think this would be a great opportunity for the town to be able to offer this to residents."

A workshop will be held Monday, July 12 at 7 p.m. on the subject. The public is encouraged to attend.

The first order of business was to set up another workshop between the council, the Hilliard Planning & Zoning Board and Doug Adkins. Adkins is planning to build a mixed-use development that will be constructed and operated by Dayspring Health, LLC. The project will be Daysprings Common Planned Unit Development (PUD) proposed for 4.17 acres of property located at Orange Street

and West Sixth Street in Hilliard. The workshop will be held Monday, July 12 at 6 p.m.

The following agenda item was a recommendation from the Planning & Zoning Board to allow the re-plot of Lots 36-40 and 56-63 of the Deer Run subdivision (between Kristie Circle south & north on CR 108), to create the SSI subdivision for the property, complying with Chapter 46 of the Town Code. The council approved the recommendation.

The next item concerned another recommendation from the Planning & Zoning Board for the council to waive the permit fee for the relocation of manufactured homes, older than five years, from the Pine Street trailer park to other locations within the Hilliard City limits. The council approved the recommendation. Town Clerk Lisa Purvis also added, "I have been in touch with the county concerning searching for other apartments or mobile homes

for these residents plus we have had many people helping out with the relocations. We (the town) are trying to assist where we can."

The council approved Resolution 2021-15 which concerned accepting a FDOT New State Highway lighting, maintenance and compensation agreement. This agreement is for the street lighting and maintenance on US Highway 1.

In closing comments, Hilliard resident Skip Frye added, "I just want to compliment Hilliard Parks & Recreation Director Gabe Whittenberg for his great work with the recreation department. It is so great to see so many children out there playing sports and the pool being used."

"Thank you for allowing me to 'listen in' to the meeting via teleconference while we await the arrival of our baby daughter. I don't want to be too far away when she arrives," said Attorney Christian Waugh.

The next meeting of the council will be Thursday, July 15 at 7 p.m.

Bicyclist Fatally Injured Friday

According to Florida Highway Patrol reports, a vehicle driven by a 27-year-old man from Miami was traveling southbound on US 1 south of CR 108 in the left lane. A 34-year-old bicyclist from Hilliard was westbound crossing US 1 from the east shoulder. The bicycle crossed into the path of the oncoming vehicle. The front of the vehicle struck the right side of the bicycle causing fatal injuries to the rider. The accident is still under investigation.

More Nutrition Available for WIC Families

The American Rescue Plan Act (ARPA) authorized State WIC Agencies to enhance the WIC benefit for a period of four months, expanding the vegetable and fruit voucher from \$9/month for children and \$11/month for women to \$35 per month, per participant. Florida WIC has implemented the increase now until September 30, 2021. All women and children 1 - 4 years old

who participate in the WIC Program will receive an increase in their fruits and vegetables cash voucher to \$35 per participant, per month.

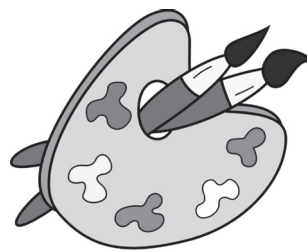

But in reflection, after what has happened since a year ago July 4th, I'm not all together critical of that sentiment. America is burning, being invaded, turning its attention to the law-breakers and away from the law-abiding. In doing so, the American Dream is being eroded and the amount of people that believe that this is the "Land Of Opportunity" are fading fast.

With national polls indicating a loss of nearly 20 percent in the number of people that take pride in America, a national network interviewed eight students from Georgetown University, a private institution in Washington D.C., asking if they were proud to be an American. To the person, not one said that they were and most all acknowledged that, to varying degrees, they were embarrassed to be Americans.

You don't know how glad I am that my father is not alive to hear that. A Veteran of WWII, and the father of two sons that served during some of the most contemptuous times in our nation's history, he was thrilled to not only enjoy the celebration of the Fourth of July, but also include friends and relatives in on that joy.

Due to the dreamed up political (Lie) climate, we have law enforcement officers retiring or resigning at an alarming rate. Law Enforcement Officers are being encouraged to NOT wear their uniforms as they travel to and from work, so as not to create a potential hostile atmosphere in their travels. I recall the same instructions by our base commander, during the Viet Nam Conflict, advising us to not wear our uniforms off base so as to avoid being targets for the protestors. Even to the point that we, who lived off base, were advised not to stop going to our homes or anywhere along the way, until we changed clothes. I was very proud of that uniform and of my

Shots Fired...Arrest Made

On Friday, July 2, 2021 around 1:45 a.m. a shooting incident occurred at the Circle K convenience store at US-17 and Harts Road in Yulee. A male suspect, identified as Ernest Mitchell Bannister, Jr., 31, from Callahan, was in the parking lot of the Circle K looking around a vehicle that was parked there. As he was looking inside the vehicle, the male owner (victim 1) who had parked the vehicle there earlier in the day and two other males (victim 2 and 3) drove into the parking lot. Victim 1 asked Bannister what he was doing around his vehicle and he stated that he was looking for his girl.



attendant, who also heard the gunshots and glass breaking, came out. They told her they had just been shot at and she called 911. Deputies arrived to gather more information about the incident and put out a description of the suspect's vehicle. The investigation revealed

that one of the bullets went through the front glass window of the business and penetrated the soda machine in the back of the store.

At approximately 2 a.m. a Nassau County Sheriff's Office deputy was traveling on CR-108 west of I-95 and observed an abandoned vehicle fitting the description of the suspect's vehicle (white with large rims) in the ditch near the wood line on the north side of the road.

Other deputies responded as well as our drone unit to search the area for the suspect. As the drone flew over a dark heavily wooded area on the south side of the road the suspect was observed hiding approximately 200 feet from the roadway. Deputies called for the suspect to come out and he complied. The handgun used in the incident was found in the ditch near the vehicle.

Ernest Mitchell Bannister, Jr. was arrested for Aggravated Battery with a Deadly Weapon; Aggravated Assault with a Deadly Weapon; and Felony Criminal Mischief.
