Tuesday's election results were close. Nassau County only had a 30% voter turn-out with 22,481 votes cast.

The closest race was for School Board District 4 with Kristi Simpkins winning with 10,173 votes to incumbent Cindy Grooms with 10,099 votes, a margin of only 74 votes. Per Florida Statues, the Supervisor of Elections office, will do a recount for the District 4 seat on Saturday. Certification of the counts and the election will be held Monday, August 26.

The Callahan Town Council met Monday night for their final meeting of August. The meeting began with two Callahan residents wishing to address the council. The first, Ms. Jenny Ackerman, who lives on Robinwood Circle. "I have lived in Callahan for five years and I love it. I'm here to address code violations within Robinwood Circle and Brown Street," said Ackerman. "These violations range from mobile homes in disrepair to open trailers filled with debris, old campers and vehicles in yards, etc. There is also a retention pond that the fence is


broken and needs to be repaired before something happens. Some sidewalks have been repaired but not all. People, like me, like to get out and walk and it can be dangerous on the sidewalks. I'm not just a grumpy old woman, I love people and I love Callahan, but these things are an eyesore. I maintain my home and yard. I'm here to ask for your (council) help to have these things addressed and taken care of. These are truly town code violations." Ms. Ackerman provided pictures and a letter of her concerns to the mayor and council.

who lives on Arline Road, addressed her concerns about the Callahan Volunteer Fire Department (CVFD) and began her message with her letter of resignation from the department. "Please accept my resignation as a member of the CVFD, where I have been a member for over two years. I have served as a career firefighter in metro sized departments and am fully aware of the State laws on certification for Fire Departments," said Roberts. "In January, we (CVFD) were told that the jobs for Chief and Assistant Chief would be posted and was not done so until April. I informed Bass about the requirements, per Florida Statues, for the positions. I have voiced my concerns about the lack of safety equipment and training for our personnel and no actions have been taken. In my two years, there has been no training. Two candidates, one certified and one not, applied for the Fire Chief position and in May interviews were held. The non-certified was chosen. I cannot, in good conscience, serve as a firefighter under a chief with no legitimate time in service."

Roberts provided a letter of resignation to the mayor and council

and turned in her volunteer equipment promptly following the meeting.

The first order of business on the agenda was a presentation from Callahan Mayor Randy Knagge. "We would like to recognize former council member, Mr. David Mellecker, for his 12 years of service to the Town of Callahan. "Mr. Mellecker was always present at meetings and always aware of the concerns of the town and its people," said Knagge. "We could always count on you (Mellecker) to go above and beyond to learn about the issues that the town faced and do his due diligence to make our town better. For that we thank you for your service."

The following agenda item was a presentation from Sherri Mitchell,

Executive Director of the Nassau County Economic Development Board. "First, thank you for having me tonight. We (NCEDB) have been very busy working on bringing industry to Nassau County. As the Crawford Diamond draws closer to being finished, we have FPL that bought 1,800 acres of the Diamond. They placed a solar farm on 1400 acres and there are still 400 acres left for other industry and we have had many companies looking at the property," said Mitchell. "We are continuing to maintain the businesses we have and encouraging them to continue to grow here in Nassau County. There are new businesses coming right here in Callahan and more to come. We (NCEDB) appreciate the support of Callahan and ask for your continued support of \$2,500 this year."

The next agenda item was a presentation from Mr. Jari Edwards. "I'm here to tell you about my mother, Kay Raulerson Edwards. My mother was the greatest person to her family, school and town. She was always... all in! No matter what she did, she did it with all her heart. She passed away in 2019," said Edwards. "Her lifelong dream was to relieve the burden and expense from teachers to provide for their students, so they could just teach. I've started a foundation, NSEW

Foundation, which is North, South, East, West of the county. Her dream was to help all teachers throughout the entire county. Right now, my focus is on the west side. I plan to host fundraisers and events to raise money to provide for teachers each year. This year, my goal is \$200 per teacher and starting with Callahan Elementary School. I'm also asking for the town's support for this cause."

The next item concerned the town supporting the West Nassau Swim Team with a donation. Keith Whaley thanked the town for their support each year and graciously asked for it again. "The team has to rent time at the Hilliard pool and also the Jacksonville Aquatic Center to practice, as they don't have their own pool. We would appreciate any donation from the town," said Whaley.

"We will do a resolution at the next meeting concerning a donation for the swim team," said Council President Ken Bass.

John Hendricks, representing the West Nassau Historical Society, addressed the council concerning the upcoming Callahan Christmas Parade. "Yes, I know, this seems early but it will be here before we know it. We (WNHS) wanted to ask the town again for their monetary support for the parade. The Christmas Parade and Craft Show will be held Saturday, December 7 at 11 a.m. This year's theme will be A Red, White and/or Blue Christmas! We have prepared a breakdown of items the town has provided in the past and hope for your support again," said Hendricks. "Also, we are asking for the use of the railbed, Saturday, November 16, Hobos, Tractors, Heroes Festival; Saturday, December 7 Christmas Craft Fair; and Saturday, March 29, 2025, Railroad Day Festival."

The final agenda item was the approval of the Callahan Volunteer Fire Chief. "Per the Florida Statue, if the Volunteer Fire Chief is a paid position the person must have their Fire I and II certifications," said Bass. "If they are not paid, they may hold the position of chief contingent on getting their Fire I certification within 1 year."

With many questions from the council, the council approved of Chris Wood to be the Volunteer Fire Chief, contingent on him achieving his Fire I Certification within one year.

The next meeting of the council will be Tuesday, September 3 at 7 p.m., due to the Labor holiday on Monday, September 2.



# The Silence Is Broken

In the last article, we completed our overview of the Old Testament. Between the Testaments there are 400 years of silence. The Old Testament covered 4,000 years of history and the New Testament will only cover 100 years of history (6 BC-95 AD). The New Testament was anticipated in the Old Testament. In the Old Testament we saw Christ concealed and in the New Testament we will Christ revealed. In the Old Testament, Christ was anticipated. In the New Testament,

Christ is manifested and proclaimed.

The first books in the New Testament are called the Gospels. A gospel is not a biography of Jesus. A biography would tell you everything about the life the Christ. The Gospels tell us about the birth of Jesus, then one verse is given to what Jesus did when he was 12 years old, and then speak of the last three years of Jesus' life. The Gospels are selective and purposeful collections of the good news of Jesus' sinless life, sacrificial death, and triumphant resurrection. The Gospels do not satisfy our curiosity about the entirety of Jesus' life, the Gospels give us the good news of Jesus' life and ministry and why Jesus is most important figure in history.

• The Gospel of Matthew: Matthew was one of the 12 apostles. Matthew was a Jew writing to Jews to show that Jesus is the fulfillment of the Old Testament prophecies and promises. Jesus is presented as the Son of David and the Son of Abraham (Matt.1:1). Matthew's gospel can be summarized as follows: Jesus is revealed (1-9), resisted (10-18), rejected (19-27), and resurrected (28).

• The Gospel of Mark: Mark was not an apostle, but he was a companion of Peter. Mark is the oldest and shortest Gospel. Mark presents the good news about Jesus to Gentile audience highlighting most important facts regarding Jesus' life, death, and resurrection. Mark's dominant portrayal of Jesus is the Suffering Servant (Mark 10:45). The Gospel of Mark begins with an introduction (1), summarizes the ministry of Christ (2-8:30), and concludes with the Passion of Christ (8:31-16).

• The Gospel of Luke: Like Mark, Luke was not an apostle. Luke was a traveling companion of Paul. Luke was a historian who carefully constructed a summary of Jesus' life and ministry. Luke arranges his Gospel around a travel narrative of Jesus' time on earth. In (1-4:13), Luke introduces us to Jesus and then he proceeds to show us Jesus' ministry in Galilee (4:14-9:50), Jesus' ministry en route to Jerusalem (9:51-19:27), and concludes with Jesus' ministry in Jerusalem (19:28-24).


• The Gospel of John: John was an apostle who wrote his gospel in order to prove that Jesus was the Son of God and by believing in Jesus, we could have life in his name (John 20:30-31). John's Gospel is absolutely fascinating as he presents Jesus as the Son of God (John 1:1). John's Gospel is composed of an introduction (1), the book of signs (2-11), and the book of glory (12-21).

# Hilliard to Increase Water and Sewer Rates

Hilliard Town Council The met Thursday night for their final regular meeting of August. Callahan businessman and resident Paul Schwend wished to address the council. "I just want to thank each of you for your hard work and participation with the Fireworks event," said Schwend. "We worked hard but it was a great event. Each time I visit Hilliard or the council I am greeted so warmly. It's like we are all family. It's good to see the 'westside' sticking together."

The first item was a public hearing and Second and Final Reading on Ordinance 2024-05. The Ordinance concerns the council to consider regulating the Water and Sewer Usage Rates in accordance with the Town Charter Section 4.11 (5) Action Requiring an Ordinance; and further stated in Chapter 58 Utilities of the Town Code; which states that the Town Council shall conduct annually a review of charges and fees; and water and sewer rates shall increase annually using the Municipal Cost Index.

The Public Hearing was open for public comment. Hilliard resident John Russell approached the podium. "I'm not in favor of a water/sewer increase, again. I voted against this last time too. I know other residents feel the same however, they feel as I do, that it will pass anyway," said Russell. "If you (council) allowed more corporations and companies in the town, they could help defray the cost."

"We have not turned any companies away from coming to Hilliard," said Councilman Jared Wollitz. "None of us up here like to increase any rates or taxes."

"Mr. Russell, I completely understand what you are saying. I'm sure you traveled on Pine Street when it was closed recently," said Councilman Kenny Sims. "Just that one manhole and line replacements cost \$203,000. And we have others that are

close to needing repair." "I would like for us to have another store. Callahan is getting a new COUNT Tractor Supply with two others only 15 - 20 minutes away," added Russell. "I would love another grocery store. I travel 100 miles each week to go to Walmart."

The council approved the increase.

"On the base rate of water and sewer, the average bill will only be about .50 cents more per month," added Town Clerk Lisa Purvis.

The increase will not go into effect until the October billing.

The next order of business was a presentation by Sherri Mitchell, Executive Director of the Nassau County Economic Development Board. "Thank you for making room for me on your agenda tonight. The NCEDB has been around for 30 years. We work with county leaders and local officials throughout Nassau County," said Mitchell. "Nassau County has recently been named the 7th fastest growing county in Florida, out of 67 counties. Our continued focus is Business Retention Expansion, which focuses on keeping businesses here!"

"We all see the businesses moving into Callahan but we need some and ours may be a smaller group but a necessary need for people," said Wollitz. "My parents are aging and they have to travel

to Jacksonville to have blood drawn or to an imaging center. Why can't we attract a LabCorp in Hilliard? We (Hilliard) also have two nursing homes and a mental facility. We can surely HILL use a medical facility here."

"We're a value-added service at the NCEDB. I suggest you (council and/or residents) make a wish list of businesses, industries, facilities, you would like to see in Hilliard," added Schwend, who is also on the NCEDB board.

The next agenda item, the council the Architectural approved & Engineering Services Firm of PQH Group for the Hurricane/Community Shelter Project. A workshop was set for Monday, August 26 at 6 p.m. to negotiate the cost.

The next item concerned the council approval to proceed with the Florida Commerce Rural Infrastructure Fund Grant application for the FAA Water Main Extension Project, which will cover 100% of the infrastructure needs of the project. The engineering services portion will be paid by the town's State Recovery Funds of \$200,000.

The council approved of the Capital Purchase of the Aerzen Turbo Blower & Package for the Wastewater Treatment Plant Digester in the amount of \$27,540.18. "This is a crucial part of the plant. Should one go out, we have a back-up," said Interim Public Works Director Corey Hobbs.

The council approved the request for an additional Parks & Recreation Department staff member for the new position of Program Manager. "As quickly as our programs continue to grow, I think this is a necessary employee," said Parks & Recreation Director Gabe Whittenburg. "We have several new subdivisions being built and people moving in which allows for our program to continue to grow."

The council approved the purchase of a 125' x 25' parcel located on Georgia Street at West Seventh Avenue for \$2,000. The property has a drainage ditch on it.

The council approved the Town Clerk's recommendation to fill the Administrative Assistant vacant position with Mr. Luke Headington with a starting salary of \$19.60/per hour.

The council approved a payable of \$2,500 to Cantrell Ray Real Estate, LLC, for Project Name: Acquire land on the north side of the Hilliard Airpark.

The council approved two payables to Mittaurer & Associates, Inc. for (1) Project Name: Oxford Street Force Main Rerouting in the amount of \$1,380; and (2) Project Name: WWTP Permit Renewal in the amount of \$360.

The council approved a pay request for TB Landmark Construction, Inc. for Project Name: Oxford Street Force Main Rerouting in the amount of \$26,766.25.





Late in the first half, Hilliard committed its fourth turnover on a deep heave on 4th down. The Eagles marched down the field and scored to go up 24-6 at halftime.






