Remembering History...One of Callahan's Black Schools

Our county has so much rich history and it's interesting to explore. As Nassau County students returned to school this week I felt like there was no better time to share and discuss one of the school's history in Callahan. My dear friend Earnestine Taylor dropped by the office last week all excited. Ms. Earnestine has history with the school system herself, retiring from the Nassau County School District. She wanted to let me know that the old 'colored' school building was currently being torn down and we needed a picture. Quickly, she and I went over to the school on Historical Lane, right beside Greater Mt. Pleasant Baptist Church. When we got there half of the wood framed building was already gone. She was determined to get one of her classmates for a picture in front of the building. Ms. Earnestine and her sweet friend, Doris Walker, started school in that building and went there until around 7th grade. In 1953, Pine Forest School (now Callahan Middle School) was built by the county for the black students from Callahan and Hilliard.

I went back to the office and looked for my copy of *Yesterday's Reflections II Nassau County, Florida* and started searching for the school. Much to my delight, I found it. What a wonderful book! It is full of the rich history in Nassau County. Following is just a portion of the story about the school from the book:

A schoolhouse for black children is believed to have existed here years before the Civil War. Retired black educator Doyle Arline, himself a student of local black history, purchased the property and lived there. The old school house, known as Callahan's black elementary and junior



high school, was built way before the turn into the 20th century. This was his way of helping to preserve the community's black history. There were two buildings that were once connected by a common gable roof and walkway. One side was Helen Carter's room, believed to have taught third and fourth grade. On the other side of the building was first and second grade. Grades five through nine were in the adjoining building. At the front of the upper-grades building was a concrete slab that was at one time the school cafeteria. Water was available by carrying buckets from a well on the back side of the buildings. There were about four teachers and more than one hundred students.

In a field in the rear, was where the boys played baseball. Each school day started with the different grades lining up at the flag pole near the main double doors, where they recited the Pledge to the Flag before marching to their classes. In 1953, the old school doors were closed forever as

the Pine Forest School was completed.

On Monday, I met Ms. Earnestine and Ms. Doris over by the old school. How precious it was to see those ladies so proud of the memories they shared in that school and through the years. "The school only went through the ninth grade," said Ms. Earnestine. "After that, students had to go to Jacksonville to finish high

school and graduate. When Doyle bought the property, he completely renovated the old school and always had the property looking so nice."

As young teenagers, the ladies graduated from Pine Forest School in 1956. Just last year, a historical marker was placed at Callahan Middle School to honor Pine Forest School. And just guess who the first ladies were to take the cover off of the special marker...Ms. Earnestine and Ms. Doris! They still remain close friends today and are still enjoying their lives in Callahan!

Thank you for sharing your special memories and reminding us of the rich history right here in Callahan!



Watch for School Zones!

Students in Nassau County returned to school Monday! Here are some important reminders for everyone! Plan to experience an increase in vehicles on the roads with school buses beginning their routes as early as 6 a.m. until 9 a.m.; and again in the afternoon from 1:30 p.m. until 5 p.m.

Please watch for children waiting at bus stops in the morning or walking home after school in the afternoon. Watch for buses signaling that they are preparing to stop (yellow flashing lights), or are stopped (red flashing lights) to load and unload students. Passing a stopped school bus can cost you \$271 or a visit to the judge! Parents dropping off and picking

up students will also add to the amount of traffic on the roads so please plan ahead to allow for ample time to get to your destination safely. Be aware of active school zone times and look for those flashing school zone lights.

Speeding in a school zone can cost you anywhere from \$156 up to \$456 or a visit to see the judge!

Also, remember that all school zones are considered hands free for mobile devices. Using a wireless communication device in a school zone, school crossing or a work zone will cost you \$166. Please put your phone down.

How Does God Keep Us on Track?

Chaos is a word that is used all of the time. Sometimes it is overused and spoken of in a dramatic way. These are not those times. Chaos is the order of the day. Everywhere we look, there is chaos. Every time we turn on the news, there is chaos. I have never seen anything like this before. What in the world is going on and why is there so much chaos in the world? The Bible answers this question in Romans 1:18-32. I will not quote this passage in this article, but Romans 1:18-32 reveals to us what God's judgment looks like in the present. It is interesting that Paul never speaks of meteors or hailstorms; he speaks of God handing people over to warped thinking. The result of people being handed over to warped thinking is chaos. So what I am about to say will not be popular at all, but the reason that we see so much chaos is because of God's judgment on people. These are not words that I use lightly, but I do believe that these words reflect the truth of the Scripture.

As you survey the Scriptures, there are four primary ways that God uses to keep people from living in chaos. This idea is not original to me, John MacArthur has spoken on this issue and Biblical theologians have written on this for years. So let's consider each of the four safeguards that God has built into our world to restrain evil and to promote the well-being of humanity and ultimately the Gospel. For the sake of this article, I have condensed this to bullet points, but each one of these safeguards demands our attention and careful reflection.

Safeguard #1: The human conscience. Paul speaks of the conscience in Romans 2:14-15 as God's laws written on our hearts. God has made sure that each person made in his image knows instinctively how to behave. When the conscience is suppressed or rewired in an individual's life and this is followed up on a societal level, the result will be chaos. Almost everything in our culture is assaulting the conscience and trying to convince us that wrong is right and right is wrong. This is chaos.

Safeguard #2: Marriage and the family. Humans and society cannot flourish apart from the stabilizing force of the family. The family is designed to be the primary place of religious instruction and stability in our world. When the stabilizing factor of the family is removed, chaos will ensue. When you consider the movements that are taking place all across our country, it is safe to say that this would not exist if there were stable families.

Safeguard #3: The government. Paul says that in Romans 13 that government is ordained by God to promote good and to punish evil. This is part of God's good design for human flourishing. Anarchy and the neutering of the government's ability to punish those that commit evil result in chaos.

Safeguard #4: The church. The church is the most important of all of the institutions because only the church deals with eternal realities of heaven and hell. When the church is ignored, society cannot flourish. The conscience and the government may make us moral, but only the Gospel can make us new creations and give us the forgiveness of sins.







It is a program that the sheriff's office has which will be implemented for someone perhaps that has Alzheimer's and they wander off from the home," said Beazley. "It's basically a tracking device, for that person, that comes in the form of it looks like a watch. It's about as small as a watch but it'll be on that person and so if they wander off or go missing we're able to track them with that device and we can get them back to their family as soon as possible."



have been high when they came in but after months and months of being in jail they had sobered up and I've met the real person that had been arrested and it made me see that obviously as citizens when we make mistakes it shouldn't define us for the rest of our life. So I ask myself, how can I use that when I'm out here as a detective or as a patrolman?"

Beazley met his wife (Samantha) at West Nassau High School. She was the cheerleading captain, at the time, and I was a lineman (playing football) for West Nassau Warriors. Beazley went into US Navy following high school; however, the two continued dating. While overseas, he signed to the fifth fleet for anti-terrorism force protection. After getting out of the Navy in 2007, they got married and now have two children. The children, who are 11 and 7, attend Nassau schools. Beazley followed the plan he had for his life: to graduate high school, join the military, come back to Callahan and get married and raise his family here in Nassau County. "If I wasn't a police officer, I actually think I would be on stage as a comedian or perhaps in the movies," said Beazley. "I'm often confused with Kevin James from the King of Queens, which I understand and I see that connection. But I just like making people laugh and making people feel comfortable. I think it still may be in my cards actually."

Beazley feels like in this job, it's very important to remain humanized and not allow what we deal with on a daily basis or a weekly basis to affect our personalities. "We have got to be able to connect with the public because frankly we are still the public. I try to find the best in everyone and use that motto to go by. I credit that a lot to my three years when I was working in the jail," continued Beazley. "I have seen the transformation of people who had been arrested, say on drugs, and they would come into the jail. They may


