Davis Chosen as Callahan Mayor

The Callahan Town Council met via conference calling on Monday night. The first order of business was a discussion of the Fire contract with Nassau County. At the previous meeting, the council discussed increasing the rent to Nassau County for the fire station from \$1,800 per month to \$2,100 per month. "I'm asking to increase the rent because the electric bill is now \$800-\$850 per month for them," said Council President & Fire Commissioner Ken Bass.

The council approved going ahead with the increase in the contract and sending it back to the county for approval.

In other business, the town advertised for a mayor and received two responses. Both gentlemen were at town hall during the meeting. They were: Matthew Davis; and former Mayor Bobby Rau. Both presented resumes for the council to look over. Councilman Bass introduced Matthew Davis as a Callahan business owner and of course resident. "I called Mr. Davis on the phone today and we had a lengthy conversation," said Councilwoman Shirley Graham. "He seems very enthusiastic about the job and the opportunity to serve. He also has some ideas concerning growth here in Callahan."

"How much time do you think you could give us (the town)?" asked Bass.

"I am very flexible and feel I can be available whenever I'm needed," said Davis.

Bass introduced Rau as the former mayor and asked for questions from the council. "Do you plan on keeping your current job?" asked Graham.

"At this time I plan to," answered Rau. "I love the town of Callahan. If I didn't I wouldn't live here. Maybe we could visit new directions for the town."

Bass asked, "What's the pleasure of the council?"

"I make a motion to appoint Matthew Davis as Interim Mayor," said Graham.

The motion was seconded by Councilman David Mellecker followed by a unanimous vote by the council to appoint Matthew Davis as Interim Mayor.


"I like Bobby Rau a lot but I don't feel like he got things done as Mayor," added Graham.

The council approved having a special meeting Monday, August 10 at 7 p.m. to swear in Mr. Davis.

Town Manager Mike Williams advised the council about the town receiving one of the two FERDAP Grants that were applied for. "We (the town) submitted two grant applications, both for Depot Park," said Williams. "We could only have one open grant per park so we got one grant worth \$50,000 for Depot Park. This will allow us to start on Phase I of Depot Park. We can apply for another one next year."

Williams also advised the council that Governor DeSantis has extended the State of Emergency until September 1, meaning our meetings will continue by conference calls.

A special meeting of the council will be held Monday, August 10 at 7 p.m. to swear in the new Interim Mayor. The next regular meeting will be Monday, August 17 at 7 p.m.



Remembering Becky Jordi

Rebecca 'Becky' Lynn Jordi, 66, passed away July 31, 2020, after a courageous battle with cancer. A private service will be held for the immediate family. A Celebration of Life service will be held this fall to coincide with the dedication of the new Extension Building on Miner Road which will bear her name.

She found her calling as an Extension Agent for the University of Florida here in Nassau County. It was here Becky thrived, starting as the Horticulture Agent, achieving certification with the International Society of Arborists, and becoming the Nassau County Extension Director.

Rebecca initiated many projects including the Demonstration Gardens at the Governmental Complex and the Yulee office; Landscape Matters; Crash Course on Gardening; Garden Talk; and many clinics on native plants, birds, rain barrels, herbs, and her beloved citrus. The Master Gardener program has thrived under her leadership, with many of them tirelessly serving the community with science-based knowledge gained through IFAS/UF. She was often a feature speaker during the Home and Garden shows at Epcot, and did occasional TV appearances on WTLV 12 First Coast Living.

Her many awards include the Florida Association of Natural Resources Master Gardener Professionals-Mid Career Leadership Award; Florida Nassau Extension Director and author Rebecca Jordi, and Master Gardener volunteer Carol Ann Atwood, all hold Jordi's newly-released book, for Excellence Team Award, *Zoe's Mission*.

National Finalist; National Finalist in Landscape Horticulture; Computerized Graphic Presentation Silver Award; and Extension Professional Association Young Professional of the Year.

One of her greatest achievements is seeing her children's book "Zoe's Mission" published, which was illustrated by local artist and Master Gardener Joanne Roach.

Becky had a passion for her job and truly loved what she did and you could see it in her many awards. Even through her illness she strived to continue her work and did it well. With her

knowledge she expanded the extension office.

Our thoughts and prayers are with her family and her extension family during this difficult time. Fish Talk

Flounder Talk

I'm guessing by now you probably have your dove fields planted and are awaiting opening day. Or, maybe you are doing the last minute work in the hunting club. For some reason, I always wait until the hottest months to prepare for deer season. By the time the actual season rolls around, it's so hot that I'd rather just stay home! That is unless I hear the fish are biting.

Well, that's just what happened this past weekend. We had a hunch so we tried to beat the storm. Although there weren't many effects from this system, the pressure dropped just enough to turn the bite on. We made it our mission to find where the flounder were holding. Starting at the jetties, we moved inland fishing everywhere we could find rock structure. It wasn't long before we found that perfect balance where flounder were holding. The water wasn't dirty nor clean but had just the right clarity. We had approximately three feet of visibility which is great for predatory fish feeding from the bottom. There we found the right bait and the perfect tidal flow.



We used plastics for search baits to begin with then, switched up to live mullet after a couple of decent fish. It didn't take long to find some really solid flounder. They were lying just outside of the structure and were hammering our baits when we presented them properly. The bite tapered off after about an hour but not before we landed seven solid fish.

The moral of the story is, those prefrontal systems will many times bring the big fish out of hiding. So check the forecast and get in on the action. Also, if I haven't said it enough, the St. Johns River is loaded with good quality fish. Look for that to only get better as we move toward the end of August and into September.



The Gospel

In Southern Greece, there is a city called Corinth. Almost 2,000 years ago the Apostle Paul wrote a series of letters to the church in this city; two of which are preserved in the Bible called 1st and 2nd Corinthians. If I were to describe this church, I would use the words "Hot Mess."

Here are some of the problems that were going on in this church: Division based on allegiance to Paul, Apollos, Peter, and Christ; Puffed up (prideful) (1 Corinthians 4:6); Rejecting authority; Self-deception (1 Corinthians 3:18); Division between license and legalism (1 Corinthians 8); Christians suing each other in secular court; Patronizing prostitutes; Participating in ceremonial meals of pagan cults; One man was even sleeping with his father's wife (1 Corinthians 5:1)

They had gone as far to resent Paul, the other apostles, and the Gospel itself. They thought he was simple and lacked wisdom. So how does Paul handle all of this? He reminds them how he came to them: "When I came to you, brothers and sisters, I did not come with superior eloquence or wisdom as I proclaimed the testimony of God. For I decided to be concerned about nothing among you except Jesus Christ, and him crucified. And I was with you in weakness and in fear and with much trembling. My conversation and my preaching were not with persuasive words of wisdom, but with a demonstration of the Spirit and of power, so that your faith would not be based on human wisdom but on the power of God." 1 Corinthians 2:1-5 (ESV)

Paul came with the simple truth of the Gospel. Paul knows it is this Gospel (Good News) that saved them several years earlier. And that it is this same Good News that will rescue this church from all the problems it is experiencing now.

I believe that on either side of any of the issues we face in our country today (and there are a lot of them), both sides would agree, we are a "Hot Mess." The solution to every problem we face is the Good News of Jesus Christ. The Gospel is not just for saving people from hell (although praise God that it does); it is for daily application in our lives.

I love how 22-year-old Jonathan Isaac, NBA Orlando magic player, put it. When asked why he was the only player on all the teams that didn't kneel for the National Anthem, he used the opportunity to present the Gospel as the answer to it all: "I think when you look around, racism isn't the only thing that plagues our society, that plagues our nation, that plagues our world, and I feel like coming together on that message that we want to get past not only racism but everything that plagues our society," Jonathan Isaac said. "The answer to it is the gospel."

What is this Good News that Paul and Jonathan Isaac are talking about? It is that even though every one of us has broken our relationship with our Creator through sin; He has made a way to restore our broken relationship. Jesus Christ took our place of punishment so that we can have right relationship with God. On the cross, He took our sin. And because He rose on the third day we too, will rise to be with Him on our last day if we have received what He is offering us. Have you accepted Jesus' offer? Election COVID-19 Preparations for Voting, Polling Place Changes

We are nearing August 18th Primary Election Day with early voting beginning on August 3, 2020. My colleagues have gone above and beyond the call of duty to prepare for the upcoming elections. I am deeply grateful for the commitment they have to the citizens of Nassau County and our nation! Likewise, although many of our election workers are not able to work during the pandemic and we support their decisions wholeheartedly, we are also deeply grateful for the election workers and county employees who have committed to working during early voting and on Election Day.

By now, all registered voters in Nassau County should have received a new Voter Information Card and a Sample Ballot in the mail. It is important to make sure the voter information in the official mailings from our office are accurate and, if not, contact our office as soon as possible to ensure that you have no delays in receiving your Vote by Mail ballot, if requested, or when voting in-person during early voting and on Election Day.

COVID-19 SUPPLIES AND PREPARATIONS:

Election Workers will:

- Have their temperatures taken and answer questions upon arrival as recommended by guidelines
- Wear face shields or face masks and gloves (when needed)
- Have hand sanitizer at their stations and will wash their hands and clean surfaces regularly
- Voting booths will be cleaned after each use and will have a "reserved" sign to provide social distancing between the booths

Air Purifier machines will be running throughout the day (and evening during early voting)

Voters will be provided:

- A face mask and gloves, if requested, and hand sanitizer before entering the polling room and at various stations during the voting process
- A disposable cotton tipped wooden stick to sign the signature pad

- A secrecy sleeve if requested

Everyone in the polling room will be requested to keep conversations to a minimum for the protection of all. To show your appreciation, give the dedicated election workers of Nassau County a "thumbs up."

ACCESSIBLE SAMPLE BALLOT:

An accessible sample ballot is available at www.VoteNassau.com. Although a local news station recently reported that Nassau County was directed to provide an accessible ballot as a result of a recent lawsuit, our county had an accessible ballot for the 2020 Presidential Preference Primary election and had a contract in place for a new online ballot delivery system for persons with disabilities (once it was certified) even prior to the lawsuit. The new system was certified by the Florida Division of Elections on July 14, 2020 and will be implemented for the November 3rd General Election. Five counties in Florida, including Nassau County, volunteered to be pilot counties for Florida. Should any voter need assistance now or in the future, email access@votenassau.com or call 904.491.7500 or TDD 904.491.7510 for assistance.

POLLING PLACE CHANGES:

As a result of losing five polling places due to 2019 legislative changes and due to the limited number of election workers available to work in the upcoming elections, we consolidated polling places and are using school gyms and large facilities to allow for social distancing for voters who wish to vote in-person. Most locations are landmarks (schools, community centers, etc.) and, therefore, easy to locate. Prior to the 2022 Gubernatorial Election cycle, the county will have completed the redistricting process and precinct boundaries and polling places will be changed as a result. All voters will then receive a new voter information card in preparation for the 2022 elections.

• **TRACK MY BALLOT:** If you requested a Vote by Mail ballot, you can track it online and it will show the following: Requested, Sent, Received and Counted. Once the status of your ballot displays as "Counted" it will confirm that you had no voter errors and your ballot will be counted for the election. If there is a voter error, it will display as "Received" with a message below and instructions on how to cure the voter error.

• **EARLY VOTING LOCATIONS AND STATUS:** All voters can vote at any of the five early voting locations. Early voting locations, dates, times and even wait times are displayed at this link.

• **BALLOT DROP BOX LOCATIONS:** A list of all drop box locations and information.

• **FIND MY POLLING PLACE:** Before or on Election Day, make sure you know where your polling place is located. Florida law requires that you vote in your assigned polling place on Election Day.

• And much more!

RECAP OF PRIMARY ELECTION BALLOT FROM PREVIOUS PRESS RELEASE:

• **BALLOT STYLES:** In a primary election, your ballot style is based on your residential address and your party affiliation. Every voter will receive a ballot with the same races, except for the Republican ballot style which will have one additional race: Representative in Congress, District 4.

• **REPRESENTATIVE IN CONGRESS, DISTRICT 4 RACE:** In order to vote in this race, a voter must be registered as Republican. The deadline to change party affiliation for this election was July 20, 2020. The Republican candidate who receives a majority of the votes will face a Democratic and write-in candidate in the General Election.

• **UNIVERSAL PRIMARY CONTESTS:**

There are seven (7) races that are Universal Primary Contests on the ballot. This means that candidates with the same party affiliation qualified for the seat and, because there were no other candidates to face in the General Election, all registered voters in Nassau County are eligible to vote in these races. The candidate with the highest number of votes in the Primary Election will be elected to the seat.

• **DISTRICT RACES:** In Nassau County, the County Commission, School Board and Ocean, Highway and Port Authority are at large districts. This means that all registered voters in the county are eligible to vote in all district races. Provided your address is correct in your voter record, you are eligible to vote for any contest on your ballot. You will never be issued a ballot with a race for which you are not eligible to vote.

• **NONPARTISAN RACES (COUNTY JUDGE AND SCHOOL BOARD):** The following nonpartisan races are on the ballot:

• **County Judge:** There are four candidates in this race. If one candidate does not receive a majority of the votes (50% plus 1 vote) in the primary election, the two candidates with the highest number of votes will be on the ballot in the General Election.

• **School Board:** There are only two candidates in this race. Therefore, the race will be decided in the Primary Election and will not be on the General Election ballot. The candidate with a majority of the votes will win.



All devices that are removable or transmit data should be inspected/replaced periodically to ensure that voter data is not compromised. I would expand the camera surveillance system to enhance security. Other key issues include: 1. Federal lawsuits aimed at expanding "vote by mail" - sending ballots to all voters regardless of whether they requested these ballots. I am opposed to this policy and will lend my voice if elected to serve to offer the reasons why this should NOT be permitted. 2. Federal lawsuits aimed at "ballot harvesting" - to allow an expansion of current state law to authorize more people to pick up "vote by mail" ballots. I am opposed to this change. The handling of ballots should be restricted to prevent election fraud. 3. Infection Control - with COVID19 we will need to consider safe, smart methods to maintain voting facilities that prevent infection and allow voters the confidence to early vote and to vote on election day. Because of my healthcare experience, I have the necessary skills to address this challenge and keep our voters safe.

Goals: Maintaining the public trust is the highest priority. Helping our veterans, seniors, disabled and citizens register to vote, find their voting location, resolving their eligibility questions, and keeping the voters informed are core responsibility of SOE. Courts, where he has spent the past 7 1/2 years.



- A gallon of water per person per day—minimum of a 3-day supply

- Hand sanitizer and disinfectant wipes
- Personal hygiene supplies: soap, shampoo, toothpaste/brush, feminine products
- Battery chargers for electronics
- Battery or hand-crank radio
- Manual can opener
- Flashlights and/or lanterns plus extra batteries
- First aid supplies
- Prescription medications—minimum 7-day supply
- Don't forget your pets' water, food and supplies
