Commissioners Vote to Reduce Tax Rate

At the Monday, September 13, 2021 meeting, the Board of County Commissioners unanimously voted to lower the property tax rate and invest in our quality of life by delivering big on road, park and public safety projects.

Chairman Thomas Ford stated, "I am very proud of this Board for its in-depth review of the budget. We have worked hard to fund programs and initiatives that improve the quality of life for our residents. We have been given an opportunity to take some burden off the taxpayers by lowering the millage rate, while still having the funds needed to accomplish our goals for the next budget year."

The tentative budget includes a robust, Capital Improvement Plan with \$33 million allocated for major projects/initiatives in Fiscal Year 2021/2022, including but not limited to: 1) \$6.2 million allocation for Parks and Recreation Projects: Hilliard Ballpark improvements for new playground installation; Improvements at Holly Point Boat Ramp: Improvements at Melton Nelson Boat ramp; Tributary Community Park Phase One development which includes amenities for ballfields, concession stand, walking trails, and playground; Blackrock Cove Community Park Development for site furnishings such as soccer goals, trash receptacles and parking lot lighting; and Nassau Crossing Community Park Development which includes lighting and landscaping; American Beach Historic Park (exact activities to be determined).

2) \$900,000 allocation for the Double Chip Seal Program. Double chip seal is a paving alternative used to treat dirt roads. It is similar to asphalt but about 50% cheaper. Roads designated for Double Chip Seal include: Midway Rd.; Hagan Lane; Plum Loop; Pirates Bluff Rd.; Will Young Rd.; Durden Rd.; Winona Bayview Rd.; DB Hicks; Sheri Lane; Ann Drive; Parks Rd.; Lance Rd.; Roy Booth Rd.; and Marlee Rd.

3) \$3.9 million allocation for the Pavement Management Plan that will allow 27 of the worst roads in Nassau County to be repaved. The roads to be repaved, in full or part, next year are: Will Hardee Rd.; South 4th Street; Susan Drive; South 5th Street; Magnolia Street; Clinch Drive; Ocean Forest Drive; Bonnieview Rd.; O'Neil Scott Rd.; Greenberry Rd.; Hendricks Rd.; Ocean Forest Lane; Cayman Circle; Arbor Lane; Barnwell Rd.; Bailey Rd.; Benchmark Ave.; Dove Rd.; Roses Bluff Rd.; Duane Rd.; Harts Road South; Harts Lane; Bill Johnson Rd.; County Road 121 (from Duval line to SR2); Musselwhite Rd.; Charlotte Drive; and Thomas Rd.

4) \$15.3 million allocation for projects: transportation Amelia Island Parkway and Buccaneer Trail roundabout design; Amelia Island Trail design (from South Fletcher Ave. to State Road 200/8th Street); Citrona Drive pedestrian safety improvements; County Road 108 repaying from Bay Rd. to Middle Rd.; County Road 108 repaving from Middle Rd. to US 17; Hendricks Rd. Extension to County Road 107 design and permitting; Hendricks Rd. Extension to Amelia Concourse design and permitting; Pages Dairy/Chester Rd. Signalization; Sunberg Rd. paving; William Burgess Blvd. Extension design, permitting and early construction from U.S. 17 to Miner Rd.

5) \$3 million allocation to replace Fire Station 90 in Hilliard.

Traffic Light at Mickler Street?

The Callahan Town Council met Monday night for their final meeting of September. The first order of business was the Final Reading and Public Hearing on Resolution 2021-R09. The resolution concerned setting the millage rate at 2.2799 for Fiscal Year 2021-2022. The council approved the resolution. Also, the Final Reading and Public Hearing on Resolution 2021-R10 was approved which was to set the Budget for Fiscal Year 2021-2022 at \$7,865,319.00.

The council also discussed making a donation to the Nassau County Council on Aging as they (council) have never donated to the organization before. The council approved donating \$500.

In closing comments, Councilwoman Ashton Bishop Vargas advised the council that after months of studies and emails, the Florida Department of Transportation has approved placing a traffic light on US 301 at Mickler Street. "I'm very excited to see this email. However, the email also says that the process can go through 3 stages," said Vargas. "So this could be sometime before it happens but it has been approved. It is definitely needed!" Councilwoman Janet Shaw advised the council that the CSX property on the corner of Mickler and Brandies Avenue looks horrible. "Today I saw them placing a huge pile of broken up concrete on the property," said Shaw. "Isn't there something we can do to get them to clean it up?"

"The Code Enforcement Officer will send them a letter of compliance to clean it up," said Town Manager Mike Williams. "We'll see what happens after that."

"I'm also concerned about the retention ponds in town. Have they been directed to the Code Enforcement Officer to clean them up?" said Shaw.

"Yes they have and some of them have cleaned up a little," said Williams.

"Last but not least, I want us (town) to get our Christmas decorations up before the parade this year. Is that possible?" asked Shaw.

"It would be however FPL has put up almost all new poles in town and of course all our straps and connections are gone," said Williams. "We have been getting supplies together to get the decorations up as soon as we can."

The next meeting of the council will be Monday, October 4 at 7 p.m.



Hilliard Town News

The Hilliard Town Council met Thursday night for their final meeting of September. The first order of business was the Public Hearing and First Reading on Ordinance 2021-07. The ordinance concerned setting the Tax Millage Rate for Fiscal Year 2021-2022 at the roll back rate of 2.3554 mills. The council approved the rate. The next item was the Public Hearing and First Reading on Ordinance 2021-08 which concerned setting the Fiscal Year 2021-2022 budget at \$8,955,660.00. The council approved the amount. The final reading was set for Monday, October 4 at 7 p.m. for both ordinances.

The council approved the payable to Mittauer & Associates, Inc. of \$1,500 for the Oxford Park Drainage Improvements project.

The council also approved a payment for Southeast Pump Specialist in the amount of \$5,126.38 for the purchase of the Wetland Pump. The council approved a payable for Sunbelt Rentals of a bypass pump on Fourth Street for a period of 4 weeks at a total cost of \$6,345.44. The rental will continue until the Gravity Sewer Pipe Project is in service.

The next item, a payable to Smart Quality Lawn Care (bid winner for the yearly mowing contract) of \$5,500 for the month was approved with discussion. Councilman Jared Wollitz brought some of the mowing areas to the council's attention. "I've seen places where the grass and weeds are so tall," said Wollitz. "I don't know if any of you (council) have ridden around and checked things out but we need to.

I don't know who's watching them or what's happening."

"I've tried to keep up with it. We worked out zones to mow to make it easier. When he (Smart) got a zone finished I would go see it," said Public Works Director Ritchie Rowe. "Now he just mows here & there."

"I know last year they did a great job," said Councilman Kenny Sims. "Perhaps he is having personnel problems, which that is not our problem. We'll approve the payment this time but get with him and see what is going on."

Mrs. Tracy Lucas, W 3rd Avenue, Hilliard, addressed the council. "I sent out an email to the office staff and the entire council and I hope you have all have had a chance to read it. It seems every time we are ready to get our permit for our building, we have to do something else," said Lucas. "I really need a decision made on this by Tuesday by 2 p.m. We have done everything on the list that we were supposed to however each time we come to get the permit, there is something else. This is our fourth attempt to get this done."

"I would like to think that there should not be another issue but I would like to be cc'd on the email of what's happening with this issue," said Sims.

"I think we should have a workshop on this to find out what and where the problem is," said Councilwoman Callie Bishop. "I also would like to be cc'd on the email of the progress of this permit."

"Me also," added Councilman Lee Pickett.

The next meeting of the council will be Thursday, October 2 at 7 p.m.
