## A Community Mourns the Loss of NCSO Deputy Joshua Moyers

## Suspect Captured After Five Day Manhunt



Last Friday, our town, our community was turned upside down. As news stations began to share the news about a shooting involving a Nassau County Sheriff's Office deputy, Friday became a day filled with sorrow, fear and anger. According to the NCSO reports, Deputy Joshua Moyers was dispatched to a call on US 301 out of Callahan around 2:30 a.m. While enroute, he was distracted by a van and pulled the vehicle over at Sandy Ford Road. Moyers called

in the tag number and left his vehicle to get the driver's information. The male driver gave a name and said he didn't have a driver's license. Moyers went back to his vehicle to call in the information and call for back up as there was also a female passenger.

Information from dispatch revealed that the vehicle was stolen from Jacksonville and that the driver wasn't who he said

As Moyers returned to the suspect's vehicle, he asked the driver to step out of the vehicle. As Moyers reached for the handle to open the door, the driver, now known as Patrick McDowell, raised his right hand out the window and shot the deputy in the face. As he fell to the ground, McDowell shot Moyers in the back. At this time, a train was coming



and the vehicle sped

up to respond.

How quickly a simple traffic stop turned into a horrible situation. Moyers was transported to UF Health trauma center in critical condition. **NCSO** deputies continued their pursuit of the suspect down Sandy Ford Road where they found the vehicle abandoned. After a search with canines, the passenger, a

woman, revealed herself from hiding under a shed. She cooperated with NCSO by giving officers the driver's name and information. It was then that an all-out manhunt began. Agencies from all over, including the FBI, FHP, ATF and several surrounding county agencies continued to thoroughly search the area on foot, with ATVs, helicopters, additional K9s and drones.

A staging area was set up at Callahan First Baptist Church. Early Saturday morning, a food truck owner and a group of volunteers met at the church and began serving meals to the crews. The community has been amazing with the outpouring of food, snacks, drinks, water, etc., for the officers. Local restaurants provided meals. The Callahan First Baptist Family Life Center was quickly turned into a staging area where there were tables, restrooms and air conditioning. We are so blessed to live in such a loving and giving community. Gratitude goes out to Callahan First Baptist for graciously providing their building and resources, food and volunteers.

On Sunday, September 26, Deputy Joshua Moyers passed away. A reward of \$54,000 was offered to anyone who had information leading to the arrest and conviction of Patrick McDowell.






## A Community Mourns

On July 14, 2018 Deputy Moyers received an ABCD Award for going 'Above and the Beyond the Call of Duty' on a Narcotics case. He was known for his proactive police work, good attitude and hard work. Deputy Moyers was engaged to be married.


## CAPTURED!

Tuesday, September 28 around 1:30 p.m. Patrick McDowell was captured at the Kirsten Higginbotham Sports Complex in Callahan. Deputies surrounded the restroom facility at the ballpark. They called out his name and he surrendered. "He crawled out of the restroom, like the coward he is. McDowell didn't obey orders completely and a canine were released on him again," said NCSO Sheriff Leeper. "It was then that he was handcuffed with Deputy Moyers handcuffs."

Deputies had zeroed in on the area of the Callahan sports complex, but were later led to him. According to the Nassau County Sheriff's Office reports, Monday, September 27 the suspect, Patrick McDowell, contacted Breiana Elizabeth Tole, 27, of Jacksonville.







Tuesday, September 28, after further investigation, Tole attempted to aid Patrick McDowell by removing him from the ballpark area. At that time, Breiana Tole knew that McDowell had committed the murder and came to his location with the intent that McDowell avoid or escape detection, arrest, trial or punishment. Tole was placed under arrest and transported to the Nassau County Detention Facility charged with Felony Accessory After the Fact.

## Keep Nassau Beautiful Hosts Free Tree Drive-through Events

Proof of Nassau County Residency and Pre-Reservation Required



Beginning Saturday, October 2 and on alternating Saturdays in October, Nassau Beautiful (KNB) volunteers and partner organizations will be holding three free-tree drivethrough events where residents will pick-up one or two free trees to be planted in Nassau County.

Individuals, businesses and organizations may reserve free trees by completing these easy steps; Review UF/ IFAS tree fact sheets for the available species and view an educational video. Once the online learning is complete residents will be ready to complete the Free Tree Reservation form to select their preferred tree species and pick-up location. Completion of the reservation

form is required 72 hours prior to the drive-through event. Nassau County proof of residency and completion of the reservation form is required the day of the event to pick up one or two of our 3-gallon size trees. Residents are also asked to help the tree get its best chance at a healthy long life by following a watering schedule until the tree gets established.

Free tree drive-through events are scheduled as follows: Callahan: Saturday, Oct. 2; Yulee: Saturday, Oct. 16; and Fernandina Beach: Saturday, Oct. 30. All events will be held between 9 a.m. – 11a.m. Details and reservation form at https://keepnassaubeautiful.org/ news-andevents/.

The project is being generously funded through dedicated grants, fundraising activities and private donations. Liberty Landscape Supply sponsors the supply of the 4-species of trees for the drive-through events.

Looking back, I'm thankful I took the position at LaVilla.

It has also made me appreciate being a mom even more than I did

before. One of my fondest LaVilla memories is from December 2019 (before the school shutdowns caused by Covid-19) when Thelma, my mother-inlaw, Stan, my husband, and other relatives attended Hayden's first orchestra concert as a sixth grader. We enjoyed hearing her play cello with her school orchestra.



Now, I'm thankful I took the position at LaVilla. Doing so has stretched me and made me a better teacher. I've also modeled a willingness to try new things for my family.

Another change I made more than ten years ago was establishing a community writing group here in Callahan. I participated in writing groups in cities where I lived in the past, and they were wonderful. So, I wondered if a creative writing group would fly in Callahan. Naysayers who told me no one would come were plentiful, but the group has flourished for the past 11 years.

Starting the writing group moved

me out of a rut and helped me adjust from city life to country life in a positive way. It also provided a space and a place for more creativity in my life and in the lives of attendees.

Finally, another change I made involves my reading preferences. I try to read my Bible early every morning during my devotional time, but for many years,

fiction served as my pleasure reading genre of choice. Of course, there's nothing wrong with fiction. Some compelling fiction titles I've read this year are "Jane Eyre" by Charlotte Bronte, "The Four Winds" by Kristin Hannah, and "The Only Woman in the Room" by Marie Benedict. Characters and plots may be made up, but through fiction, we can enter other worlds and empathize with characters' problems and

situations. That being said, a few years ago I chose to leave my 'fiction rut' and expand my reading choices. I read more non-fiction, poetry, and drama. Right now, I'm reading "The Power of Writing It Down" by Allison Fallon. In the book, Fallon shares how the simple act of writing down your thoughts for 10 to 15 minutes a day can help you clear mental clutter and find your unique voice. I highly recommend this book to everyone.

I'm also reading "The Collected Poems of Emily Dickinson," which is a book my mom gave me. I've been writing poems in Dickinson's style as a result, and it has been so much fun.

I encourage you to step back and examine your daily habits. Are you stuck in any ruts? If so, know you have the power to change, leave the ruts, and travel new roads.

One way Stan does this is by learning new things from YouTube videos. He just watched one on window tinting and another on how automobile automatic transmissions work. Together, we like to try new restaurants, take walks or bike ride in parks near and far, and meet new people.

We also try to pause a few times a week as a family to verbalize what we are thankful for. Being grateful for our blessings helps us keep things in perspective and remain open to ways God may want to use us to impact others. He created us in His image to glorify Him, not to stay stuck in ruts of our own making!



## A Privilege to Serve

On Saturday, September 18, 2021, reinternment services were conducted for Lt. General Nathan Bedford Forrest and his wife, Maryann Montgomery Forrest at "Elm Springs," the National Headquarters of the Sons of Confederate Veterans in Columbia, Tennessee. Two days of visitation were held prior to the service, with visitors respectfully passing the caskets of the General and his wife. A rotating, four-man Honor Guard posted the front and rear doors of Elm Springs, as well as at the head and foot of the caskets. This Guard was changed hourly, around the clock, up until the time of the service at 10 a.m. on Saturday morning. I am proud to say that I was one of the 80 men chosen from throughout the SCV for this duty, along with another Kirby Smith Camp 1209 member, Chris Elands.

On Friday, Elands, myself and two other men were assigned the duty from 4-5 p.m., busy in that many visitors

came through Elm Springs paying their respects to one of the greatest Calvary Officers in Military history. I then had a break, but returned for another duty from 3-4 a.m. The home was closed during this time. I felt that not only had I been given a rare opportunity to honor the General and his wife in serving as Honor Guard, but in some way was experiencing a piece of history that few people would ever know. During that hour the hall was illuminated only by the overhead chandelier. I was posted at the head of the General's flag draped casket, while another man was posted at the foot of Mrs. Forrest's casket. During the entire hour, not a word was spoken, not a sound was made. Alone with my thoughts, thinking only about this man and those who rode and fought with him. Shortly before my shift ended, I rested my left hand on the edge of the casket and just thought about how close I was to a part of history.

"Opioid abuse is becoming more and more prevalent in our community," said Prince Danso-Odei, MD, DrPH, MPH, FDOH-Nassau Administrator. "Our prevention and treatment messaging is prominent on NassauTRANSIT's buses, and we appreciate the opportunity to get the word out in our county."

"We are extremely proud to partner with Nassau's Health Department on this important initiative," said Janice Ancrum, NCCOA President & CEO. "It is a critical message for people of all ages, and we are happy to help with publicity throughout Nassau County."

"We are glad this collaboration will help raise awareness about opioid use within the county as a response to our increasing needs," said Ray Richardson, MSW Community Prevention Coordinator; while Lee Anne Stephens, BSN RN Youth Prevention Coordinator said, "It is exciting for our community to be able to learn about opioid/substance use and we thank NassauTRANSIT for their partnership to make this possible."


# CONNER'S A-MAIZE-ING ACRES OPENS SATURDAY

## Operation Behind the Tracks

During the month of June 2021, the Nassau County Sheriff's Office received numerous complaints about several drug houses being operated off of Oneil-Scott Road Fernandina Beach. The Nassau County Narcotics Unit, which consists of deputies from the Nassau County Sheriff's Office and officers from Fernandina Beach Police Department, began formulating a plan of action to initiate a narcotics investigation in that area based off the information received from complaints. During the investigation detectives were able to develop sale of cocaine charges on several narcotic suppliers from Oneil-Scott Road.

On September 15, 2021, the Nassau County Narcotics Unit, along with members from the Florida Highway Patrol, Bureau of Alcohol, Tobacco and Firearms, U.S. Customs and Border Protection, NCSO and FBPD conducted a narcotics operation that consisted of locating and arresting several suspects with active arrest warrants in the Oneil-Scott Road area. During the operation six suspects were arrested for charges involving both sales and

possession of cocaine. "The people who were involved in this operation are drug dealers and repeat offenders," said Sheriff Bill Leeper. "We see the destruction that these illegal narcotics reek on the homes, individuals and families within our communities. If you have knowledge of someone dealing illegal drugs within Nassau County please let us know."

The Voter Participation Center and the Center for Voter Information are thirdparty nongovernmental organizations and are not affiliated with the Nassau County Elections office. The Nassau County Elections Office has not printed, distributed, nor provided the data used in these mail pieces. The Florida Association of Supervisors of Elections (FSASE) submitted a letter of concern to both agencies expressing concern regarding the incorrect data used in these mailings, which have created confusion and distrust in elections in the past. "These ongoing misleading and inaccurate mailings from the VPC and CVI continue to erode voter confidence and increase suspicion, mistrust, and anger among Florida voters," states Wesley Wilcox, Marion County Supervisor of Elections and President of the FSASE.



## **Flashes Roll Past Raiders**

Fresh off of a defensive duel on Monday night to remain unbeaten, the Hilliard Flashes continued their three-game road trip to take on the Crescent City Raiders. The last time these two teams squared off was in 2016 with the Flashes winning.

The Raiders won the coin toss and received the opening kickoff, gashing the Flashes kickoff team inside their own 45 yard line. The positive momentum didn't last very long because the Flashes defense created a turnover when Walker Avera forced and recovered his own fumble, setting the Flashes offense up at their own 30. The offense went right to work using explosive plays from the ground game that led to Avera being punched into the end zone for a 2-yard score. With the extra point missed, the Flashes sprung out to an early 6-0 lead. The momentum kept on rolling for the Flashes as Avera channeled a heat seeking missile and sprinted straight to the punter untouched to block the kick and set up the offense with prime real estate at the Raider 20 vard line. On the ensuing play, the Flashes took full advantage of the big play on special teams thanks to DJ Coston

gliding through the Raider defense untouched for a 20-yard touchdown run. After the extra point was missed, the Flashes stretched the lead out a little further to 12-0. But, the Raiders would answer the call by relying on special teams for an 80-yard kick six. The extra point was good and the Raiders were on the board 12-7. The Flashes answered back using the offense to march methodically down the field. The drive was then

capped off with another touchdown when Lyle Bennett connected with Seth Moore on a flat route for a 10-yard score. And at the end of the first quarter, the Flashes emerged with a healthy 20-7 lead.

It was much more of the same in the second quarter, this time the Flashes used their defense to keep the momentum rolling. Coming off the edge, Tucker Pickett bolted for the quarterback and forced an erratic throw that was intercepted by Bradyn Matto who navigated through the Raider offense for a 54-yard pick six. With the failed 2-point conversion, the Flashes extended the lead 26-7. But, the Raiders were able to respond with a scoring drive of their



own, this time using the aerial attack to do it with a 49-yard touchdown pass. With the extra point good, the Raiders began to claw back into the game cutting the deficit down to 26-14. However, the Flashes dumped a bucket of water on the momentum the Raiders were beginning to form and they used a combination of both the offense and defense to do so. On defense, the Flashes found themselves pinned inside their own goal line. But, the Raiders had no answer for Pickett as he came free off the edge and forced another bad pass that was intercepted by Avera. The Flashes capitalized on the turnover when Coston shredded through Raider defenders for a 22-yard touchdown run. With a successful 2-point conversion, the Flashes went into halftime with a healthy 34-14 lead.

It was more of the same in the third quarter. The Flashes began the quarter with the football and continued to roll with help from Avera as he cruised into the end zone untouched thanks to textbook blocking from the line for a 3-yard touchdown run. With the 2-point conversion good, the Flashes continued to fertilize their lead to 42-14. But, then the Raiders were able to answer with a scoring drive of their own with a 2-yard touchdown run. With the extra point good, the Raiders cut into the deficit a little more with the score being 42-21 at the end of the quarter.

There was not much offense to

document from both teams. However, the Flashes defense was able to force two more turnovers before the game finished. First, it was Avera coming off a blitz in the red zone and forced another erratic throw that was in the waiting arms of Damon Kibler. Then, in garbage time, the Raiders had an issue with the handoff as their ball carrier played hot potato with the pigskin and was recovered by Brandon Matthews. And as the game concluded, the Flashes emerged victorious on the road with a 42-21 victory over the Raiders to improve their record to 5-0.

The Flashes offense had their way with the Raiders defense, gashing them with 227 yards rushing and putting up 374 yards of total offense. Lyle Bennett went 10/15 for 147 yards and a touchdown and a carry for 10 yards; DJ Coston had 13 carries for 115 yards and 2 touchdowns; Walker Avera had 10 carries for 46 yards and 2 touchdowns; and Braydon Holley had 7 carries for 57 yards. On the receiving end were the Coston brothers with Dylan having 4 catches for 62 yards; and DJ having 3 catches for 39 yards; Bradyn Matto had 2 catches for 36 yards; and Seth Moore caught the touchdown pass from 10 yards out.

Defensively, it was a living nightmare for the Raiders as the Flashes forced 5 turnovers and a blocked punt. Walker Avera had 5 tackles, an interception, a forced fumble and fumble recovery; Klayton Bright had 5 tackles and a pass breakup; Damon Kibler had 4 tackles and an interception; Carson Newkirk and Ricky Vining each had 3 tackles. Brandon Matthews had a fumble recovery; Bradyn Matto had the pick six in the 2nd quarter; Brogan Johns and Angelo Benjamin each shared a pass breakup; and Tucker Pickett had 2 quarterback pressures.

The Hilliard Flashes have a bye this week, but return to action next week (Thursday, October 7) to face the Providence Stallions on the road with a 7 p.m. kickoff.
