David Thompson came to the office and told us what was happening. My heart sank. Fear struck through every part of my body as the joy I had just experienced quickly turned to sadness and panic. How are my children, my parents and my sister flying to Texas on Tuesday? So many questions going through my mind... it was horrible. Immediately, churches throughout our area and in the entire country opened their doors to welcome anyone that wanted to come and pray. It was a time of reverence and deep prayer (wouldn't be a bad idea today). And people flooded to them.

However, my pain and fear was so minor compared to all those right in the middle of the attack. As I got home and began to watch the images on TV, all I could do was cry and hold my

children. Roger was working with Fire Rescue and his job quickly turned to high alert profile. Although it seemed like my entire world was crashing, the images on the screen reminded me to pray without ceasing for those people, families, first responders, our country.

It's hard to believe that 20 years have passed since that horrible day. New York, the Pentagon and Shanksville, Pennsylvania will never be the same. So many tragic deaths and so many heroes. The American people were wounded and hurting. Everyone was reaching out to their friends and neighbors. There was so much good. The American

people bonded and felt each other's pain.

My how time changes things! It seems many Americans have forgotten all the pain and loss that we, the American people, went through. Everyone seems to have their own opinions about everything. Our America is quickly changing and we Americans need to find the courage to remember who we are. We are, 'One Nation Under

Each one of us needs to make sure to Remember the day as the 20th Anniversary is this Saturday, September 11. If you are not attending any events,

make sure to take a moment of silence in remembrance. The first tower was hit at 8:46 a.m.: the second tower at 9:03 a.m; the Pentagon was hit at 9:38 a.m.; and at 10:10 a.m. the final plane went down in Somerset, Pennsylvania.

Service or Power?

Dear Editor,

"The servant-leader is servant first, it begins with a natural feeling that one wants to serve, to serve first, as opposed to, wanting power, influence, fame, or wealth." — Robert K Greenleaf

Obviously none of Mr. Greenleaf's works can be found on Dr. Burns' bookshelf. Her most recent decision, lack of collaboration and non- existent communication screams power not service. On August 17, she announced correctly at the Board Meeting, convened to discuss masks, that the mandatory wearing of masks by staff was a change in working conditions. It was subject to negotiations and Burns said that, in her conversation with Union leadership, there was no obstacle to implementing the mandate.

In the interim, Burns must have received a legal opinion that mandates of limited duration are not subject to negotiation. Does she communicate this with Union leadership

who has already submitted their proposals to other members of Burns' administration? No, she announces on the 26th that the staff mask mandate for the next 30 days is a "management right." She also instructed those who received the Unions' proposals not to respond back. Both Union Presidents heard about the mandate for the first time while in transit to an out of the area meeting. Service or power?

Rather than giving other examples of Burns failure to act as a Servant Leader, I will end with an offer. I am willing to conduct a workshop, pro bono, on Servant Leadership for Dr. Burns, her administration, the School Board and the Union Leadership. I have done this numerous times with other education leaders in my career as a K-12 senior administrator and, most recently, with the administrative team of a large local employer. All I ask is the ability to follow up with the attendees.

Hilliard to Increase Water/Sewer Rates

The Hilliard Town Council met Thursday night for their first meeting of September. Town resident Christina Morgan addressed the council concerning changing or amending a town ordinance. "The ordinance allows chickens in the town limits but no roosters. I want to have a rooster on my property," said Morgan. "The ordinance also says I must have a survey of

my property and get a permit. That would all be around \$1,000."

No comments were made to Ms. Morgan following her

The first order of business was to revisit the opportunity for the town to have first option on purchasing the Boondocks Junction property. Jennifer Mezara, the realtor handling the property, addressed the council with some strong points about the property with a working venue on site. "I just wanted to refresh your memory about this valuable property that has a 3,780sf multi-purpose venue with adjacent three parcels," said Mezara. "The growth from this business, which brings people from all over, can boost a small town's community development and offer for more economic development. With it being a working venue, booked into 2022, the town could profit right off the bat."

"We're just not set up for running this type of business. We would need someone fulltime to handle it," said Council President John Beasley. "It's a tough sale for me."

property," added Councilman Jared Wollitz.

"I just don't think it's a good thing for the town to do," said Councilman Lee Pickett. "This would be using the taxpayers money and I don't see it."

The council chose not to look any further into purchasing the property.

Following business included the council approving for Mayor Floyd Vanzant to sign the American

Rescue Plan Act Coronavirus Local Fiscal Recovery Fund Agreement.

The council approved
Resolution 2021-22
which concerned amending
Resolution 2020-10, changing

the Schedule of Fees for Streets, Sidewalks and other public places. Due to the cost of steel, this would include a 60% increase on culvert pricing. The prices will go into effect October 1,

The council also approved Resolution 2021-23 which concerned amending Resolution 2020-08, amending Water and Sewer Usage Rates. The rates will increase 1.08% based on the Municipal Cost Index as stated in the Town Code Chapter 58 Utilities Sec. 58-86, annual increases tied to inflation. The increase for residents will be around \$2 per month.

The council approved paying \$5,484.74 to CPE (Coastal Pump & Equipment, Inc.) for the Main Lift Station Pump.

The final business item was the approval of the hiring of Hannah Nicks Bray for the Administrative Assistant position. Bray began the new position Tuesday, September 7 at a cost of \$17/per hour.

The next council meeting will be Thursday, September 16 at 7 p.m.

Callahan Boy Scouts Organize an Adopt-A-Road Litter Cleanup

Following safety guidelines for the safe collection of litter, Callahan Boy Scout Troop 351, under the leadership Christine Waltman, completed their 3rd Adopt-Aquarter Road cleanup event on Saturday, August

Troop 351 has adopted Warrior Road as their cleanup location. however

their enthusiasm for a clean, green and beautiful environment often leads them to clean additional areas. Saturday's event was no exception. The Troop cleaned Warrior Drive, Brown Street and the student parking lot of West Nassau High School removing two large bags of litter and several bulk



"Callahan Boy Scout Troop 351 sets a great example for all partners in the Adopt-A-Road program," said Lynda Bell, Keep Nassau Beautiful Executive Director. "We appreciate their service to the community by helping keep areas in Callahan clean, green, and beautiful."

Management Plan In September 2020, the County secured RoadBotics, an enterprise firm specializing in road and infrastructure assessments, to conduct an unbiased survey of all the County's existing 437

miles of paved roads and to provide feedback on current conditions. This information was used to develop a new, robust Pavement Management Plan that will guide the County in preventative

maintenance.

The firm utilized their interactive. online platform and advanced data collection tool to record virtual imagery of each of the existing paved roads. The imagery was then uploaded to their RoadSense app which used an algorithm to identify deficiencies in the roadways. The roadways were then scored based on condition, with the best roadways scoring a 1.00 and the worst scoring a 5.0. The projects with the highest scores are typically placed with the highest priority in the Pavement Management Plan. However, roadways classified as Collector Roadways (lowto-moderate capacity roads which serve to move traffic from local streets and arterial roads) will be given priority over local roadway classifications where condition scores tie.

At the August 22, 2021 meeting, the Board adopted the new Pavement Management Plan utilizing a 22year cycle for ranking, prioritizing, and budgeting purposes. The Plan is expected to require a minimum of \$3.9 million annually (in today's dollars), however this amount may fluctuate based on the value of the U.S. dollar, prevailing wages, and cost of raw

material.

Based on current maintenance purview and previous funding, each paved County roadway could only be resurfaced every 86 years. However, under the new Pavement Management Plan, the County will be able to resurface an estimated 18-20 miles of roadway annually.

Another exciting feature of this new Plan is that the County can now utilize the RoadSense app to reassess roadways periodically and update plans for maintenance as needed. The interactive mapping software can determine if a roadway condition score is dropping notably and whether or not it requires resurfacing sooner than originally anticipated.

Upon approval of the new Pavement Management Plan, County Manager, Taco Pope, stated, "This Plan not only improves quality of life by having the roads resurfaced more frequently, the County benefits from a fiscal sustainability standpoint as well. One of the biggest problems jurisdictions face is the inability to maintain their infrastructure. You all (the Board) should be very proud that you have a proactive approach to pavement management. Nassau County is moving in a very positive direction."







Genealogy Tidbits

History and genealogy always walk hand in hand. As the world around us many times dictates the decisions we make, as to our professions, where we live, and the battles we may be called on to fight. Here are four Historic events that changed America (and maybe your ancestors lives) forever.

According to Family History Daily they are:

- 1. The Homestead Act of 1862 and the opening of the American West, post Civil War. You can find records of people who took advantage of the promise of land through the Bureau of Land Management.
- 2. The 1875 Supreme Court Decision in Henderson vs. Mayor of the City of New York. This transferred control of immigration from the States to the Federal Government for the first time. This helped bring about Immigration Centers such as Castle Garden, Ellis Island and Angel Island, where immigration records are consolidated.
 - 3. The 1918 Flu Pandemic, which claimed more lives than in WWI.
- 4. The Great Depression and the formation of the Works Progress Administration, WPA and the Civilian Conservation Corps, CCC. These programs created inventories, indexes and transcripts of historical records that can be located in the US National Archives and Civilian Conservation Corps Legacy.



This time it was Walker Avera finding pay dirt from 19-yards out. With the extra point good, the Flashes closed the first quarter with a comfortable 21-0 lead.

The Flashes kept up the momentum in

the second quarter by continuing to rely on the ground game with DJ Coston getting in on the action as he shed through would be tacklers like he was lathered in butter for a 5-yard touchdown run. With the extra point good, the Flashes added on to the lead, 28-0. But, the tide began to shift. The Blue Devil offense began to march down the field with help from a roughing the punter

penalty and a pass interference penalty from the Flashes defense. They used the battering ram to bust the castle doors open to get into the end zone, but the Flashes defense bent but didn't break and kept the Blue Devils out of the end zone. On the next play, the Flashes found trouble with a fumble on the handoff that led to a recovery by a Flashes player in the end zone, allowing the Blue Devils to get on the board with a safety. point good, the Flashes went into halftime with a comfortable 35-2 lead.



The Flashes defense denied any further advancement when Colton Conner made a tackle in the end zone for the safety, thus adding 2 more points to their score. On the ensuing punt, the Flashes special teams got in on the scoring fun when Braydon Holley found some space, put on a series of jukes and used his speed to return the kick 60 yards for the score. With the extra point good, the Flashes extended the lead 44-2. Even when

the game went to running clock, the Flashes still managed to find the end zone one more time thanks to Avera's 12-yard touchdown run. And just like that, the Flashes continued to roll with a 51-2 beat down against the Blue Devils as they improve to 2-0.

Offensively, the Flashes generated 284 yards total with 180 of those yards coming on the ground. Walker Avera led the charge with 5 carries for 63 yards and 2 touchdowns; DJ Coston had 12 carries for 60 yards and a touchdown; Lyle Bennett had 2 carries for 37 yards and a touchdown; and Braydon Holley had 2 carries for 21 yards and a 60 yard punt return touchdown. Bennett went 5/9 for 99 yards and 2 touchdowns; Coston had 2 catches for 54 yards and a touchdown; Dylan Coston had 2 catches for 28 yards; and Bradyn Matto had a catch for 19 yards and a touchdown.

Defensively, the Flashes forced two turnovers that led to 14 points. Avera was in front on defense with 5 tackles; Carson Newkirk had 3 tackles and a pass breakup; Travis Sapp had 3 tackles and a fumble recovery; Coston had 2 tackles and an interception; and Brogan Johns, Klayton Bright and Colton Conner each had 2 tackles.
