3. To establish School , College, Educational College , Technical College , Medical College, Agriculture college, paramedical college, veterinary college to provide quality education for all human being specially for the boys and girls of minority community .
4. To Arrange and provide such medical aid and such other assistance necessary for living to the needy persons who are otherwise incapable or handicapped or mentally or physically retarded and to financially uplift and person of poor class.
5. To educate the common people and personal hygiene, sanitation , disease prevention methods, and to create in them a sense of awareness on the

7. To foster friendship and amiability and understanding between the communities of the rural sectors throughout India
8. To make students disciplined in conduct, refine in good behaviour at reasoning and honest in the discharge of all their obligations with a special emphasis on the development of character and personality.
9. To enlighten students through guidance and consequently about careers and courses so that by choosing career of their linking they may become useful citizens of India.

10. No member shall have any personal claim on any property of the or make profit out of his or her membership. The income and property of the shall be applied solely towards the promotion of his objects and no portion thereof shall be paid or transferred directly or indirectly in any manner whatsoever to the members or past members of the or to any persons claiming through any one or more of the members. The shall provide education to the students in every possible manner in every field.

11. To implement and run the various Welfare Schemes and Projects e.g. Vocational Training, Awareness Project, Day Care Centre, Home for the aged, Rehabilitation Centre etc. for the old, children, women, handicapped, mentally retarded youth beggars, street children's, backwards classes, Sc's, SDs. instead of above, the Organization/ shall also construct the building, roads houses and toilet etc. for the general welfare of the people keeping in view the basic needs.

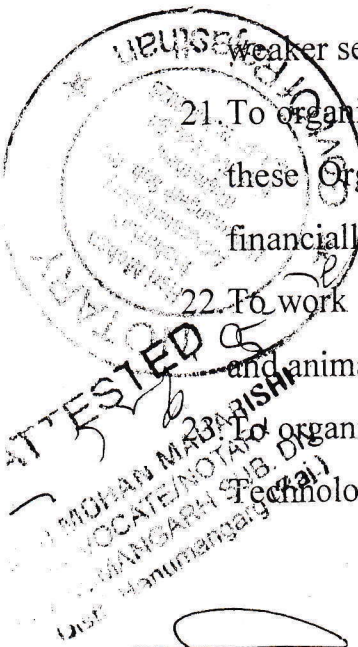

13. To carry on various schemes for the development of barren land, environmental protection, non conventional energy sources, preservation of water and the natural heritage.
14. To conduct the various schemes and projects aided and sanctioned by the Govt. of India and run by the various Departments and Ministers through the medium of non- Governmental Organizations.
15. To establish and conduct the counselling Centres for legal awareness in order to make the people aware about the same.
16. To establish and conduct the counselling Centres for providing the knowledge about Panchayati Raj and Consumer protection etc.
17. To buy, to take on Lease or on rent the houses, the land and the vehicles etc. for the achievement of the objects of the organization.
18. To publish paper, Magazines etc. for the welfare of the people.
19. To establish paper and conduct the Libraries, Orphanages, School, Colleges coaching centre, Hostels and Hospitals etc.

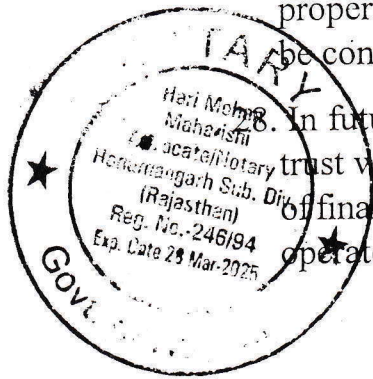

26. To take loan from any bank, institution for the purchase of land. Vehicle etc. and construction of building and other needs of the .

27. In future, if the owner or the officials of the trust claim ownership rights on the movable & immovable property of the trust, individually or collectively, in the event of a dispute, the landowner of all the movable and immovable properties of the trust, Momanram, son of the Mr. Devaram Ownership will be considered.

28. In future, the right to sell all the movable and immovable property of the trust will be reserved by the Momanram son of Shri Devaram in the event of financial loss and indebtedness of the trust and the institutions / institutions operated by him.



5. SOURCES OF FUNDS:-

That the trustees shall receive donations from the government local bodies state organs, public, private institutions and private persons, loan from Pvt. & financial institutions/Banks for the purpose of advancement of the objects.

6. APPLICATION OF FUNDS:-

That the trustees shall have powers to invest the funds of the trust in such securities, institutions or banks as may be approved from the time to time under the provisions of the income tax act or other acts.

DISPOSAL OF PROPERTIES OF THE TRUST:-

That the immovable property of the trust shall not be sold or otherwise alienated. However the moveable property the trust may be sold or otherwise disposed of if the same is surplus, obsolete or otherwise unusable. Property can be mortgaged or pledged for loan taken by the trust.

8. MEMBERSHIP:-

- That trust will consist of at present 6 members of all not less than 18 years of age and literate who believe in the aims and objects of the trust.
- That the maximum number of trustees shall be limited to 9 and power of appointing new trustee shall be vested in executive committee of the trust by 2/3rd of the majority of members of executive committee.
- Any ordinary Indian who desire to become member of the trust shall submit an application on prescribed Performa. The membership will be granted on approval of Executive Committee.
- There will be two types of membership i.e. patron memberships & life membership. Membership fees of pattern member will be Rs. 1100/- only (One Thousand One Hundred rupees only) & Rs.500/- (Five Hundred rupees only) for the life members. The executive committee will reconsider however after registration this fee.
- A member is free to resign by giving a notice of at least one month in writing to president giving reasons thereof.
- An ordinary resident of India.

9. RIGHT OF VOTE:-

Every member shall have the right of vote. There will be no proxies. The President will exercise right of deciding vote in the event of tie.

10. POWER OF TRUSTEES:-

- That the president and any other trustees so empowered shall have right to sue or to be sued on behalf of the trust and shall be entitled to prosecuted and defend any legal action or cases in accordance with the resolution any legal action or cases in accordance with the resolution or wishes of the trustees. He shall be entitled to apply to taxation authorities or any other authorities for any refund due to the trust and to receive the same. He shall also be entitled to make any applications to any court, office taxation or, public institutions in respect of matter relating to this trust.

12. LIABILITY CLAUSE:-

That the trustee shall not be liable for any loss not attributable of their own dishonesty or to the willful negligence of any act known to them to be breach of the trust and in particularly one trustee shall not entitled to take proceedings against another trustee or trustees.

13. MEETING OF TRUSTEES:-

That the meeting of the trustees shall be held as and When determined by the executive committee, the trust also hold such other meeting from time to time as may be necessary for the transaction of the business of the trust or furtherance.

14. POWER OF MAKING RULES:-

That the trustee shall be entitled to frame rules for the management and administration of the Trust for convening meeting of the trust and for conduct of business, thereon. They may delegate any of the powers and duties to any one or more of the trustee or sub-committee of the trustee by resolutions passed in this respect for the purpose of doing such specific work or works or for attending day to day business of the trust and its institutions.

15. MEETING OF THE GENRAL COUNCIL:-

The General council will meet at least one in a calendar year.

16. QUORUM:-

Quorum for the meeting will be 1/3rd of the total house and a 10days notice will be required for the annual meeting and 5 days for special General meetings. Meeting can be called at shorter notice if therefore agree.

17. MAJORITY DECESIONS:-

That in case of lack of unanimity amongst the trustee majority shall take the decision and acts of majority in execution of the powers being given in trust deed shall be valid as if they acted unanimously in that respect.

18. MINUTE BOOKS:-

A minute book shall provide by the trustee and kept at register Office of the trust. This shall contain the proceeding of the meeting of General Council of the trustees and shall be signed by the all the trustees of the meeting at the conclusion or at subsequent meeting when they are fully confirmed.

19. ACCOUNT BOOKS:-

That the trustee shall maintain true and complete account of the all of the monies received or spent by the trustees in respect of which such receipts and expenditures taken place and of properties, credits and liabilities, of the trust. The account shall be made up at the end of every year ending 31st March (Financial year) .Such accounts and balance sheet shall be examined and passed in the meeting of members or at such other meeting may be called for that purpose accounts of the trust shall be got audits in accordance with the provisions of the Income Tax Act.

20 .APPOINTMENT OF ACCOUNTANT:-

That they shall also be entitled to appoint paid persons to keep accounts etc.

21. CORPUS OF TRUST:-

That such other properties or amount as may be donated by the founders of trust or by any other persons or institutions shall also from part of the trust property and shall be held by the trustees in trust for furtherance of the objects of the trust.

22. FULL FILL OF THE VACANCY:-

That in event of death, resignation or removal of any trustee or his refusal, vacate the vacancy shall be filled by the decision taken by the members.

23. In Any Circumstance Central Govt./ State Govt./Devsthan Vibagh Cannot be Takeover this Trust in any condition.

24. VALIDITY OF THE PROCEEDING DURING ANY VACANCY:-

That no filling of any vacancy that may be caused will not invalidate the proceedings of the Trust or anything or act done by the trustees till vacancy is filled.

25. NOTICE OF THE MEETINGS ETC:-

26. HONORARIUM TO TRUSTEES:-

27. VALIDATION OF EXPENSES OF TRUSTS:-

28. BANK ACCOUNTS:-

That the trustee shall be competent to open account in any bank/s or in the name of the trust and to operate the same. The bank account will be operated by two trustees as mutually decided by all the trustees.

29. APPLICABILITY OF TRUST ACT:-

That the provisions of the Indian Act shall apply to the trust to the extent these are not inconsistent with the above provisions.

30. IN THE CASE OF DISSOLUTION:-

That under no circumstances including the winding up of the trust, the fund of trust shall be distributed among its trustee and that even in case of compulsory dissolution of the trustees and that even in case of compulsory dissolution of the trust the funds of the trust shall be transferred to trust or institution solely for the same purpose of carrying out charitable activities.
