Assumption of Risk Statement

I (we) the undersigned, am (are) about to take a hunting/fishing/recreational outing into the woods and waters (inland and seaward) of Maine with Grayson Krause of Buxton, Maine, Owner of Maine Wilderness Pursuit LLC

I (we) understand that such a trip involves considerable risk of injury or loss. Including but not limited to: loss of property or life, hypothermia from immersion in cold water or otherwise, lightning, lack of communication or unavailability of early medical treatment, dehydration, and/or sun exposure.

I acknowledge that hunting and/or target shooting has inherent risks, hazards, and dangers for anyone, that cannot be eliminated, particularly in a wilderness environment. I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:

1. The risk of handling firearms and being near others that have firearms in their possession;
2. The risk of injury from ammunition and shot from other guns;
3. Walking in rugged country, including encounters with wildlife, animals and insects;
4. Inclement weather conditions;
5. The risk of injury from riding on an all terrain vehicle (ATV) or any vehicle used off the paved road
6. The risk of injury from the use of tree stands.
