

Terms & Conditions

PAYMENT AND CANCELLATIONS:

All guests are required to place a 50% down payment on the date of booking. The remaining 50% payment must be paid to Maine Wilderness Pursuit or its booking agent no less than 15 days prior to the calendar day in which you are scheduled to hunt. All deposits and payments are fully non-refundable once provided to Maine Wilderness Pursuit. In the event you should cancel your scheduled trip within 60 days prior to hunt, any and all deposits and payments paid by you shall be deemed fully forfeited and non-refundable and shall not be returned nor applied to future hunting trips. In the event you cancel your scheduled trip with at least 60 days' notice, any deposits and payments already paid by you shall not be refunded but shall be applied to a future hunting trip to be held within 12 months from the date of cancellation of the original trip.

If your trip is canceled at any point due to prolonged dangerous weather conditions in the 7 days immediately prior to the commencement of the trip, we will reschedule your trip and retain all funds paid by you to be applied towards the rescheduled trip. If we cannot reschedule your trip within the next 12 months from the date of cancellation, we will refund you in full. In the event your trip is cancelled due to dangerous weather conditions on or after the date of commencement of the trip, you shall not be refunded.

We reserve the right to terminate or cancel the remainder of your trip with no refunds of any payments already made by you in the event such cancellation or termination is necessary for the safety or well-being of all parties involved, or inappropriate or illegal behavior of client. Factors or events which may lead to the cancellation of a hunting outing or the trip in its entirety include, but are not limited to, being intoxicated during a hunt; improper or irresponsible handling or discharging of firearms; the destruction of any landowner property; disrespectful actions towards any guides, or other individuals; failure to follow the rules and guidelines of any hunts; or any other actions which are unlawful or illegal.

Hunting Permits

All guests are responsible for obtaining their own hunting permits at their own expense. Permits for certain types of game may expire, close purchase windows, or sell out from time to time; it is your responsibility to ensure that you have obtained the requisite permit(s) prior to your scheduled visit. In the event you fail to obtain your own hunting permit, Maine Wilderness Pursuit reserves the right to cancel a hunt or trip at its own discretion with no refund.

What to expect:

All of our hunts are fair chase and these are wild animals, which mean there are no guarantees. There are many factors outside of our control that will affect our trips for good or bad every day of the season. We are committed to providing you with the best hunt we can. Limits do not happen every day of the season, but your guide will always be professional, keep a positive attitude, and will provide all knowledge and equipment necessary for a safe and enjoyable hunt.

What we expect from you:

We expect you to have a positive attitude and enjoy the excursion! We ask that you follow our rules and conduct yourself in a safe manner at all times.

LIABILITY WAIVER

A.) Covenant to Hold Harmless and Absolve Liability

Hunter agrees to hold harmless and absolve Maine Wilderness Pursuit LLC, and its owners, agents, representatives, landlords, and suppliers of any and all liability of any kind for any incidents, accidents, or damages incurred by Hunter or Hunter's personal property during the course of Hunter's hunting trip. Hunter covenants and agrees not to hold any forementioned parties liable for any and all injuries, illness, or casualty of any kind incurred while engaged in a hunting trip led by Maine Wilderness Pursuit LLC.

B.) Terms and Conditions of Liability Waiver

a) Hunter agrees to abide by all applicable Federal and state laws throughout the duration of the hunting trip. Any violation of any and all Federal, State, and/or Local laws by Hunter shall be a result of Hunter's own actions and Hunter agrees to bear responsibility for such and will not hold Maine Wilderness Pursuit LLC or any of its agents, owners, employees, guides, or representatives liable for any actions undertaken by the Hunter during the trip.

b) Absolutely no drugs or intoxication will be tolerated at any time. In the event that the Hunter or their companions are observed consuming or being in possession of any alcohol or drug paraphernalia immediately prior to or during a hunting session Maine Wilderness Pursuit LLC may cancel the hunting session at Hunter's expense.

d) Hunting is our business, however Maine Wilderness Pursuit LLC, cannot guarantee you a successful hunt. We work diligently to produce game for the hunters and will hunt you in areas where waterfowl have been previously taken or in areas that have been pre-scouted. We cannot control the weather or interference from outside factors.

e) Canine guide dog companions are an integral, essential, and necessary part of Maine Wilderness Pursuit LLC operations. Due to the time and expenses incurred in obtaining, training, caring for, and maintaining our canine guide dogs and their essential role in our operations, any damage, harm, injury of any kind (regardless of severity), or death to any canine which is caused directly or indirectly by a Hunter or a member of the hunter's group shall carry a fine of \$10,000.00. This includes but is not limited to injuries or death from the discharge or use of firearms or weapons, vehicles, chemicals or choking hazards, and any other objects or devices used or handled by Hunter.

f) Hunter agrees to all rules discussed during orientation of the practices of Maine Wilderness Pursuit LLC.

g) Hunter understands and acknowledges that the real property utilized by Maine Wilderness Pursuit LLC during the hunting trip, whether private or public, is sensitive and necessary to the continued operations of Maine Wilderness Pursuit LLC. To that effect, Hunter covenants and agrees to NOT utilize, publish or share hunting areas and access to areas or hunt any of the property utilized by Maine Wilderness Pursuit LLC during the hunt for a period of no less than ten (5) years following the date of the start of the hunting trip.

h) Hunter agrees that any and all photos, videos, or other recordings or images captured by the Hunter and/or his/her companions during the hunting trip shall be deemed the mutual property of the Hunter and Maine Wilderness Pursuit LLC. To that effect, Maine Wilderness Pursuit LLC may use, replicate, and redistribute any photos, videos, or other recordings or images captured during the hunting trip without the permission of the Hunter for any and all uses and purposes.

i) The parties hereby agree that Maine or applicable state law shall be governing throughout the
