Mike Davidson & Associates, Inc. – Mike Davidson provided Council with a copy of the January 2024 Wastewater and Water Treatment Plant report (See Attached).

Borough Manager Update – Kayla Jewell updated the council on what tasks she has been working on in the borough office. She informed council that she had sent out letters to the owners of rentals, so that they could reach out to Richardson Inspections. They have from February to October 2024 to have inspections done. She also Updated the council on a few questions she had regarding the Online Bill pay for water and sewer, which was regarding whether they should allow customers just to pay online or pay in the office as well with a credit card. They all decided the online option for the time being would be fine.
