The minutes for the March 18th, 2025 council meeting was presented and upon a motion by Mr. Gaynor second by Mrs. Ross, with all voting yea, the minutes were approved as presented.

Mr. Holland moved the council approve Resolution No. 2025-06 authorizing the use of DS200 (scanner and tabulator) and Express Vote BMD (ballot marking device) complying with Section 17-7-21 of the Code of Alabama and any regulations adopted pursuant thereto, is hereby authorized for the reporting, counting and tabulating of any and all elections results. Mrs. Hall seconded the motion and with all voting yea the motion carried.

Mr. Gaynor moved the council appoint Mr. Gaynor as the voting delegate and Ms. Hall as the 1st alternate delegate to represent the City of Brundidge at the annual Alabama Municipal Insurance Corporation membership meeting to be held May 14, 2025 at the ALM Annual Conference in Huntsville, Alabama. Mrs. Rodgers seconded the motion and with all voting yea the motion carried.

Mrs. Rodgers moved the council appoint Mrs. Hall as the voting delegate and Ms. Rodgers as the 1st alternate delegate to represent the City of Brundidge at the annual Alabama League of Municipalities membership meeting to be held May 15, 2025 at the ALM Annual Conference in Huntsville, Alabama. Mr. Gaynor seconded the motion and with all voting yea the motion carried.

Pursuant to the "Open Meeting Act" Mayor Boyd moved the council to go into executive session to consider the discipline of the Brundidge Chief of Police Samuel Green regarding the indictment of federal criminal charges brought against him. Mrs. Rodgers seconded the motion. Roll call vote was as follows, Holland yea, Hall yea, Ross yea, Gaynor yea, Rodgers yea, and Boyd yea. The motion carried as presented. Mayor Boyd advised the ones in attendance, the regular meeting would resume in approximately twenty minutes. The executive session began at 6:11 p.m.

Mrs. Boyd moved the council to come out of executive session and resume the meeting at 6:27 p.m. Mrs. Rodgers seconded the motion. Roll call vote was as follows, Holland yea, Hall yea, Ross yea, Gaynor yea, Rogers yea, and Boyd yea. The motion carried as presented.

Mr. Holland moved that the council suspend Samuel Green without pay pending the outcome of the indictment of federal criminal charges brought against him. Mrs. Rodgers seconded the motion. Roll call vote was as follows, Holland yea, Hall yea, Ross yea, Gaynor yea, Rodgers yea, and Boyd yea. The motion carried as presented.

There being no further business to come before the council, Mrs. Rodgers moved the meeting to be adjourned with a second by Mr. Holland.
