The City Clerk reviewed the proposed FY2025 annual budget. After a discussion, the council instructed the staff to make changes in the appropriations to include the Troy-Pike Cultural Arts Center (\$2,000) and House of Hope (\$3,500), also a 5% increase to city employee's salary.
