Absent: Holland and Rodgers. Mayor Boyd called the meeting to order.

Mayor Boyd opened the meeting with a public hearing regarding a request from Mr. William Shackelford to rezone property located at 405 North Main Street from B1 (Neighborhood Commercial District) to B2 (Community Commercial District). Mr. Shackelford spoke to the Mayor and council requesting they approve the rezoning to allow him to put in an auto mechanic shop. Mayor Boyd asked how many cars would be outside at night? Mr. Shackelford responded no more than one or two.
