The minutes for the November 19<sup>th</sup>, 2019 council meeting was presented and upon a motion by Mr. Foster second by Mr. Gaynor, with all voting yea, the minutes were approved as presented.

Mrs. Ross moved the council approve the FY2020 annual budget to include a five percent increase to the employee's rate of pay effective the first pay period in January. Mr. Gaynor seconded the motion and with all voting yea the motion carried.

Mr. Foster moved the council appoint Mrs. Ross as Mayor Pro Tempore for the remaining term of office. Mr. Gaynor seconded the motion and with all voting yea the motion carried.

Mr. Foster moved to change the December 17<sup>th</sup>, 2019 regular council meeting to 1:00 p.m. at Brundidge Station. Mrs. Ross seconded the motion and with all voting yea the motion carried.

Mr. Foster moved the council recess this meeting until December 10<sup>th</sup> to further discuss the ambulance contract. Mrs. Ross seconded the motion and with all voting yea the motion carried.

The Council reconvened its' December 3<sup>rd</sup>, 2019 meeting on December 10<sup>th</sup>, 2019 at 1:00 p.m. at City Hall at which time and place the following members were present: Councilmembers Griffin, Ross, Gaynor and Foster. Absent: Baxter. Mayor Boyd called the meeting to order.

Mrs. Ross moved the council approve Haynes Ambulance contract option that does not include a subsidy. Mr. Gaynor seconded the motion and with all voting yea the motion carried.
