The Council of the City of Brundidge, Alabama met in regular session February 18th, 2020 at 6:00 p.m. at City Hall at which time and place the following members were present: Councilmembers Baxter, Griffin, Ross, Gaynor and Foster (6:04 p.m.). Mayor Boyd called the meeting to order.

The minutes for the February 4th, 2020 council meeting was presented and upon a motion by Mr. Gaynor second by Mrs. Ross, with all voting yea, the minutes were approved as presented.

Bids were received for the TAPNU-TA19 (919) sidewalk project on February 13th, 2020 at 10:00 a.m. at City Hall. The lowest and most responsive bid was submitted by Triple J Construction, LLC of Arley, Alabama in the amount of \$364,975.00. Kenny Sanders, of Poly, Inc., verified that Triple J Construction, LLC is a properly licensed contractor in the State of Alabama and recommends the contract award be made to the same in the amount of \$364,975.00. A letter was received on February 18th, 2020 from Ms. Sharon Ellis, Area Operations Engineer – Troy Division of the Alabama Department of Transportation concurring with the recommendation to award Triple J Construction, LLC, the contract in the amount of \$364,975.00. Mr. Gaynor moved the council approve the recommendations of the engineer to approve the bid submitted by Triple J Construction, LLC in the amount of \$364,975.00. Mr. Foster seconded the motion and with all voting yea the motion was approved.

Mr. Foster moved to appoint Mrs. Ross as an alternate for the Alabama League of Municipality's annual business meeting and a second was made by Ms. Griffin and all voted yea.

There being no further business to come before the council, Mr. Foster moved the meeting be adjourned with a second by Mr. Gaynor, all voted yea.
