The Council of the City of Brundidge, Alabama met in regular session Tuesday, June 7th, 2022 at 6:00 o'clock p.m. at City Hall at which time and place the following members were present: Holland, Ross, Gaynor and Rodgers. Absent: Hall. Mayor Boyd called the meeting to order.

Mayor Boyd opened the meeting with a public hearing regarding an application to the Alabama Department of Transportation Section 5310 Federal Transit Act to apply for a van for the senior and disabled citizens of our community. Mayor Boyd acknowledged the mechanical problems we are having with the current van which is a 2014 model. Linda Faust provided information about the application and advised the project request for funding is 80% with the City providing 20% toward the purchase of the van. Those in attendance were pleased the City is apply for this funding so that the senior and disabled citizens would be taken of and meals provided. There being no further comments, Mayor Boyd closed the public hearing.

Mayor Boyd opened a second public hearing regarding the program year 2022 Community Development Block Grant (CDBG) application. Mrs. Ashton Hutchinson, Community and Economic Development Director of SCADC, was in attendance to explain to the council the various types of funds available and the activities eligible for those particular funds. She advised the City is currently looking at a sewer rehabilitation project. This is a competitive grant with maximum funding of \$400,000 and a 10% local match. The City Manager, Willie Wright, told the council a company is in town running cameras through various sewer lines to define the ones needing rehab the most. Once that is complete the engineers with draw up plans and present to Mrs. Hutchinson for approval and she will then submit the application to ADECA. Deadline for the submission is July 18, 2022. Citizens in attendance were happy to see the City moving forward to provide the people of Brundidge a better quality of life. There being no further comments, Mayor Boyd closed the public hearing.

The minutes for the May 17th, 2022 council meeting was presented and upon a motion by Mr. Gaynor second by Mrs. Rodgers, with all voting yea, the minutes were approved as presented.

Mr. Gaynor moved the council approve Resolution No. 2022-07 authorizing Mayor Boyd to execute and file an application to the Alabama Department of Transportation for aid in the financing of a Section 5310 transportation assistance project for a van to assist the seniors and disabled citizens of Brundidge. Mrs. Rodgers seconded the motion and with all voting yea the motion carried.

Mrs. Rodgers moved the council approve the Haynes Ambulance Agreement as presented. Mrs. Ross seconded the motion and with all voting yea the motion carried.

Mrs. Rodgers moved the council approve a contract with Electric Cities of Georgia for annual training for the electric department employees. Mrs. Ross seconded the motion and with all voting yea the motion carried.

There being no further business to come before the council, Mrs. Rodgers moved the meeting be adjourned with a second by Mr. Holland, all voted yea.

The minutes for the June 7th, 2022 council meeting was presented and upon a motion by Mrs. Rodgers second by Mr. Gaynor, with all voting yea, the minutes were approved as presented.

Mrs. Rodgers moved the council approve Resolution No. 2022-08 providing a one-time lump sum payment to eligible retirees of the City of Brundidge through the Retirement Systems of Alabama. The estimated cost to fund the bonus for the City is \$7,916.00. Mrs. Hall seconded the motion and with all voting yea the motion carried.

Mrs. Rodgers moved the council approve the recommendation from Mayor Boyd to reappoint Mrs. Catherine Flowers to the Brundidge Housing Authority Board (term February 1, 2022 through February 1, 2027) and also appoint Mrs. Brenda Black to fill the remaining term of her late husband, Gary Black, whose term will expire June 1, 2026. Mrs. Hall seconded the motion and with all voting yea the motion carried.

City Clerk, Linda Faust, reviewed the FY2022 April financials.

There being no further business to come before the council, Mrs. Rodgers moved the meeting be adjourned with a second by Mrs. Hall, all voted yea.
