Ms. Rodgers moved the council approve Resolution No. 2021-04 which designates the depositories of the city and approves payment of the re-occurring expenses of the city during this four year term. Mr. Gaynor moved the council approve Resolution No. 2021-05 which appoints Linda Faust as City Clerk for the term of office beginning November 2, 2020 through November 4, 2024. The motion was seconded by Mrs. Ross and by show of hands the vote was recorded as follows; voting yea, Holland, Hall, Ross, Gaynor and Rodgers; voting nay, none.

Ms. Rodgers moved the council approve Resolution No. 2021-06 which appoints Willie Wright as City Manager for the term of office beginning November 2, 2020 through November 4, 2024.
