The minutes for the October 18th and 19th, 2021 council meeting were presented and upon a motion by Mrs. Rodgers second by Mr. Holland, with all voting yea, the minutes were approved as presented.

The City Manager, Willie Wright, presented the council with a proposed contract with GameTime for two playground play structures. He explained the City applied for a grant to purchase two play structures, one to be placed at Galloway Park and one at Ramage Park. The grant provided the City a 50% discount on both play structures. He advised the grant was approved and would need the council to approve the contract provided to them. Mr. Gaynor moved the council approve the contract with GameTime to purchase two play structures for a total cost of \$228,766.77.
