The minutes for the August 5<sup>th</sup>, 2023 council meeting was presented and upon a motion by Mrs. Rodgers second by Mrs. Ross, with all voting yea, the minutes were approved as presented.

Mayor Pro Temp Gaynor opened the meeting with a public hearing regarding assessments of the following properties the City determined was in violation of City Ordinance No. 87-6 – Weed Control.

Mrs. Rodgers moved the council approve Resolution No. 2023-20 regarding the assessment of property located at 414 Mike Street. Mrs. Ross seconded the motion and with all voting yea the motion carried.

Mrs. Rodger moved the council approve the recommendation from Poly, Inc. approving the bid from Schmidt Environmental Construction Inc, of Auburn for the aeration/mixing system in the amount of \$408,200.00 also to approve Dean Electrical for electrical and controls work associated with aeration/mixing improvement in the amount of \$94,500. Mr. Holland seconded the motion and with all voting yea the motion carried.

Mr. Holland moved the council approve a Retail Table Wine License Application from Brundidge Marathon, 7458 US Highway 231, Brundidge, AL 36010. Mrs. Ross seconded the motion and the following vote was recorded. Voting yea: Holland, Ross, Gaynor and Rodgers. The motion carried as presented.

Mrs. Rodgers moved the council approve a Retail Beer and Table Wine License Application from J S Buy Rite, 120 E. Troy Street, Brundidge, AL 36010. Mrs. Ross seconded the motion and the following vote was recorded. Voting yea: Holland, Ross, Gaynor and Rodgers. The motion carried as presented

Mrs. Rodgers moved the council approve FY2023 Budget Amendment #2. Mrs. Ross seconded the motion and with all coting yea the motion carried as presented.

There being no further business to come before the council, Mrs. Rodgers moved the meeting to be adjourned with a second by Mrs. Ross.
