Ordinance No. 2025-01 was presented and upon motion by Mrs. Hall, second by Mrs. Ross, with all voting yea, the Ordinance was approved as presented.

Mr. Gaynor moved the council approve Resolution No. 2025-04 which allows the City of Brundidge to enter into an agreement with South Central Alabama Development Commission for the provision of administrative services of SEID Project Number SEID23AL001 and authorizes the Mayor to execute the contract on behalf of the City. Mrs. Hall seconded the motion and with all voting yea the motion carried.

Mr. Gaynor moved the council approve Resolution No. 2025-05 which allows the City of Brundidge to enter into an agreement with South Central Alabama Development Commission for the provision of administrative services of CDBG No. SM-CM-PF-24-011 and authorizes the Mayor to execute the contract on behalf of the City. Mrs. Hall seconded the motion and with all voting yea the motion carried.

There being no further business to come before the council, Mrs. Hall moved the meeting to be adjourned with a second by Mrs. Ross.
