1. That Dixie Shehane received a majority of the votes cast for the office of Council Member District 1 and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2025.
2. That Henry Everett received a majority of the votes cast for the office of Council Member District 3 and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2025.
3. That Marilyn Rodgers received a majority of the votes cast for the office of Council Member District 5 and is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2025.
4. Further that for Mayor no candidate received a majority of the votes cast; therefore, a runoff election for Mayor between Isabell “Fronnie” Boyd and Henry E. Wilson is hereby ordered to be held on Tuesday, September 23, 2025 pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended.
5. Further that in Council District No. 2 no candidate received a majority of the votes cast; therefore, a runoff election in Council District 2 between Alexandria M. Griffin and Latisher Hall is hereby ordered to be held on Tuesday, September 23, 2025 pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended.
