- 5. Further that in Council District No. 2 no candidate received a majority of the votes cast; therefore, a runoff election in Council District 2 between Alexandria M. Griffin and Latisher Hall is hereby ordered to be held on Tuesday, September 23, 2025 pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended.
