# EATON TOWNSHIP BOARD OF SUPERVISORS MONTHLY MEETING October 1, 2025

The regular monthly meeting of the Eaton Township Board of Supervisors was called to order at 7 p.m. by on Wednesday, October 1, 2025.

Present were Chairperson Kenny White, Supervisor Robert Pitcavage and Supervisor Jim Greenley.

Minutes from the previous meeting were distributed in draft form. Supervisor Pitcavage made a motion to accept the minutes with a correction on the time for the budget workshop from 5:50 to 5:30, seconded by Supervisor Greenley.

### **FINANCIAL REPORT:**

Financial report was distributed. Ms. Patton noted that money was spent on road projects, approximately \$50,000. Mr. White and Mr. Pitcavage added that they turned out well. Fire Relief monies have been received and sent out to Triton.

Motion by Mr. Pitcavage to accept the financial report, second by Mr. Greenley.

#### **ZONING OFFICER REPORT:**

One permit was issued for a garage; two for sewer for five and a half hours. Mr. Patton added that he spoke Jack Middleton about the fire hydrants report. There has been a request by the new owners of Jennings ATV to hook up to Eaton Water and Sewer. This would be accomplished by running adjacent to Penn Lane and hooking in via boring under 29. Mr. Pitcavage will look into the proper procedure. Mr. White added that there has been boring performed in other townships. Ms. Tuttle is working on an ordinance to further protect the township from data centers. Mr. Patton added that the Supervisors, Monroe Townships Supervisors and then a joint plaining commission would have to approve. Mr. Pitcavage noted Jessup Township, and Ms. Patton noted Clifton Township having a data center coming in. She will supply the ordinance they are using. Mr. Pitcavage added that we do not have high intensity lines and water available.

Motion by Mr. Pitcavage Mr. Greenley to accept the zoning officer report, second by Mr. Greenley, Mr. White agreeing.

#### **ROADS REPORT:**

Ms. Tuttle reported that the handicap installation was completed. Truck number 4 got a new box and inspection. T.V.'s and other electronics were picked up by RSS recycling. Tires went to Mavis. Fixed the driveways after FDR completion. Backhoe and loader tires have been replaced. Patching potholes. Trees from the FEMA property are cut down. Dust control is still being accomplished. The Eaton/ Monroe bridge repairs are complete. Ms. Patton inquired about the Sherwood's bill. Mr. Greenley noted that the work was completed as discussed. Mr. Greenley made a motion to accept the report, second by Mr. Pitcavage.

# **EMA REPORT:**

Ms. Tuttle is now continuing her work as Emergency Operating Procedures and Plans. Local ambulance, fire, K-9 rescue and addresses are top priorities. Forms have been supplied on the website. Mr. Greenley made a motion to accept the report second by Mr. Pitcavage.

## **VISITORS AND GUESTS:**

Carl McGrady from Wyoming Sand Lane expressed his views on the FDR project- siting problems with dust, speeding traffic and widening. Mr. White noted that the lack of rain has affected the efficacy of the calcium chloride. Mr. Pitcavage offered to look into it.

Nick Lylo from DCNR attended to discuss the proposed abandonment of a portion of Jurista Hill Road to provide parking for the entrance to the State Game Lands known as Miller Mountain. Ms. Rogers was concerned about how that would affect her property. According to database the State uses- the property would be unaffected. Unfortunately- she did not attend. She would have the right to dispute the Commonwealth. She also brought up the Miller Mountain Run traffic. Mr. Lylo noted that the road is public- therefore there is no help for maintenance. The Township would lose approximately \$1000 in liquid fuels money- but would also be giving several large culverts maintenance to the state. Plowing would be provided as needed. The yellow house would be removed, providing parking for the state forest. Mr. Pitcavage inquires about the races. Mr. Lylo noted that the group pays a fee to the state for the use of the land. Mr. Pitcavage will find out the exact dollar amount for liquid fuels loss, and meet with Ms. Rogers about her land. Mr. Lylo also noted that his crew has removed trees impacting the park. Winter maintenance will be provided through deer season.

Mr. McGrady added that debris was pushed into his yard during plowing and requested snow be pushed to the opposite side. He also requested a stop sign on township road near Maple Road. Mr. White noted that he would look into it. Another visitor asked why the road was widened. It was noted that township roads should be 33 feet. Mr. Pitcavage will look at the road.

## **UNFINISHED BUSINESS:**

The install of the ramp was completed-thanks to the Patton's. Eaton Monroe Bridge project was completed. The bill had not yet been completed by the meeting. On the issue of supplemental heat- Mr. Pitcavage received information on inexpensive blue flame heating units. The least expensive units are \$279 at Tractor Supply, or \$240 at Home Depot. At the Convention- Mr. Pitcavage was approached by Joe Sick- that a street light would be appreciated by the old Walmart.

### **NEW BUSINESS:**

Assessor's changes were noted.

Motion to sign checks by Chairman White, second by Mr. Pitcavage second.

Meeting was adjourned at 7:40 p.m. by Chairman White second by Supervisor Ptcavage.
