EATON TOWNSHIP BOARD OF SUPERVISORS MONTHLY MEETING August 3, 2021

The regular monthly meeting of the Eaton Township Board of Supervisors was called to order at 7:00 p.m. by Chairman White on Tuesday August 3, 2021.

Present were, Chairman Kenny White, Supervisor Abe Kukuchka, Supervisor/Road Master Paul Rowker.ro

Minutes from the previous meeting were distributed in draft form. With no corrections needed, Supervisor Kukuchka made a motion to accept the minutes, seconded by Supervisor Rowker.

FINANCIAL REPORT:

Supervisor Kukuchka declared the report good. Supervisor Rowker stated that there was no trouble, but the bills for blacktop had not yet come out. Lori Faux Bennet requested a report.

ZONING OFFICER REPORT:

Supervisor Kukuchka made a motion to accept the report. It was noted by Supervisor Rowker that the Zoning Officers were finishing the transition, and Officer Woods wrapped up his current working permits.

VISITORS AND GUESTS:

Resident Lori Bennet first questioned unclassified expenditures of \$51. She stated she was busy and did not join the Seneca Park Committee, and also that the roads were well taken care of this winter. She then voiced her opinion about using the park for sports since the school cannot accommodate them. Further discussion ensued.

Pat Quinn , Ambassador of the Seneca Nation, and professor presented his hopes for the pork using volunteerism and attrition. Resident Lori Bennet inquired about the educational aspects specifically and Mr. Quinn explained the various talks he gives. Lacrosse fields were discussed. Resident Linda Coolbaugh spoke of bussing children to the park for education. She also commented that litter is under control and problem with the lavatory and pets has been corrected. They asked if they could buy shirts denoting the Seneca Park Staff, and it was discussed and decided that the Township should speak with our attorney first. Resident Dawn Rogers brought up the presentation to beheld at the courthouse making this a Purple Heart Community and requested a sign be put up at the park. Following, Dr. Gere Reisinger spoke more about the Seneca Nation and lacrosse, and Mr. Richard Scalese, friend of the doctor offered his services with setting up the park and insurances.

NEW BUSINESS:

The assessors Report was reviewed. The South Eaton Cemetery Association meeting will be held on August 16. Electronics recycling was removed. Centennial/Business meeting for PSATS was scheduled. Black top projects are completed, and tar chip projects are in the future. The shoulders in Thurston Hollow were4 discussed. A grant for tree removal has been filed.
